NEW FOR 2021:

- Two-tier prescription Value Formulary for all plans
- First changes to LivingWell PPO since 2014
 - prescription co-pay increased by \$5
 - specialist office visit co-pay increased by \$5
- No health insurance premium increases over \$21 per month

ANTHEM OPTIONAL DENTAL & VISION INSURANCE



- Premiums are pre-tax and payroll deducted
- Enrollment is voluntary
- Dental premiums have increased in 2021
- No action needed to keep your current coverage
- You can enroll in new coverage or terminate your existing coverage during Open Enrollment

All planholders are required to fulfill the LivingWell Promise. You can either take an online health assessment at KEHPlivingwell.com or get a biometric screening from January 1 through July 1, 2021.

The LivingWell Promise is required if you have at least 90 days of active coverage from January 1 through July 1.
