

After "KRS", insert "116.025,".

Section 10

After "Section 10.", insert the following:

A voter who changes his or her place of registration to a different state while the registration books are closed in the new state of residence before a presidential election shall be permitted to cast an absentee ballot for President and Vice President only, pursuant to KRS 116.025(7) and 117.085(1)(h)4. by completing SBE Form 44P, Presidential Only Absentee Ballot Application.

NOTE TO COMPILER: Renumber the final Section of the administrative regulation on Incorporation by Reference as Section 11.

Section 11(1)(d) (As renumbered, previously Section 10.)

After "Form SBE 44E,", insert "<u>04/2024</u>". Delete "04/2022".

Section 11(1)(e)

After "03/2023;", delete "and".

Section 11(1)(f)

After "Form SBE 78, 04/2022", insert the following:

(g) "Presidential Only Absentee Ballot Application", Form SBE 44P, 08/2024
