**Petitioners Right to Redress of Grievances**

WHEREAS, the First Amendment of the U.S. Constitution, states, in part, “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances, and,

WHEREAS, Section 4 of the Kentucky Constitution provides that “All power is inherent in the people, and all free governments are founded on their authority and instituted for their peace, safety, happiness and the protection of property. For the advancement of these ends, they have at all times an inalienable and indefeasible right to alter, reform, or abolish their government in such manner as they may deem proper;” and,

WHEREAS, KRS 63.030 Petition for impeachment. (1) Any person may, by written petition to the House of Representatives, signed by himself, verified by his own affidavit and the affidavits of such others as he deems necessary, and setting forth the facts, pray the impeachment of any officer. (2) The House shall refer the petition to a committee, with power to send for persons and papers, to report thereon, and,

**PROVISIONS OF THE KENTUCKY CONSTITUTION, U.S.  
CONSTITUTION, and KRS 522.030**

**Section 66 of the Kentucky Constitution** states that “The House of Representatives shall have the sole power of impeachment;” and

**Section 68 of the Kentucky Constitution** provides that “The Governor and all civil officers shall be liable to impeachment for any misdemeanors in office,” which includes misconduct in office, deemed sufficiently by this House of Representatives; and

**1<sup>st</sup> Amendment of the U.S. Constitution**, states, in part, “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances;” and

**Article IV, Section 1 of the U.S. Constitution**, states “The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several States,” which includes the right of travel; and

**Section 1 of the Kentucky Constitution** provides that Kentuckians have “the right of enjoying and defending their lives and liberties,” “the right of worshipping Almighty God according to the dictates of their conscience,” “the right of seeking and pursuing their safety and happiness,” “the right of freely communicating their thoughts and opinions,” “the right of acquiring and protecting property,” and “the right of assembling together in a peaceable manner for their common good;” and

**Section 2 of the Kentucky Constitution** provides that “absolute and arbitrary power over the lives, liberty, and property of freemen exists nowhere in a republic, not even in the largest majority;” and

**Section 5 of the Kentucky Constitution** provides that “[n]o human authority shall, in any case whatever, control or interfere with the rights of conscience;” and

**Section 14 of the Kentucky Constitution** provides that “[a]ll courts shall be open, and every person for any injury done him in his lands, goods, person, or reputation, shall have remedy by due course of law, and right and justice administered without sale, denial, or delay;” and

**Section 19 of the Kentucky Constitution** provides that no “law impairing the obligation of contracts shall be enacted;” and

**Section 24 of the Kentucky Constitution** provides that “Emigration from the State shall not be prohibited;” and

**Sections 27 and 28 of the Kentucky Constitution** provides that the Executive Branch is separate from the Legislative Branch, and that “No person or collection of persons, bring of one of those departments, shall exercise any power properly belonging to either of the others;” and

**Section 49 of the Kentucky Constitution** contains an explicit limitation on the ability to contract debt, and such debts may not exceed \$500,000; and

**Section 50 of the Kentucky Constitution** requires that sufficient revenues be had to pay debts, including interest and the ability to pay off same within 30 days; and

**Section 147 of the Kentucky Constitution** requires in person voting, and, unless someone is absent from the county of residence or the state, must vote in person; and

**KRS 522.030** provides, in relevant part, that a “public servant is guilty of official misconduct in the second degree when he knowingly: commits an act relating to his office which constitutes an unauthorized exercise of his official functions,” and which is



## STATEMENT OF FACTS

### Count I – Violation of Section 1

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, violated the rights of millions of Kentuckians, by depriving them of “the right of enjoying and defending their lives and liberties,” “the right of worshipping Almighty God according to the dictates of their conscience,”<sup>1</sup> “the right of seeking and pursuing their safety and happiness,” “the right of freely communicating their thoughts and opinions,”<sup>2</sup> “the right of acquiring and protecting property,” and “the right of assembling together in a peaceable manner for their common good,”<sup>3</sup> by imposing lockdown orders that denied Kentuckians the right and usage of their businesses, their personal freedoms, the freedom of movement, of conscience, of worship, of the ability to gather and speak and protest, **in contravention of Section 1 of the Kentucky Constitution and the First Amendment of the U.S. Constitution, and KRS 522.030,**

### Count II – Violation of Section 2

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, violated the rights of millions of Kentuckians, by exercising “absolute and arbitrary power over the lives, liberty, and property of freemen,” by imposing lockdown orders that denied Kentuckians the right and usage of their businesses, their personal freedoms, the freedom of movement, of conscience, of worship, of the ability to gather and speak and protest **in contravention of Section 2 of the Kentucky Constitution, and KRS 522.030,**

**Count III – Violation of Section 5**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, violated the rights of millions of Kentuckians, by prohibiting the free exercise of religion, by prohibiting and limiting in person worship in the Commonwealth of Kentucky and closing in person instruction in private religious schools, in contravention of Section 5 of the Kentucky Constitution which provides that “[n]o human authority shall, in any case whatever, control or interfere with the rights of conscience;”<sup>4</sup> and “nor shall any man be compelled to send his child to any school to which he may be conscientiously opposed;”<sup>5</sup> the First Amendment to the U.S. Constitution, and KRS 522.030,

**Count IV – Violation of Section 14 and 19**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, violated the rights of millions of Kentuckians, by restricting access to courts and impairing their contracts, for, among other things, property owners to regain possession of their property from tenants who refused to provide compensation, in contravention of Section 14 and Section 19 of the Kentucky Constitution, and KRS 522.030;

**Count V – Violation of Section 24**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, violated the rights of millions of Kentuckians, by restricting their ability to leave the state, in contravention of Section 24 of the Kentucky Constitution, and Article IV, Section 2 of the U.S. Constitution, regarding the right to travel,<sup>6</sup> and KRS 522.030;

**Count VI – Violation of Sections 27 and 28 of the Kentucky Constitution**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, enacted a series of laws by decree, acting as a one man legislature, and refused to convene the Kentucky General Assembly back into session; and, further, has made a number of public statements indicating his desire to continue to do so, in contravention of Sections 27 and 28 of the Kentucky Constitution, which provides for a strict separation of powers, and KRS 522.030

**Count VII – Violation of Sections 49 and 50 of the Kentucky Constitution**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, borrowed up to \$800,000,000, and actually withdrew over \$100,000,000 of that loan, without the consent or permission of the Kentucky General Assembly, and without any ability to repay same, in contravention of Sections 49 and 50 of the Kentucky Constitution, and KRS 522.030

**Count VIII – Violation of Section 147 of the Kentucky Constitution**

That Andrew G. Beshear, on or about March 6, 2020, and in the days, weeks, and months that followed, altered voting procedures in the Commonwealth of Kentucky, to permit other than in person voting by persons not absent from the County, in contravention of Section 147 of the Kentucky Constitution, and KRS 522.030

**WHEREFORE, The petitioners charge that Governor Andrew G. Beshear is guilty of the above violations and asks this committee to find this to be fact and return Articles of Impeachment against him.**
