At the August 15, 2024 meeting of the Legislative Oversight and Investigations Committee, Senator Julie Raque Adams asked committee staff to produce a list of boards, the date the boards were created, and the last time the boards were updated. The following list provides an alphabetical list of boards, their primary statute or other authority, their date of creation, and by the last year the primary statute or other authority was updated.

The list of boards was based on the listing of all boards and commissions compiled by the Governor's Office.¹ The statute or other document on creation was based on the board directory created by the Governor's office.² The list of all boards appears to have been last updated in 2017, based on document properties, and may not contain more recently created boards.
