Increasing Pressure to Go Digital in the Real Estate Industry

Digital tools were being adopted prior to 2020 by the full range of stakeholders in the real estate industry, including:



Home buyers

The three most popular sources home buyers used in home search:

Online website (93%)

Real estate agent (86%)

Mobile, website, or app (73%)¹



Borrowers

50% of borrowers said they chose a lender based on whether they offered an online application or portal, and 47% said access to an online portal for uploading documents electronically was a factor in their decision.²



Financial institutions

48% of lenders reported putting significant effort into both their front- and back-end digital transformation.³



Settlement agents

In a survey of title agents, respondents said renewed sales and marketing approaches, new technology, and cost reductions represented the best opportunities. Cyber threats concern them more than any other business problem.⁴

Advantages of Technology Adoption in 2021 and Beyond

- The shift to digital transactions has occurred over the last several years, but the pandemic has now made technology a necessity.
 - Reduction of operation costs
 - Increased efficiency
 - A positive borrower experience
 - Reliable security and storage
 - Real-time sharing and accessibility feasibility
 - New operation standards with longer-term affects, including increased flexibility and migration

State Challenges and Solutions

- Overall, most states have had one of the following scenarios:
 - Permanent RON laws
 - Emergency authorizations
- What's legal may not get authorized—all parties need to agree
 - County support and adoption
 - Underwriter approval
 - GSE acceptance
- Solutions
 - Counties have adapted guidelines to assist with faster implementation
 - Technology (eSigning and RON) expanded document acceptance processes
 - More efficiency led to improved customer service
 - eRecording enabled states to pivot in face of pandemic



Recent Standards and Legislation Support the Rise of Digital

- **MISMO**

- New standards finalized September 2019 allowing the use of audio-visual communication devices to notarize documents (RON) in all states
- Credential analysis procedures and technology are widely accepted as identity proofing processes
- Free to the public and no license required to use these standards

- **TILA-RESPA**

- Integrated disclosure rule (TRID) requires electronic audit trail for lenders for regulatory audits

Kentucky Legislation Updates:

Senate Bill 114

permits the use of electronic recording (“e-recording”) of real estate documents by county clerks.

Uniform Real Property Electronic Recording Act (URPERA)

allows clerks and recorders to e-record real property transactions and land records

Revised Uniform Law on Notarial Acts (RULONA)

a uniform law allowing notaries to electronically perform notarial acts

Uniform Electronic Transactions Act (UETA)

Act makes many electronic documents and e-signature legally valid

Enjoy the Benefits of Going Digital with eRecording

- Convenience, speed, transparency, communication
 - Documents are submitted in seconds, not hours or days
 - Submissions are date and time-stamped
 - Recording offices process on a first-come, first-served basis
 - Documents are returned same-day on average
 - Acknowledgements are returned to customers electronically
- Security
 - Retain control of your documents throughout the process
 - Secure web connections, including HTTPS web service with data and documents protected by transport layer security (TLS) aka secure sockets layer (SSL) encryption

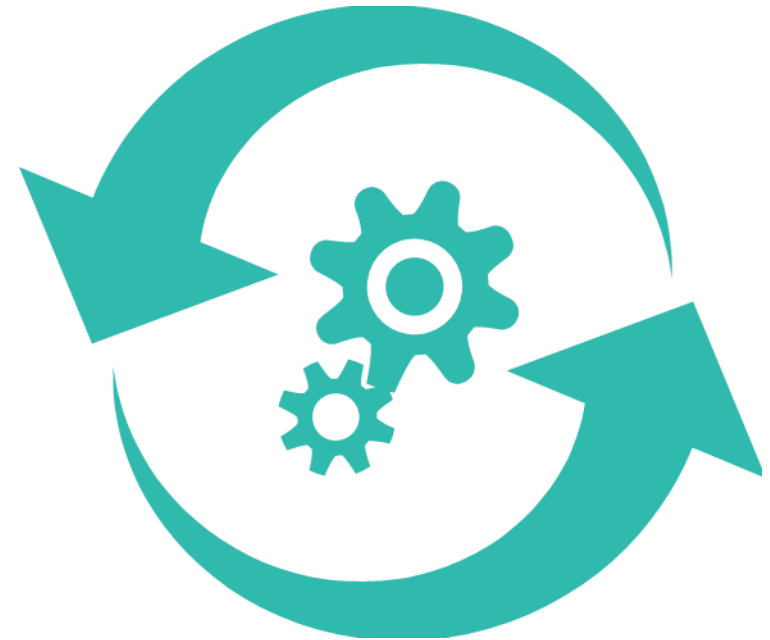

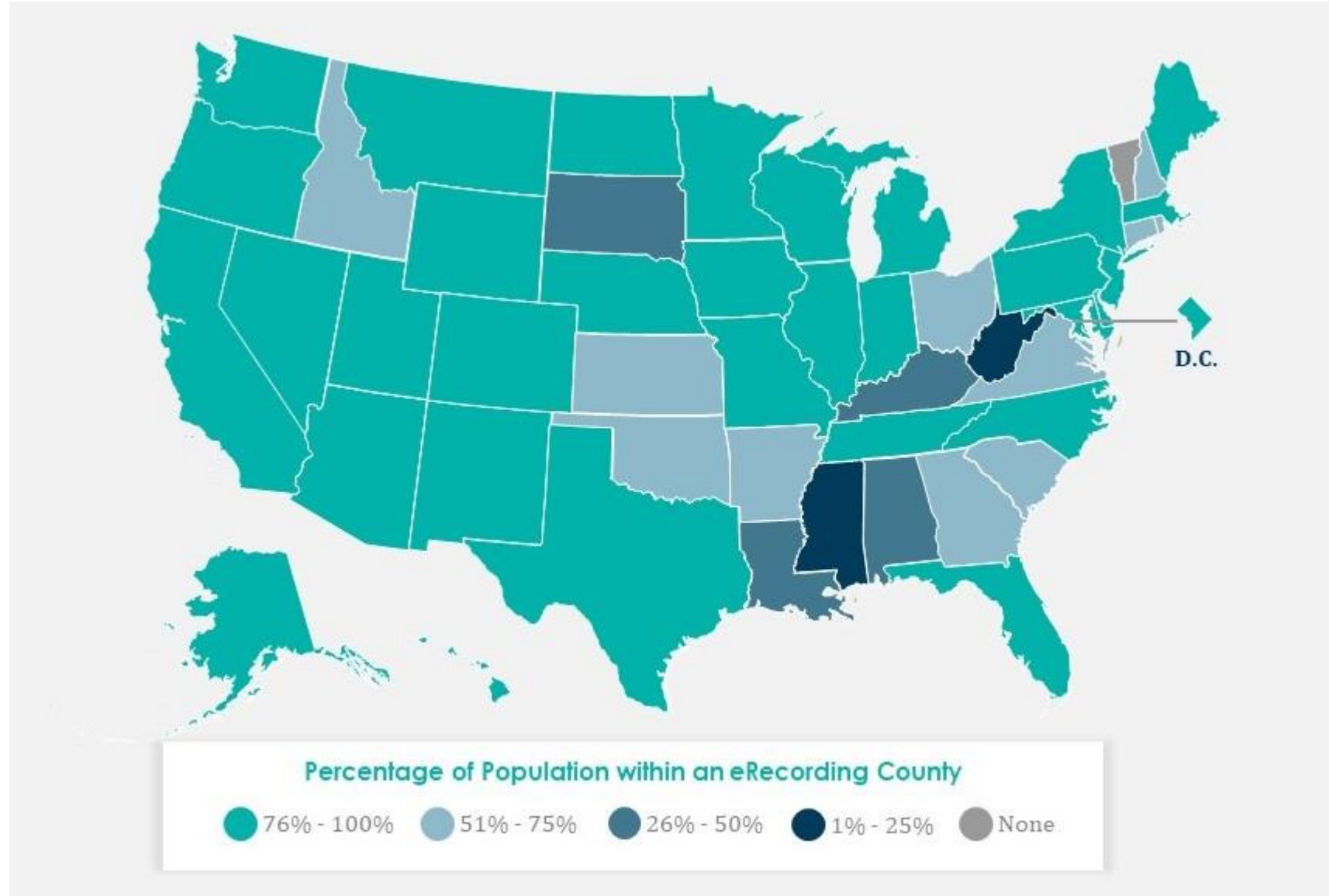
Payment Process/Fee Reconciliation

COUNTY ACQUISITION PROCESS

- All Recording Jurisdictions are invited to eRecord
- CSC does not charge Recording offices for implementation
- MOU's are signed with each County/City/Parish/Town
- Jurisdiction provides ACH Bank Information for payment
- Integration with LRMS or a Stand Alone with Recording office
- Each Recording office determines Doc Types to eRecord
