




Barrel Tax: Impact on Bullitt County

Bourbon Barrel Taxation Task Force September 1, 2022

Bullitt County Revenue Impact







- Impact to fiscal court and taxing districts: \$1 million
- Impact to Bullitt County Sheriff: \$89,923
- Impact to schools: \$2.6 million
- Fiscal court barrel tax revenue (\$330,330) does not cover county expenses related to distillery growth.
 - In 2021, the county spent over \$350,000 repairing roads damaged by construction of bourbon warehouses.
- Bullitt County barrel tax revenue is expected to double by 2026.

County Investments: Industrial Revenue Bonds

- Counties have provided financial incentives to distilleries by issuing \$2.5 billion in IRBs since 2012.
- Counties issued IRBs to provide property tax exemptions to distilleries based on the expectation of future revenue growth from the barrel tax.



Impact on Nelson County:


12% of annual fiscal court tax revenue

Financial Impact of Barrel Tax

- Impact to fiscal court: \$1.1 million
- Impact to Nelson County Sheriff: \$230,000
- Future revenue: expecting barrel tax revenue to increase substantially over the next 10 years – about 40 more warehouses.

Financial Incentives Provided by County

- Issued **\$1.2 billion** in IRBs—providing property tax exemptions to multiple distilleries.
- Provided discounted land.

Impact on Marion County:

5% of annual fiscal court tax revenue

Financial Impact of Barrel Tax


- Impact to fiscal court: \$302,791
- Impact to Marion County Sheriff: \$90,000
- Future revenue: expecting barrel tax revenue to double beginning in 2025 when barrels reach taxable age.

Financial Incentives Provided by County

- Issued \$682 million in IRBs providing property tax exemptions.
- Special pricing on land, water, and other infrastructure needs.

Impact on Henry County:



Financial Impact of Barrel Tax

- Future Revenue: **expect over \$2.5 million in new revenue** countywide once current projects are completed—approximately \$330,000 in new revenue for the fiscal court in the next 3-5 years.
- This would result in a 20 percent increase in fiscal court tax revenue.

Financial Incentives Provided by County

- Sold 40 acres of the county industrial park for warehouses at a very discounted price.
- Decision was made based on expected return on investment through the barrel tax.
