In May of 2022, Mobile Forensic Solutions was contacted to analyze the contents of a cell phone. It was discovered by the owner of the cell phone, [REDACTED], that his girlfriend [REDACTED] had an outside relationship with another person. The other person was Ronnie Goldy Jr., a Commonwealth County Prosecutor. According to [REDACTED] Mr. Goldy had granted favors in court when [REDACTED] was the defendant. Dan Jackman of Mobile Forensic Solutions was retained to perform the analysis of the evidence as a consulting expert.

#### About Dan Jackman

Dan Jackman retired from the Louisville Metro Police Department in 2017 after 21 years of service. He initiated the establishment of an Internet Crimes Against Children (ICAC) unit in Louisville, KY. Mr. Jackman spent over a decade investigating incidents of sexual exploitation of minors. Mr. Jackman was recognized locally and nationally for his successful investigations. Not only was he an investigator, but a certified law enforcement instructor for the Department of Criminal Justice Training for 15 years. Mr. Jackman created training courses related to Undercover Investigations and Digital Evidence Investigations which were taught throughout the region. Mr. Jackman was also a keynote speaker at several conferences and conventions related to child abuse and investigating the sexual exploitation of children.

During his 21 years with the Louisville Metro Police Department, Mr. Jackman spent 6 years with the Federal Bureau of Investigations on the Cyber Crimes Task Force. During his tenure with the FBI, Mr. Jackman investigated incidences of Child Sexual Exploitation and Cyber Hacking. While with the FBI, Mr. Jackman became involved in the field of forensic examination of mobile devices. Toward the end of Mr. Jackman's career with LMPD, he was assigned to forensically examine cell phones and other mobile devices. He has been recognized as an expert witness in the field of child sexual exploitation investigations and cell phone forensics.

Since retirement, Mr. Jackman created a company, Mobile Forensic Solutions, and continues to provide mobile forensic examinations. He routinely provides forensic examinations for law enforcement agencies, criminal defense attorneys, civil attorneys, and the general public.

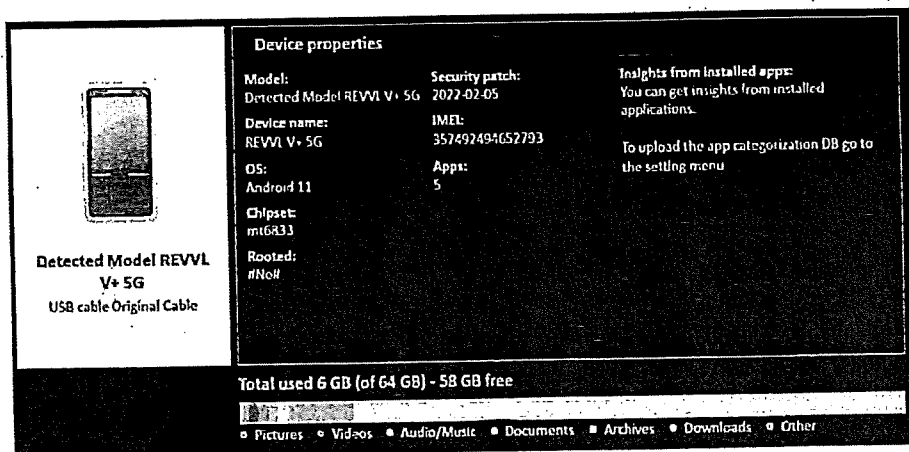
#### Evidence Submitted

EV1: EV1 is best described as a REVVL manufactured mobile phone; V+ 5G series, bearing the IMEI of 357192494652793. In addition to making and receiving phone calls, EV1 is capable of sending and receiving SMS, MMS, instant messages, and email. EV1 is equipped with a camera and is capable of creating and viewing graphic image and video files. EV1 is capable of accessing the. EV1 has an integrated storage capacity of 64 GB.



### Extraction of Data

The information on the device was extracted with a Universal Forensic Extraction Device Physical Analyzer version 7.54.0.444. The extraction method utilized for the devices were an Advanced Logical and File System extraction. The extractions took place on May 24, 2022 at 14:40. Below is a image showing the contents of EV1.



### Analysis of EV1

During the extraction of EV1, the owner was present. He only consented to allow the extraction of screenshots of various Facebook messages. The owner mentioned that he feared retaliation for him coming forth with this information. The Facebook pictures were found on the device and two digital reports were generated. One report was in an UFED reader format, while the second was an HTML.

The examination of EV1 found 230 different screenshots of a Facebook conversation. The conversation was between Ronnie Goldy and a female named [REDACTED]. A working copy of the images was generated, and the images were renamed in chronological order based upon the time there were created. The conversation between Mr. Goldy and [REDACTED] has timestamps from April 27, 2018, to September 18, 2021.

An analysis of the conversation found the following concerning actions:

1. Mr. Goldy sent \$25 to [REDACTED] for gas through FB (Image 3)
2. After sending the \$25, Mr. Goldy stated, "Now your turn. LOL" (Image3)
3. During this point in the conversation, [REDACTED] was pulled over by the police in Lexington. After the interaction with the police, [REDACTED] received a traffic citation and stated that she was heading home.
4. Mr. Goldy said, "OK. But don't leave me hanging"

5. Mr. Goldy mentioned that he was going to take a shower after umpiring a baseball game. (Image 8) The following messages were sent:
- o [REDACTED]: Don't do anything I wouldn't do
  - o Mr. Goldy: Lol, U never know
  - o [REDACTED]: I know a side of u that a lot of people don't. Don't forget that haha.
  - o Mr. Goldie: This is true.
6. Approximately 90 minutes later, [REDACTED] sent Mr. Goldie 8 seductive and nude photographs. (Image 9) After viewing the images, Mr. Goldy stated, "Wow. Nice. I do have most of those I think. But they are very nice. I'm sure you have some even better."
7. The conversation then turned to discussing addition pictures and videos. Mr. Goldy said, "Video certainly sounds interesting." (Image 10) Later the same day, Mr. Goldy asked, "Any luck finding that video."
8. That evening, [REDACTED] asked Mr. Goldy if he knew of a way she could "earn" some money for gas and to job hunting." (Images 11-12). [REDACTED] stated, "Will you help me out with some money today? I will earn it or I will pay you back when I get my first check. Either way is fine. I found all my pics and videos but they gotta be worth a lil something, right!" The timestamp for these messages was on May 9, 2018.
9. On June 15, 2018, Mr. Goldy asked, "When do I get to see a video". (Image 14)
10. The following day the following messages were sent:
- o [REDACTED] Do you know anything about federal cases? I know you don't have jurisdiction over that obviously but just didn't know if you knew anything about it, how it works, etc
  - o Mr. Goldy: Depends on case why
  - o [REDACTED] So many weird things keep happening
  - o Mr. Goldy: Like?
  - o Mr. Goldy: I mean if you want to show me some weird videos I'm cool with that Lmao.
11. On June 27, 2018 the below conversation took place (Image 17)
- o Mr. Goldy: You owe me big time
  - o [REDACTED]: Why? Lol
  - o Mr. Goldy: Judge is about to withdraw some warrants
  - o [REDACTED] YESSSS!!!
12. Following up on this conversation, Mr. Goldy said, "Don't you owe me a video? Lol" and "Yes I am right. U owe me a very good video or two." (Image 20-21)
13. On August 7, 2018, Mr. Goldy stated, "Didn't you forget to send me something? Lol" and "Well need to fix that". (Image 22)

14. On August 20, 2018, they are discussing sending videos and meeting up in person.
- o [REDACTED]: I have to get one off my other phone. I just got a new one recently. Well, I guess I could make a new one but... That would be a task, mid day yet still not impossible, I don't guess. Haha. You DID get a bond taken case of on a Sunday, I suppose. & I am currently trying to figure out how to get my vehicle out of impound (only me 😊) and then I'll let you know about meeting?
  - o Mr. Goldy: Now you're thinking right
15. The following day, Mr. Goldy said, "Don't get off topic. You still own me videos. Can't tease and then not deliver." (Image 29)
16. Through September 23, 2018, their conversation continues. [REDACTED] ask if Mr. Goldy could continue a court date so she would not get an arrest warrant. Mr. Goldy replies, "I'm still waiting on those videos remember. Lol. I can see what I can do. What time is court."
17. On September 27, 2018, Mr. Goldy was asked by [REDACTED] to continue a case in Clark County so she would not go to jail. She mentioned that she also had a fine to pay in Montgomery. Mr. Goldy replied, "Ok I'll see if I can take care of Clark. U focus on Montgomery." (Image 40)
18. On October 23, 2018, Mr. Goldy stated, "Got your Rowan county stuff done. You are completely free of that. Still working on Clark county. They are a pain." After this message, [REDACTED] send Mr. Goldy a nude picture. (Image 44)
19. The conversation between the two become less frequent. In 2019 and 2020, [REDACTED] ask Mr. Goldy in multiple occasions to check eWarrants to see if she has a warrant. She also asks if he would run a name through the system to search for warrants. (Image 61)
20. On April 14, 2020, (Image 136) [REDACTED] asked Mr. Goldy if he knew of a way, she could earn some money stating:
- o [REDACTED]: You interested in helping me make some money? Any ideas? Videos? Anythin?
  - o Mr Goldy: Could always do the private snap chat videos. I know a girl who made a bunch of \$\$ doing that. Lol
  - o [REDACTED] How do you do that? Private SC?? Is it with people I know or what? And I got video for you if you are willing to buy? All jokes aside I'm being serious
  - o Mr. Goldy: Not sure how she did the private snap chat. I don't do snap chat...What kind of video
  - o [REDACTED] So, as for this first video-it isn't much but like I said, it is a start. If you are willing to start with me. I will send it & we can go from there. You can give me advice and suggestions & I will take them. I am going to figure out about this private SC but I want you to approve of the pics/vids before I put them on there. I know this first one isn't worth much but I can send it first and you can decide on how much you want to

give me..If you even want to, that is. Just lmk.

- o Mr. Goldy then sends [REDACTED] some links to websites with instructions on creating a Snapchat account.
- o Mr. Goldy then adds: I can get some people to buy in
- o [REDACTED] What do you mean?
- o Mr. Goldy: People that would pay for access

21. On April 19, 2020, the two discuss sending nude pictures and videos for money. (Image 144)

22. On August 3, 2020, [REDACTED] ask Mr. Goldy, "Hey will you check and see if [REDACTED] has an active warrant in either Bath or Rowan County?". Mr. Goldy replies, "Looks like she does." (Image 163)

23. On August 3, 2020, [REDACTED] ask Mr. Goldy, "Does [REDACTED] have an active warrant". Mr. Goldy replies, "Yes Fayette and Rowan" (Image 176)

24. On November 6, 2020, [REDACTED] stated, "I freaking forgot about court yesterday." The court issued an arrest warrant for FTA. Mr. Goldy replied, "Oh no, Call [REDACTED] and tell him. I'm sure it wont be a big deal." Mr. Goldy also said, "Haven't been able to get judge yet. But I'll take care of it." (Images 210-211)

#### Conclusion

The above highlights are only a sample of the conversation between Mr. Goldy and [REDACTED]. It cannot be determined if [REDACTED] had committed adultery with Mr. Goldy solely based upon the messages. [REDACTED] did send nude photographs at Mr. Goldy's request. Mr. Goldy did set-aside warrants for [REDACTED] and continue cases at her request. Mr. Goldy also searched eWarrants for individuals' status when asked by [REDACTED].

Whether or not these actions constitute any ethics violations must be decided by other individuals.

A standard policy of Mobile Forensic Solutions is that the data extracted from the involved devices is only retained for 10 days. If [REDACTED] or other legal representation wishes that the extracted data be saved for a longer period of time, notification must be made to Mobile Forensic Solutions prior to the 10-day retention period.


