Title XIX Funding to Promote Transformation of State Public Behavioral Health Systems of Care

SAMHSA Block Grants

- Federal funds allocated to all 50 states and US territories
- Amount based on federal formulas developed based on population, economic indicators, and prevalence data/research
- Application/plan due in odd years (2023, 2025, 2027)
- Updated application/plan (mini applications: 2022, 2024, 2026)
- Annual reports
- Completion of revision request
- Participate in reviews/site visits by SAMHSA

Block Grant Required Expectations

Funds can only be expended for:

- Carrying out the plan as submitted;
- Evaluating programs and services carried out under the plan;
- Planning, administering, and educational activities related to providing services under the plan.

SAMHSA Block Grant Purposes

Block grant funds must be directed towards four purposes:

- Fund priority treatment and support services for individuals without insurance or for whom coverage is terminated for short periods of time.
- Fund those priority treatment and support services that demonstrate success in improving outcomes and/or supporting recovery that are not covered by Medicaid, Medicare, or private insurance.

SAMHSA Block Grant Purposes

Block grant funds must be directed towards four purposes:

- Fund primary prevention by providing universal, selective, and indicated prevention activities and services for persons not identified as needing treatment.
- Collect performance and outcome data to determine the ongoing effectiveness of behavioral health promotion, treatment, and recovery support services.

Mental Health Block Grant (MHBG) Requirements

- Community-based services for individuals with serious mental illness (adults) or serious emotional disability (children & youth)
- 10% set aside for early interventions for first episode psychosis services (using an evidence-based Coordinated Specialty Care model)
- 5% set aside for crisis services
- Minimum expenditure amount for children/youth services
- Maintenance of effort

MHBG Priority Populations

Adults with serious mental illness (SMI)

Includes persons ages 18 and older who have a diagnosable behavioral, mental, or emotional condition. Their condition substantially interferes with, or limits, one or more major life activities, such as:

- Basic daily living (e.g., eating or dressing)
- Instrumental living (e.g., managing money or getting around the community)
- Participating in social, family, vocational/educational contexts

MHBG Priority Populations

Children with serious emotional disability (SED)

Includes persons up to age 18 who have a diagnosable behavioral, mental, or emotional issue. This condition results in a functional impairment that substantially interferes with, or limits, a child's role or functioning in family, school, or community activities.

- There are state definitions of SMI and SED.
- In addition to services for SMI and SED, funds may be used for data collection/outcomes, reporting, and other infrastructure supports.

MHBG Funding

- FY 23 amount (current): \$12,582,078
- President's proposed budget for FY24: \$20,553,587
- Maintenance of effort requirements: \$20,557,597
- Children's services set aside: \$3,832,010
- First episode psychosis set aside: 10% of final allocation
- Crisis set aside: 5% of final allocation

Substance Use Prevention, Treatment & Recovery Block Grant (SUBG) Requirements

- Community-based services for individuals with or at risk of substance use disorders (all ages)
- 20% set aside for prevention (services delivered prior to diagnosis)
- Minimum expenditure amount for:
 - Pregnant women with substance use disorders
 - Women with substance use disorders who have dependent children
- Maintenance of effort

SUBG Priority Populations and Services

- Pregnant women with substance use disorders
- Women with substance use disorders who have dependent children
- Persons who inject drugs
- Tuberculosis services (for substance use disorder service recipients)
- Early intervention services for HIV/AIDS, if designated state (Kentucky is not an HIV designated state)
- Kentucky specific – Service members, veterans and their families (SMFV)

SUBG Funding Levels

- FY 23 amount: \$21,294,912
- President's proposed budget for FY 24: \$29,615,125
- Maintenance of effort requirement: \$9,306,300
- Primary prevention: 20%
- Pregnant women/women with dependent children required expenditure: \$2,616,923

Additional Funds Provided through Block Grant

Coronavirus Response & Relief Supplemental Appropriation (CRRRA)

- Three years to spend: March 2021 – March 2024
- MHBG: \$10,734,798
- SUBG: \$19,100,815

Additional Funds Provided through Block Grant

American Rescue Plan Act of 2021 (ARPA)

- Four years to spend: Sept. 2021 – Sept. 2025
- MHBG: \$18,541,925
- SUBG: \$16,496,159

Additional Funds Provided through Block Grant

American Rescue Plan COVID Mitigation Funds (ARP Mitigation)

- Three years to spend: Sept. 2021 – Sept. 2024
- These funds can only be used to prevent, prepare for, and respond to the COVID-19 pandemic and ensure continuity of services to support individuals connected to the behavioral health system.
- MHBG: \$638,096
- SUBG: \$562,833

Additional Funds Provided through Block Grant

Bipartisan Safer Communities Act (BSCA)

- Allocation 1: Oct. 2022 – Oct. 2024
- Allocation 2: Sept. 2023 – Sept. 2025
- \$832,991 for each allocation
- Designated to enhance access to behavioral health services during mental health emergencies/crises, including natural and man-made disasters, for those with complex behavioral health issues

FY 24/25 Kentucky Performance Indicators

- Avoid an increase in the rate of adults with SMI, who did not already reside in personal care homes, being discharged to personal care homes from state psychiatric hospitals.
- Maintain a provider workforce identified that serve children, youth, and transition age youth, including those with SED.
- Ensure rapid access to prescribers for young people being admitted into coordinated specialty care programs. (first episode psychosis)
- Increase the number of 988 crisis calls, texts and chats answered in-state.

FY 24/25 Kentucky Performance Indicators

- Simultaneously protect infants who are affected by prenatal substance use, and support mothers and families in their capacity to provide care to infants following birth/hospital discharges, by expanding plan of safe care (POSC) capacity and focus.
- Increase the number of Kentucky youth who receive prevention services related to vaping.
- Increase the accessibility and availability of syringe services programs (SSP) across the state.
- Ensure individuals receiving SUD services are appropriately screened for tuberculosis.
