The Department specifies yearly requirements for the Plan and Budget Proposals, which are submitted by each Eligible Entity for Departmental approval. An approved Plan and Budget is incorporated within the contractual agreement between each Eligible Entity and the Cabinet and is subject to monitoring by the Division of Financial Management (DAFM). The contractual agreement is based on the state fiscal year of July 1 through June 30. Contracts are in place by July. The State allocates 95% of the funds to the agencies and keeps 5% for state administration. Each Eligible Entity is assigned a percentage of the award. The percentage was set years ago using census data regarding each areas poverty level and population. That percentage was been carried through to set CSBG allocations for each agency. When the award is known, 95% of it is distributed to agencies in contracts using the percentage assigned to them.

The Cabinet ensures that each county within the Commonwealth will be represented by an eligible entity and that each entity provides services in an equitable manner and according to the approved Plan and Budget for each Eligible Entity. If any county becomes unserved by a CSBG eligible entity for any reason, the Governor must designate private nonprofit organization or an existing CSBG eligible entity to serve that county in accordance with 42 U.
