

## **Kinship Care in Kentucky**

#### **Informal kinship care**

Varying types of custody depending on arrangements made within those families.

#### **Kinship care/Fictive kin care**

Children who are placed with **relatives** or **close family friends (fictive kin)** as a result of an investigation and removal due to dependency, neglect, or abuse. Involvement with <u>Department or Community Based Services</u> (<u>DBCS</u>)—custody of the child is maintained by the relative or DCBS.


#### **Relative foster care**

Children placed with relatives or close family friends who have become certified as foster parents—custody of the child is maintained by DCBS.



### **Progress**

- ✓ 2014 Kinship Caregiver Authorization Affidavit
- ✓ 2015 A Kinship Hotline was established and hosted by DCBS
- ✓ 2016 Child care assistance increased access
- ✓ 2017 Improved access to Relative Placement Support Benefit,
- ✓ 2018 HB 1 additional supports for kinship caregivers, and legal access to de facto custodians
- ✓ 2019 HB 2 required the creation of a service array and a collection of reporting of data around kinship care
- ✓ 2019-2021 Increased access to supports through DCBS KY-FACES, including relative caregiver service array
- ✓ 2021 Improved access to supportive services through the University of Kentucky Kinship Resource Center (KKRC)

- Financial support
  - Mileage
  - Funds for basic needs
  - Additional funds for Relative Placement Support Benefit
  - Guardianship Assistance Program
- KTAP Access
  - Child support exception needed
  - Timelines/options beyond 5 years
- Respite
- In-State College Tuition Waiver
- Urgent need for behavioral health supports
- Urgent need for more legal supports





### Continuing the Work

- Communication with kinship families
  - Rollout of Services
  - Help Desk/Call In
  - Service Region Administrators
  - Inconsistencies of implementation in field
- Flexible approach on timelines for services
- Continue engaging Lived Experience
  - Feedback on materials
  - $\circ \ \ \, \text{Feedback loop}$
  - Rollout of services
- Consider Opioid Settlement Funds for kinship families
- Consider Regional/Statewide Review Board
