

# Inspection

- The manufacture, storage, sale, or use of combustibles, explosives, and hazardous materials or equipment
- The construction, installation, maintenance, or equipment of fire alarm systems, fire protection and extinguishing equipment, and fire escapes and other means of access to or exit from property
- Supervise and make periodic inspections of all property within the state, and assist cities having fire departments in making like periodic inspections of all property in cities, except occupied private dwellings

# Education

- Conduct fire prevention and educational campaigns
- Recommend curricula for advanced courses and seminars in fire science training in colleges and institutions of higher education

# Coordination with Local Fire Departments

- A fire chief is authorized to inspect property and investigate fires in the fire departments' district by KRS 227.240 & 227.370
- The fire marshal developed an inspection program and implemented a "deputization program" to necessitate uniformity and to assist fire departments in these inspections
- Currently the State Fire Marshal has fifty Fire Departments that have been "deputized" or delegated authority to perform inspections in their districts by the Division of Fire Prevention
