The Governor has commuted the sentences of 1,235 inmates.

To date, Gov. Beshear has commuted the sentences of offenders in four groups:

- prison inmates who were deemed by medical professionals as higher risk for severe illness or death due to their medical conditions per CDC guidelines who had less than five years of their sentence left to serve;
- jail inmates who were deemed by medical professionals as higher risk for severe illness or death due to their medical conditions per CDC guidelines who had less than five years of their sentence left to serve;
- offenders over 65 years of age who had less than five years of their sentence left to serve;
- offenders who were within six months of serving out their sentence.

These were excluded from consideration by the Governor:

- All crimes violent by statutes
- All crimes violent by ASCA definition of “violent” or “other violent” – except wanton endangerment
- All sex crimes regardless of crime type
- All sentences of life and life without parole
- These crimes: arson, sex (any crime with the word ‘sex’ in title), manslaughter, homicide, stalking, assault, robbery, any crimes with the word “immoral” or “abuse”

Below is the list of specific CDC recommended prior medical conditions that was used to identify and classify inmates as medically vulnerable and eligible for early release:

- Heart disease
- Lung (severe asthma, COPD, chronic bronchitis, emphysema)
- Diabetes
- Liver failure
- Kidney failure
- Cancer (receiving chemotherapy, radiation)
- HIV
