Annually served - 2,816 visits from 435 unique individuals

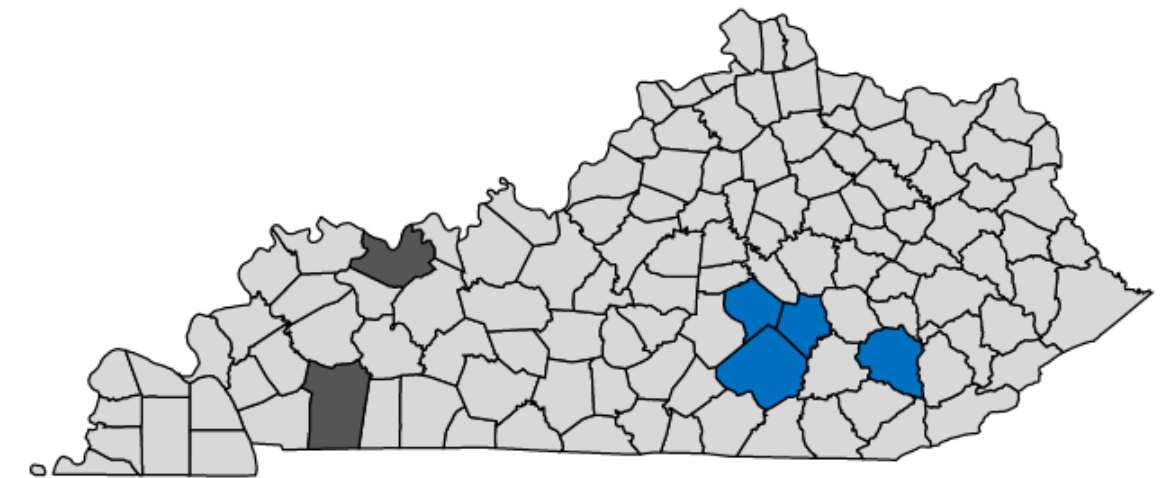
A community resource for education, information, support and socialization for those in recovery and their family and friends. We focus on Peer Recovery Support Services. The goal is to help remove barriers and provide access to support and resources to those who seek to achieve and sustain long-term recovery.

Since July 1, 2022, RCC has referred 48 people to VOA's Recovery Reintegration Program - employment services for people in recovery.

99%

99.24% of clients (since July 1) said they are satisfied with services provided at RCC.



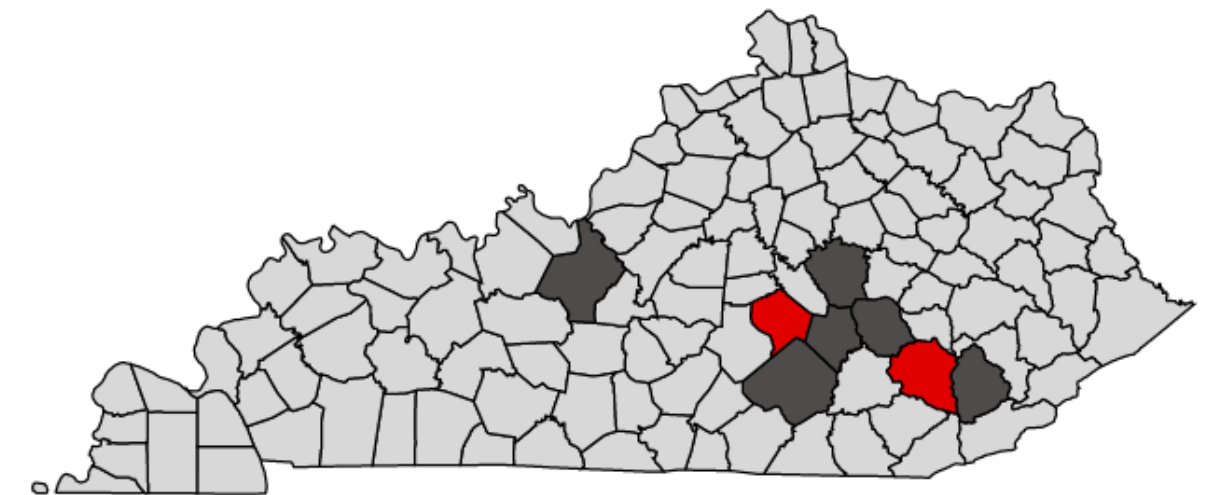

## Family Recovery Court - \$2 million

We work with families who struggle with substance use disorder and are involved in the child welfare system. The immediate goal is sobriety and the long term goal is family reunification. Individuals struggling with issues of substance use are referred to treatment programs by VOA staff who help them work toward recovery, build a support network and regain custody of their children.

85%

Within 6 months of entering the program, 85% of participants have achieved family reunification.

# Freedom House - \$15 million

Freedom House is a two-generation solution that saves taxpayer dollars, keeps families healthy and disrupts the cycle of addiction. This primary prevention model of care focuses on the delivery of healthy babies who avoid the debilitating effects of substance exposure through the secondary prevention of treating mothers and providing long-term recovery supports. As the data overwhelmingly confirms, the need for services throughout Kentucky is urgent and the cost savings are real. VOA has a proven record of an effective response that helps children and families heal.

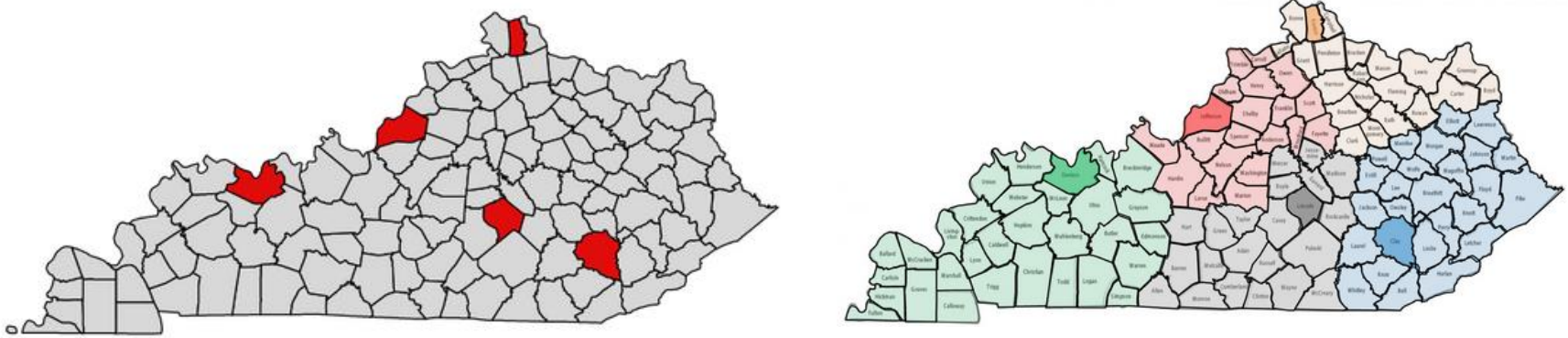
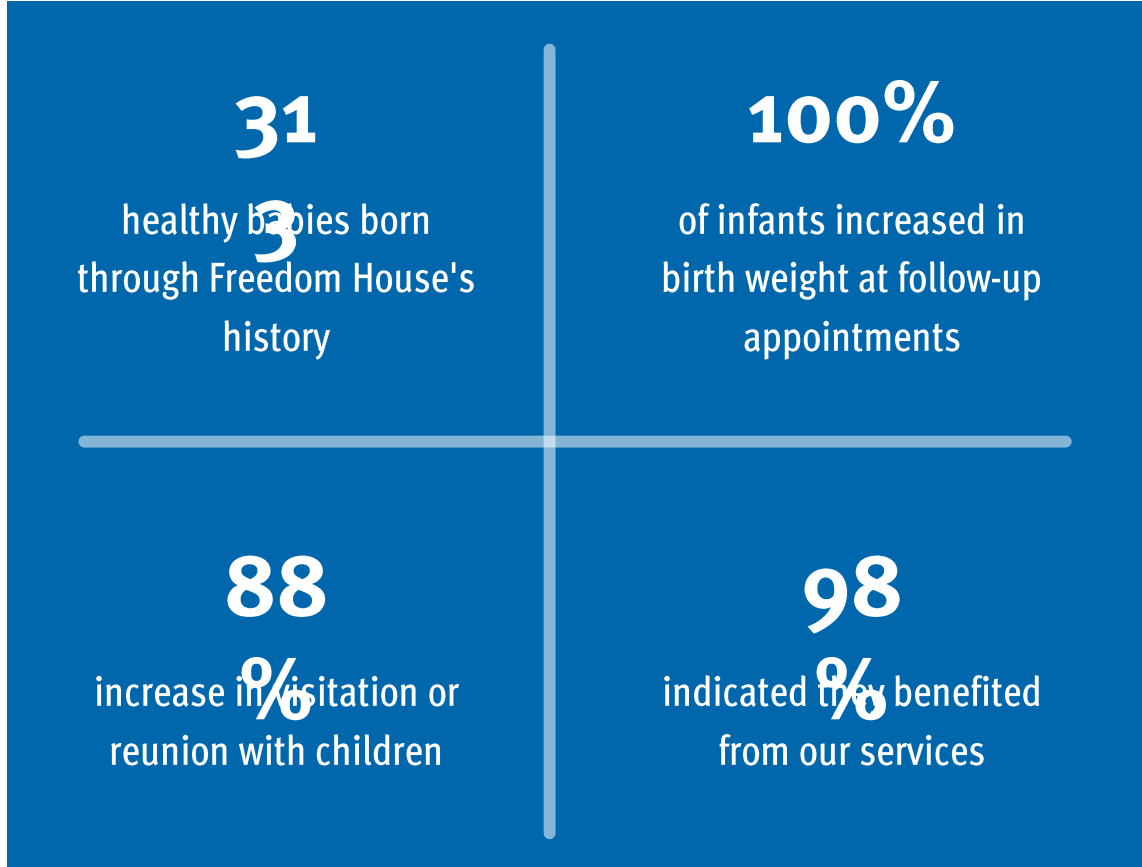
## Average NICU stay for infants born with a NAS
