Executive Summary

HFI intervenes without arrest in the lives of at-risk children and families.

Addresses chronic absenteeism— 15% of students statewide, 20% among low-income families.

2024–2025: 95,674 students served, 73,188 families, 162,714 parents across 19 DAs & 44 systems.

Mobile County Case Study

Reinstatement of HFI led to an overall 3.15% attendance improvement (2023–2024) and an overall 4% reduction in (2024–2025).

50% reduction in truancy; 58% reduction in chronic absenteeism.

The Recovered Value over the two year period was \$64.4M that otherwise would have been wasted. The combined state and local cost was \$1.32M.

The Return on Investment was \$48.67 for every dollar spent.

Superintendent Threadgill and DA Blackwood attribute gains to HFI.

Authorization & Funding

Authorized under Alabama Code §16-28-1 et seq. (Mandatory School Attendance Act).

District Attorneys required to enforce attendance laws vigorously.

Program Process Overview

Triggering Event – unexcused absences or serious violations of the codes of student conduct.

Engagement – contact with families via DA office. Families are treated with dignity and respect

Case Officer & Assessment – evaluate needs via NC Family Assessment Scale.

Individualized Intervention Plan & Interagency
Team – create tailored support plan.

Referrals – link families to counseling, social, and community services.

Follow-Up – monitor progress and outcomes.

Quantitative Results (2024–2025)

44 school systems across 19 circuits; 265,653 students (~36.5% of AL total).

95,674 students directly served; 73,188 families; 162,714 parents.

Student Absenteeism Wastes Tax Dollars

Comparing school years 2022-2023 and 2023-2024, \$47.3M recovered educational value; \$14.34 Return on \$3.3M State Investment.

Technology & Case
Management

2023: Launched HFI Case Management Database.

Automates data exchange from Alabama Department of Education; reduces clerical work for case officers.

Ensures consistency, accountability, and real-time data tracking.

2025– 2026 Early Results 12,174 students served; 10,580 families; 15,497 parents.

4,468 warning letters; 988 assessment letters sent.

56 Individualized Intervention Plans; 69 students referred for services.

1,081 referral agencies active across 1,695 ZIP codes.
