Purpose Statement

Kentucky Public Health Preparedness enhances the capacity of the Kentucky Department for Public Health, local public health departments, and the health care system to prevent, prepare for, respond to, and recover from the adverse health effects of public health emergencies and disasters.



Agency Overview: Quick Facts

The Kentucky Department for Public Health (KDPH) serves as the lead coordinating agency for public health, medical, and human services during emergency incidents or disasters in Kentucky.

Disasters and Emergency Response Guidance

- The National Response Framework (NRF) outlines how the nation responds to all types of disasters and emergencies, establishing a unified approach among federal, state, and local governments.
- The Kentucky State Emergency Operations Plan (EOP) outlines the organizational structure, roles and responsibilities, and procedures for coordinating and managing disaster and emergency response in the Commonwealth.
- Emergency Support Functions (ESFs) are groups of organizations within a specific functional area that work together to deliver core capabilities and support an effective response.
 - The Kentucky Department for Public Health is the primary coordinating agency for **ESF-8**: Public Health & Medical Services


Natural Hazards

- Severe Weather
 - 'Tornado Alley' shifting east to 'Dixie Alley;' a longer tornado season
 - Extreme rainfall events; flash flooding
 - Hurricanes; tropical storms; tropical depression remnants
- Disease Outbreaks
 - Measles
 - Declining vaccination rates


Technological Hazards


- 48-bed capacity (three wings)

Funding Overview: Quick Facts

Began in 2001 as federal bioterrorism prevention and response funding, then authorized the Public Health Emergency Preparedness (PHEP) and Hospital Preparedness (HPP) programs under the Pandemic & All Hazards Preparedness Reauthorization Act 2006, 2013 and 2019. This expired in 2024 and has operated on continuing resolutions since then.

- 100% federally funded via the U.S. Department of Health & Human Services (HHS)
 - All programs and all staff (~\$10,860,668 annually)
- Public Health Emergency Preparedness (PHEP) funded via CDC
 - ~60% of PHEP funds are used to support KY's 61 local health departments' capabilities
- Hospital Preparedness Program (HPP) funded via HHS Administration for Strategic Preparedness & Response (ASPR)
 - ~85% of HPP funds support healthcare coalitions, operations, and equipment

Public Health Preparedness Funds by Year (2002-2025)



^{*} The Prevention & Public Health Fund was established under Section 4002 of the Patient Protection & Affordable Care Act of 2010. Also known as the Prevention Fund or PPHF, it is the nation's first mandatory funding stream dedicated to improving our nation's public health system. \$40 million dollars is allocated annually to the Epidemiology & Laboratory Capacity Program as a result of PPHF.

Public Health Transformation and Local Health Funding for Local ESF8 Initiatives

In 2020, House Bill 129 was signed into law.

- KRS 211.185 established five required foundational public health programs:
 - Population health
 - 2. Enforcement of regulation
 - 3. Emergency preparedness and response
 - 4. Communicable disease control
 - 5. Administrative and organizational infrastructure
- KRS 211.186 established a new funding formula for local health departments to ensure funding for foundational services.

PHEP funding is allocated annually to local health departments to supplement local funding for emergency preparedness and response initiatives.

Sustainability Strategies for ESF-8

- Legislation committing dedicated funds for ESF-8 initiatives.
- Direct state-level general fund support in the CHFS biennial budget.
- Agency-level fee-based funds based on a percent of total fees collected for fee-based services provided by CHFS.
- Interagency funding from ESF-8 stakeholder agencies that operate under the ESF-8 umbrella.
- Collaboration on opportunities to sustain current federal funding and continued expansion into new federal funding strategies.
