ECONOMIC IMPACT


5 Commercial, 53 General Aviation Airports

- 39 airports statewide with 5,000 ft or longer
- 12.8 million passengers

\$23.7 billion in total economic output, or about 9.1% of its GDP (\$261.5 billion).

Over \$ 1 billion to state and local tax revenues.

Support over 116,000 part- and full-time jobs that generated \$8 billion in personal income

INVESTMENT IN AIRPORTS

2024 R.S. HB 1

(175)\$35,000,000 in fiscal year 2024-2025 to the Economic Development budget unit to support capital improvements at Kentucky Commercial Airports in the following allocations: (a) \$5,000,000 for the Bluegrass Airport; (b) \$5,000,000 for the Louisville Muhammad Ali International Airport; (c) \$20,000,000 for the Cincinnati/Northern Kentucky International Airport; (d) \$2,500,000 for the Barkley Regional Airport; and (e) \$2,500,000 for the Owensboro-Daviess County Regional Airport;

AIRPORT INFRASTRUCTURE

Cabinet for Economic Development contacted KY Department of Aviation to inquire about land availability at general aviation airports

- Understand possible development opportunities at airports
- Limitations and Challenges
- Explore KPDI option for land acquisition at airports

Government Resources Accelerating Needed Transformation (GRANT) Program

- A Kentucky county, city or 501(c)(3) nonprofit charitable organization engaged in public benefit improvements that is seeking federal funding assistance.
- Three airport projects received approval for the GRANT match <u>pending</u> federal approval

MARKETING AVIATION SECTOR

- CED promotes airport proximity and capabilities to companies looking to locate or expand in Kentucky

- Market aviation-related workforce and education assets:
