

1 AN ACT relating to wagering and making an appropriation therefor.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 →SECTION 1. KRS CHAPTER 239 IS ESTABLISHED AND A NEW  
4 SECTION THEREOF IS CREATED TO READ AS FOLLOWS:

5 *As used in this chapter unless the context requires otherwise:*

6 *(1) "Adjusted gross revenue" means the total sum of entry fees collected by a fantasy*  
7 *contest operator from all participants entering a fantasy contest, less winnings*  
8 *paid to participants in the contest, multiplied by the resident percentage;*

9 *(2) "Beginner" means a fantasy sports contest player who has entered fewer than*  
10 *fifty-one (51) contests offered by a single fantasy sports contest operator and who*  
11 *does not otherwise meet the definition of highly experienced player;*

12 *(3) "Cabinet" means the Public Protection Cabinet;*

13 *(4) "Confidential information" means information related to the play of a fantasy*  
14 *contest by fantasy contest participants obtained as a result of or by virtue of a*  
15 *person's employment;*

16 *(5) "Entry fee" means the cash or cash equivalent that is required to be paid by a*  
17 *fantasy contest participant to a fantasy contest operator in order to participate in*  
18 *a fantasy contest;*

19 *(6) "Fantasy contest" means any fantasy or simulated game or contest that meets the*  
20 *following conditions:*

21 *(a) The values of all prizes and awards offered to winning participants are*  
22 *made known to the participants in advance of the contest;*

23 *(b) All winning outcomes reflect the relative knowledge and skill of the*  
24 *participants and shall be determined predominantly by accumulated*  
25 *statistical results of the performance of individuals, including athletes in the*  
26 *case of sports events;*

27 *(c) No winning outcome is based on:*

- 1           1. Randomized or historical events;
- 2           2. The score, point spread, or any performance or performances of any
- 3           single actual team or combination of such teams; or
- 4           3. Solely on any single performance of an individual athlete or
- 5           participant in any single actual event; and
- 6           (d) Does not violate any provision of federal law;
- 7       (7) "Fantasy contest operator" or "operator" means a person who offers or
- 8           administers one (1) or more fantasy contests with an entry fee to the general
- 9           public, and awards a prize of value;
- 10       (8) "Fantasy contest participant" or "participant" means a person who participates
- 11           in a fantasy contest offered by a registrant;
- 12       (9) "Highly experienced player" means a person who has either:
- 13           (a) Entered more than one thousand (1,000) fantasy contests offered by a single
- 14           fantasy sports contest operator; or
- 15           (b) Won more than three (3) fantasy sports contest prizes valued at one
- 16           thousand dollars (\$1,000) or more from a single fantasy sports contest
- 17           operator. Upon making a determination that a player is a highly
- 18           experienced player, the fantasy sports contest operator shall continue to
- 19           classify the player as a highly experienced player indefinitely;
- 20       (10) "Immediate family" means a person's parents, grandparents, spouse, siblings,
- 21           children, or grandchildren residing in a home occupied by the person as a
- 22           primary residence;
- 23       (11) "Location percentage" means for each fantasy contest, the percentage, rounded
- 24           to the nearest tenth of a percent (0.1%), of the total entry fees collected from
- 25           participants located in the Commonwealth divided by the total entry fees collected
- 26           from all participants in the fantasy contest;
- 27       (12) "Person" has the same meaning as in KRS 446.010;

1 (13) "Principal stockholder" means any person who, individually or together with his  
2 or her spouse and immediate family members, beneficially owns or controls,  
3 directly or indirectly, fifteen percent (15%) or more of the equity ownership of a  
4 registrant or who, together with his or her spouse and immediate family  
5 members, has the power to vote or cause the vote of fifteen percent (15%) or more  
6 of a registrant;

7 (14) "Registered fantasy contest operator" or "registrant" means a fantasy contest  
8 operator that has been issued a valid registration by the cabinet;

9 (15) "Script" means automating a manual act using a coding language online,  
10 whereby a list of multiple commands may be executed without the user's  
11 interaction;

12 (16) "Secretary" means the secretary of the Public Protection Cabinet; and

13 (17) "Wager" means a sum of money or representation of value that is risked on an  
14 occurrence for which the outcome is uncertain.

15 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
16 READ AS FOLLOWS:

17 (1) No fantasy contest operator shall offer a fantasy contest to residents of the  
18 Commonwealth without a valid registration issued by the cabinet, except that  
19 fantasy contest operators with fewer than one hundred (100) participants located  
20 in the Commonwealth in a calendar year shall be exempt from this requirement.

21 (2) Any person seeking to be registered as a fantasy contest operator shall submit an  
22 application to the cabinet on a form prescribed by the cabinet as promulgated in  
23 an administrative regulation, accompanied by payment of the required fee  
24 established in subsection (4) of this section.

25 (3) The applicant shall provide the following information to the cabinet as a  
26 prerequisite for registration:

27 (a) The name of the applicant;

- 1 (b) The location of the applicant's principal place of business;
- 2 (c) A disclosure of ownership of the applicant including all directors, officers,  
3 and principal stockholders;
- 4 (d) A designation of the responsible party who is the agent for the contest  
5 operator for all communications with the cabinet;
- 6 (e) 1. The criminal record of all officers, general partners, and principal  
7 stockholders of the applicant.
- 8 2. An applicant may not be eligible for registration or renewal as a  
9 fantasy contest operator if the applicant or any of its officers, general  
10 partners, or principal stockholders has been convicted of or has  
11 entered a plea of nolo contendere or guilty to a felony; and
- 12 (f) Any other documentation the cabinet may require.
- 13 (4) (a) The initial registration fee for a fantasy contest operator shall be five  
14 thousand dollars (\$5,000).
- 15 (b) The annual renewal fee for a fantasy contest operator shall be an amount  
16 equal to the greater of:
- 17 1. Six percent (6%) of the adjusted gross revenues for the prior calendar  
18 year; or
- 19 2. Five thousand dollars (\$5,000).
- 20 (c) The initial registration fee and the annual renewal fee shall be deposited  
21 into the wagering administration fund established in Section 4 of this Act.
- 22 →SECTION 3. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
23 READ AS FOLLOWS:
- 24 (1) (a) The cabinet shall promulgate administrative regulations for the operation  
25 of fantasy contests as necessary to enforce the provisions of this chapter, but the  
26 cabinet shall not promulgate administrative regulations limiting or regulating:
- 27 1. Rules or the administration of an individual contest or contests;

- 1           2. The statistical makeup of a contest or contests; or
- 2           3. The digital platform of an operator.
- 3           (b) The cabinet shall promulgate the administrative regulations listing the  
4           requirements for registration within thirty (30) days of the effective date of  
5           this Act.
- 6           (2) The cabinet shall consider all applications for registration and shall issue a valid  
7           registration to an applicant that meets the criteria set forth in Section 2 of this  
8           Act and any administrative regulations promulgated by the cabinet.
- 9           (3) (a) The cabinet shall have thirty (30) days after receiving an initial application  
10           to issue a registration or deny the application.
- 11           (b) The cabinet shall prepare and issue a written statement setting forth the  
12           reasons why an application for registration has been denied.
- 13           (4) All fantasy contest operators who meet the requirements for registration shall be  
14           registered by January 15, 2020.
- 15           (5) The cabinet may revoke, deny, or suspend the registration of a fantasy contest  
16           operator if it finds that:
- 17           (a) Any partner, member, officer, principal stockholder, or director of the  
18           operator has been convicted of a felony in this state, a felony in another  
19           state which would be a felony if committed in this state, or a felony under  
20           the laws of the United States. For purposes of this paragraph, the term  
21           "convicted" means having been found guilty, regardless of adjudication of  
22           guilt, as a result of a jury verdict, nonjury trial, or entry of a plea of guilty  
23           or nolo contendere; or
- 24           (b) Any fantasy contest operator has:
- 25           1. Violated any order of the secretary or any of the provisions set forth in  
26           this chapter;
- 27           2. Failed to meet the requirements for licensure under this chapter; or

- 1           3. Used fraud, misrepresentation, or deceit in applying for or attempting  
2           to apply for a registration or otherwise in operating or offering to  
3           operate a fantasy contest.
- 4   (6) If it appears to the secretary, based upon credible evidence presented in a written  
5           complaint, that a person is operating or offering to operate a fantasy contest  
6           without being registered, the secretary may issue an order to cease and desist the  
7           activity.
- 8   (7) The secretary shall set forth in the order:
- 9           (a) The statutes and administrative regulations alleged to have been violated;  
10           (b) The facts alleged to have constituted the violation; and  
11           (c) The requirement that all unauthorized practices immediately cease.
- 12   (8) (a) Within ten (10) days after service of the order to cease and desist, the person  
13           may request a hearing on the question of whether acts or practices in  
14           violation of this section have occurred. The hearing shall be conducted  
15           pursuant to KRS Chapter 13B.
- 16           (b) The person may appeal the final order of the cabinet to the Franklin Circuit  
17           Court within thirty (30) days of the hearing.
- 18   (9) To ensure that the cabinet is not spending more than what is necessary to cover  
19           administrative expenses, on June 30 of each year, the cabinet shall submit to the  
20           Legislative Research Commission and the Interim Joint Committee on Licensing,  
21           Occupations, and Administrative Regulations a written report detailing financial  
22           transactions, including:
- 23           (a) The number of applications received;  
24           (b) The number of applications approved;  
25           (c) The number of applications denied;  
26           (d) The amount of funds received from initial registration fees;  
27           (e) The amount of funds received from annual renewal fees; and

- 1        (f) The amount of funds expended to enforce this chapter.  
2 (10) KRS Chapters 230 and 528 shall not apply to fantasy contests operated in  
3 accordance with this chapter.

4        ➔ SECTION 4. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
5 READ AS FOLLOWS:

- 6 (1) (a) There is hereby established in the State Treasury a restricted account to be  
7 known as the wagering administration fund. The fund shall consist of  
8 moneys received from the money collected under Sections 2, 15, 19, and 42  
9 of this Act and state appropriations.
- 10 (b) 1. Amounts deposited in the fund shall be used for administrative  
11 expenses of the cabinet and shall be disbursed by the Finance and  
12 Administration Cabinet upon the warrant of the Public Protection  
13 Cabinet.
- 14 2. The remaining funds shall be used as follows:
- 15 a. Five percent (5%) of the funds remaining after the expenses  
16 under subparagraph 1. of this paragraph shall be deposited in  
17 the Kentucky problem gambling assistance fund established in  
18 Section 5 of this Act; and
- 19 b. All remaining funds not allocated under subparagraph 1. of this  
20 paragraph or subdivision a. of subparagraph 2. of this  
21 paragraph shall be deposited in the Kentucky permanent pension  
22 fund established in KRS 42.205.
- 23 3. Any interest accruing to the fund shall become a part of the fund and  
24 shall not lapse.
- 25 (2) Notwithstanding KRS 45.229, fund amounts not expended at the close of a fiscal  
26 year shall not lapse but shall be carried forward into the next fiscal year.
- 27 (3) Moneys deposited in the fund are hereby appropriated for the purposes set forth

1 in this section and shall not be appropriated or transferred by the General  
2 Assembly for any other purposes.

3 →SECTION 5. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
4 READ AS FOLLOWS:

5 (1) (a) There is established in the State Treasury a revolving account to be known  
6 as the Kentucky problem gambling assistance account.

7 (b) The account shall be administered by the director of the Division of  
8 Behavioral Health of the Department for Behavioral Health,  
9 Developmental and Intellectual Disabilities, and shall consist of moneys  
10 distributed to it under Section 4 of this Act.

11 (c) Notwithstanding KRS 45.229, moneys remaining in the account at the close  
12 of a fiscal year shall not lapse but shall carry forward into the succeeding  
13 fiscal year. Interest earned on any moneys in the account shall accrue to the  
14 account.

15 (d) Except for administrative expenses of the Division of Behavioral Health  
16 relating to the account, which shall be limited to fifty thousand dollars  
17 (\$50,000) per year, all moneys in the account are appropriated for, and  
18 shall be used exclusively for the purposes of:

19 1. Providing support to agencies, groups, organizations, and persons that  
20 provide education, assistance, and counseling to persons and families  
21 experiencing difficulty as a result of addiction to alcohol or drugs, or  
22 addictive or compulsive gambling;

23 2. Promoting public awareness of, and providing education about  
24 addictions;

25 3. Establishing and funding programs to certify addiction counselors;

26 4. Promoting public awareness of assistance programs for addicts; and

27 5. Paying the costs and expenses associated with the treatment of



- 1                   additions.
- 2     (2) The cabinet shall promulgate administrative regulations to establish criteria for  
3     the expenditure of funds from the Kentucky addiction assistance account. The  
4     administrative regulations shall:
- 5         (a) Establish standards for the types of agencies, groups, organizations, and  
6             persons eligible to receive funding;
- 7         (b) Establish standards for the types of activities eligible for funding;
- 8         (c) Establish standards for the appropriate documentation of past performance  
9             and the activities of agencies, groups, organizations, and persons requesting  
10            funding;
- 11         (d) Establish standards for the development of performance measures or other  
12             evidence of successful expenditure of awarded funds;
- 13         (e) Set forth procedures for the submission, evaluation, and review of  
14             applications for funding;
- 15         (f) Set forth procedures for making funding awards to requesting entities who  
16             have demonstrated the capability to efficiently and effectively provide the  
17             necessary services;
- 18         (g) Establish requirements and procedures for the monitoring of funds  
19             awarded, including requirements for the submission of reports and  
20             documentation supporting expenditures; and
- 21         (h) Include any other provisions related to funding or the administration of the  
22             account as determined by the cabinet.
- 23     (3) On or before October 1, 2020, and every October 1 thereafter, the director of the  
24     Division of Behavioral Health, in cooperation with the commissioner of the  
25     Department for Behavioral Health, Developmental and Intellectual Disabilities  
26     and the secretary, shall submit an annual report detailing activities and  
27     expenditures associated with the Kentucky problem gambling assistance account

1 for the preceding fiscal year. The annual report shall be submitted to:

2 (a) The Legislative Research Commission; and

3 (b) The Governor.

4 →SECTION 6. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
5 READ AS FOLLOWS:

6 (1) (a) A registrant offering fantasy contests shall annually submit its records to a  
7 certified public accountant to perform an annual independent audit  
8 consistent with the standards of the American Institute of Certified Public  
9 Accountants to ensure compliance with all of the requirements in this  
10 chapter.

11 (b) The registrant shall pay all costs of the audit. The audit shall cover one (1)  
12 fiscal year.

13 (2) (a) Each registrant shall keep daily records of its operations and shall maintain  
14 the records for at least six (6) years.

15 (b) The records shall sufficiently detail all financial transactions to determine  
16 compliance with the requirements of this chapter and shall be available for  
17 audit and inspection by the cabinet during the registrant's regular business  
18 hours.

19 →SECTION 7. A NEW SECTION OF KRS CHAPTER 239 IS CREATED TO  
20 READ AS FOLLOWS:

21 (1) A registrant shall implement commercially reasonable procedures for the conduct  
22 of fantasy contests requiring an entry fee that are intended to:

23 (a) Prevent the registrant, its employees, and the immediate family of employees  
24 from competing in any public fantasy contest with a cash prize offered by  
25 any fantasy contest operator;

26 (b) Prevent sharing of confidential information with third parties that could  
27 affect fantasy contest play until that information is made publicly available;

- 1 (c) Verify that each fantasy contest participant in each fantasy contest is  
2 eighteen (18) years of age or older;
- 3 (d) Prevent an individual who is a participant or game official in an actual  
4 sporting event or competition from participating in any fantasy contest that  
5 is determined in whole or in part on the performance of that individual, the  
6 individual's actual team, or the accumulated statistical results of the  
7 sporting event or competition in which the individual is a participant or  
8 contest official;
- 9 (e) Allow an individual, upon request, to exclude himself or herself from  
10 entering a fantasy contest upon request and provide reasonable steps to  
11 prevent that person from entering the fantasy contests offered by the fantasy  
12 contest operator;
- 13 (f) Disclose the number of entries that a participant may submit to each  
14 fantasy contest;
- 15 (g) Provide reasonable steps to prevent participants from submitting more than  
16 the allowable number of entries;
- 17 (h) 1. In any contest involving more than one hundred (100) entries, prevent  
18 a participant from submitting more than the lesser of:  
19 a. Three percent (3%) or more of all entries; or  
20 b. One hundred fifty (150) entries.
- 21 2. Notwithstanding subparagraph 1. of this paragraph, a registrant may  
22 establish contests in which there are no restrictions on the number of  
23 entries if:  
24 a. The registrant clearly discloses that there are no limits on the  
25 number of entries by each participant in the contest; and  
26 b. That the entry fee is fifty dollars (\$50) or more per entry;
- 27 (i) Segregate participants' funds from operational funds or maintain a reserve

1 in the form of cash, cash equivalents, payment processor reserves, payment  
2 processor receivables, an irrevocable letter of credit, a bond, an escrow  
3 account approved by the cabinet, or a combination thereof, in the amount of  
4 the deposits in participants' accounts for benefit and protection of the funds  
5 held in those accounts;

6 (j) Distinguish highly experienced participants and beginner participants and  
7 ensure that highly experienced participants are conspicuously identified to  
8 all participants;

9 (k) Prohibit the use of external scripts in fantasy contests that give a participant  
10 an unfair advantage over other participants and make all authorized scripts  
11 readily available to all fantasy contest participants;

12 (l) Clearly and conspicuously disclose all rules that govern its contests,  
13 including the material terms of each promotional offer at the time the offer  
14 is advertised; and

15 (m) Use technologically reasonable measures to limit each fantasy contest  
16 participant to one (1) active account with that operator.

17 (2) A registrant shall not conduct, operate, or offer a fantasy contest that:

18 (a) Utilizes:

19 1. Video or mechanical reels or symbols or any other depictions of slot  
20 machines, poker, blackjack, craps, or roulette; or

21 2. Any device that qualifies as or replicates contest activities that  
22 constitute gaming; or

23 (b) Includes a university, college, high school, or youth athletic contest or  
24 event.

25 (3) Officers and directors of registrants along with their immediate family are  
26 prohibited from competing in any fantasy contest offered by any fantasy contest  
27 operator in which the operator offers a cash prize.

- 1 (4) (a) Any person who knowingly violates any provision of this chapter shall:
- 2 1. For the first offense, be liable for a civil penalty of not less than one
- 3 thousand dollars (\$1,000) nor more than five thousand dollars
- 4 (\$5,000) for each act or omission that constitutes a violation; or
- 5 2. a. For a second or subsequent offense, be liable for a civil penalty
- 6 of not less than five thousand dollars (\$5,000) and not more than
- 7 twenty-five thousand dollars (\$25,000); or
- 8 b. Revocation of registration at the discretion of the secretary.
- 9 (b) A civil penalty assessed under this subsection shall accrue to the
- 10 Commonwealth and may be recovered in a civil action brought by the
- 11 cabinet.
- 12 (c) Nothing in this chapter shall deprive an aggrieved participant of any
- 13 personal right of redress.

14 → Section 8. KRS 230.210 is amended to read as follows:

15 As used in this chapter, unless the context requires otherwise:

- 16 (1) "Advance deposit account wagering" means a form of ~~pari-mutuel~~ wagering in
- 17 which an individual may establish an account with a person or entity licensed by the
- 18 racing commission, and may place a pari-mutuel or sports wager through that
- 19 account that is permitted by law;
- 20 (2) "Advance deposit account wagering licensee" means a person or entity licensed by
- 21 the racing commission to conduct advance deposit account wagering and accept
- 22 deposits and wagers, issue a receipt or other confirmation to the account holder
- 23 evidencing such deposits and wagers, and transfer credits and debits to and from
- 24 accounts;
- 25 (3) "Appaloosa race" or "Appaloosa racing" means that form of horse racing in which
- 26 each horse participating in the race is registered with the Appaloosa Horse Club of
- 27 Moscow, Idaho, and is mounted by a jockey;

- 1 (4) "Arabian" means a horse that is registered with the Arabian Horse Registry of  
2 Denver, Colorado;
- 3 (5) "Association" means any person licensed by the Kentucky Horse Racing  
4 Commission under KRS 230.300 and engaged in the conduct of a recognized horse  
5 race meeting;
- 6 (6) "Harness race" or "harness racing" means trotting and pacing races of the  
7 standardbred horses;
- 8 (7) "Horse race meeting" means horse racing run at an association licensed and  
9 regulated by the Kentucky Horse Racing Commission, and may include  
10 Thoroughbred, harness, Appaloosa, Arabian, paint, and quarter horse racing;
- 11 (8) "Host track" means the track conducting racing and offering its racing for intertrack  
12 wagering, or, in the case of interstate wagering, means the Kentucky track  
13 conducting racing and offering simulcasts of races conducted in other states or  
14 foreign countries;
- 15 (9) "Intertrack wagering" means pari-mutuel wagering on simulcast horse races from a  
16 host track by patrons at a receiving track;
- 17 (10) "Interstate wagering" means pari-mutuel wagering on simulcast horse races from a  
18 track located in another state or foreign country by patrons at a receiving track or  
19 simulcast facility;
- 20 (11) "Kentucky quarter horse, paint horse, Appaloosa, and Arabian purse fund" means a  
21 purse fund established to receive funds as specified in KRS 230.3771 for purse  
22 programs established in KRS 230.446 to supplement purses for quarter horse, paint  
23 horse, Appaloosa, and Arabian horse races. The purse program shall be  
24 administered by the Kentucky Horse Racing Commission;
- 25 (12) "Kentucky resident" means:
- 26 (a) An individual domiciled within this state;
- 27 (b) An individual who maintains a place of abode in this state and spends, in the

- 1 aggregate, more than one hundred eighty-three (183) days of the calendar year  
2 in this state; or
- 3 (c) An individual who lists a Kentucky address as his or her principal place of  
4 residence when applying for an account to participate in advance deposit  
5 account wagering;
- 6 (13) "Paint horse" means a horse registered with the American Paint Horse Association  
7 of Fort Worth, Texas;
- 8 (14) "Principal" means any of the following individuals associated with a partnership,  
9 trust, association, limited liability company, or corporation that is licensed to  
10 conduct a horse race meeting or an applicant for a license to conduct a horse race  
11 meeting:
- 12 (a) The chairman and all members of the board of directors of a corporation;
- 13 (b) All partners of a partnership and all participating members of a limited  
14 liability company;
- 15 (c) All trustees and trust beneficiaries of an association;
- 16 (d) The president or chief executive officer and all other officers, managers, and  
17 employees who have policy-making or fiduciary responsibility within the  
18 organization;
- 19 (e) All stockholders or other individuals who own, hold, or control, either directly  
20 or indirectly, five percent (5%) or more of stock or financial interest in the  
21 collective organization; and
- 22 (f) Any other employee, agent, guardian, personal representative, or lender or  
23 holder of indebtedness who has the power to exercise a significant influence  
24 over the applicant's or licensee's operation;
- 25 (15) "Professional sports venue" means a facility, including but not limited to an  
26 indoor arena, outdoor stadium, or race track with seating for at least fifty  
27 thousand (50,000) and where professional sporting events are held under the

1           auspices of a professional league recognized by the racing commission under  
2           Section 10 of this Act;

3       (16) "Quarter horse" means a horse that is registered with the American Quarter Horse  
4           Association of Amarillo, Texas;

5       (17)~~(16)~~ "Racing commission" means the Kentucky Horse Racing Commission;

6       (18)~~(17)~~ "Receiving track" means a track where simulcasts are displayed for wagering  
7           purposes. A track that submits an application for intertrack wagering shall meet all  
8           the regulatory criteria for granting an association license of the same breed as the  
9           host track, and shall have a heated and air-conditioned facility that meets all state  
10          and local life safety code requirements and seats a number of patrons at least equal  
11          to the average daily attendance for intertrack wagering on the requested breed in the  
12          county in which the track is located during the immediately preceding calendar year;

13       (19)~~(18)~~ "Simulcast facility" means any facility approved pursuant to the provisions of  
14          KRS 230.380 to simulcast racing and conduct pari-mutuel wagering;

15       (20)~~(19)~~ "Simulcasting" means the telecast of live audio and visual signals of horse  
16          races for the purpose of pari-mutuel wagering;

17       (21)~~(20)~~ "Sports wagering" means the placing of wagers on the outcomes of  
18          professional sports contests and other events in conformance with federal law  
19          and as authorized by the racing commission at tracks and through advanced

10 (1) Sporting events that may be wagered upon at the discretion of the racing

6 (2) Random events not integral to the course of play of a sporting event, including  
 7 but not limited to:

- 8 (a) The result of a coin toss;  
 9 (b) The color of a coaches tie; or  
 10 (c) Other events that are not the result of the skilled play of the game;  
 11 shall not be wagered on, and the racing commission shall act as arbiter of  
 12 acceptable wagers when a question arises.

13 ➔Section 11. KRS 230.215 is amended to read as follows:

- 14 (1) (a) It is the policy of the Commonwealth of Kentucky, in furtherance of its  
 15 responsibility to foster and to encourage legitimate occupations and industries  
 16 in the Commonwealth and to promote and to conserve the public health,  
 17 safety, and welfare, and it is hereby declared the intent of the Commonwealth  
 18 to foster and to encourage the horse breeding industry within the  
 19 Commonwealth and to encourage the improvement of the breeds of horses.

10 (1) The racing commission is vested with jurisdiction and supervision over all horse

- 7 (7) Written notice of any petition seeking court approval of an assignment under

26 conduct procurements in accordance with the provisions of KRS Chapter 45A, the  
27 corporation may include sections of KRS Chapter 45A as part of its administrative

1 regulations. However, major lottery-specific or online poker-specific procurements  
2 for personal service contracts shall not be subject to the requirements of KRS  
3 45A.695(2)(b), due to the unique operational activities conducted for state  
4 government by the corporation as recognized in KRS 154A.020. The corporation's  
5 procurement procedures or administrative regulations shall be designed to provide  
6 for the purchase of supplies, equipment, services, and construction items that  
7 provide the greatest long term benefit to the state, the greatest integrity for the  
8 corporation, and the best service and products, for the public.

9 (2) In its bidding and negotiation processes, the corporation may do its own bidding  
10 and procurement, or may utilize the services of the Finance and Administration  
11 Cabinet, or a combination thereof. The president of the corporation may, in lieu of  
12 the secretary of finance, declare an emergency for purchasing purposes.

13 ➔Section 40. KRS 154A.130 is amended to read as follows:

14 (1) All money received by the corporation from the sale of lottery tickets and all other  
15 sources, except from the proceeds of online poker, shall be deposited into a  
16 corporate operating account. The corporation is authorized to use all money in the  
17 corporate operating account for the purposes of paying prizes and the necessary  
18 expenses of the corporation and dividends to the state. The corporation shall  
19 allocate the amount to be paid by the corporation to prize winners. The amount in  
20 the corporate operating account which the corporation anticipates will be available  
21 for the payment of prizes on an annuity basis may be invested in direct United  
22 States Treasury obligations. These instruments may be in varying maturities with  
23 respect to payment of annuities and may be in book-entry form. Monthly, no later  
24 than the last business day of the succeeding month, the corporation shall transfer to  
25 a lottery trust fund the amount of net revenues which the corporation determines are  
26 surplus to its needs. These funds shall be held in trust until 1990 at which time the  
27 General Assembly shall determine the manner in which the funds will be allocated

1 and appropriated. The net revenues shall be determined by deducting from gross  
2 revenues the payment costs incurred in the operation and administration of the  
3 lottery, including the expenses of the corporation and the costs resulting from any  
4 contract or contracts entered into for promotional, advertising, or operational  
5 services or for the purchase or lease of lottery equipment and materials, fixed  
6 capital outlays, and the payment of prizes to the holders of winning tickets. After  
7 the start-up costs are paid, it is the intent of the Legislature that it shall be the goal  
8 of the corporation to transfer each year thirty-five percent (35%) of gross revenues  
9 to the general fund for the purposes stated above.

10 (2) A Kentucky lottery trust account is established in the State Treasury. Net lottery  
11 revenues shall be credited to this restricted account as provided in subsection (1) of  
12 this section. Moneys credited to the Kentucky lottery trust account shall be invested  
13 by the state in accordance with state investment practices and all earnings from the  
14 investments shall accrue to this account. No moneys shall be allotted or expended  
15 from this account unless pursuant to an appropriation by the General Assembly,  
16 except that moneys as are needed shall be transferred to the general fund pursuant to  
17 the provisions of the Acts of the Extraordinary Session of the 1988 General  
18 Assembly. Moneys in the Kentucky lottery trust account shall not lapse at the close  
19 of the state fiscal year.

20 (3) Each fiscal year, three million dollars (\$3,000,000) from net lottery revenues from  
21 the sale of lottery tickets shall be credited from the general fund as follows:

22 (a) To the Collaborative Center for Literacy Development, one million two  
23 hundred thousand dollars (\$1,200,000); and

24 (b) To the reading diagnostic and intervention fund, one million eight hundred  
25 thousand dollars (\$1,800,000).

26 (4) After the allocation of three million dollars (\$3,000,000) to literacy development, as  
27 provided in subsection (3) of this section, net lottery revenues from the sale of

- 1 lottery tickets shall be credited from the general fund as follows:
- 2 (a) To the Wallace G. Wilkinson Kentucky educational excellence scholarship  
3 trust fund established in KRS 164.7877:
- 4 1. Forty percent (40%) in fiscal year 2003-2004; and
  - 5 2. Forty-five percent (45%) in fiscal year 2004-2005 and each fiscal year  
6 thereafter; and
- 7 (b) To the College Access Program and the Kentucky Tuition Grants Program  
8 established in KRS Chapter 164:
- 9 1. Forty percent (40%) in fiscal year 2003-2004;
  - 10 2. Forty-five percent (45%) in fiscal year 2004-2005; and
  - 11 3. Fifty-five percent (55%) of net lottery revenues in fiscal year 2005-2006  
12 and each fiscal year thereafter.
- 13 (5) The Auditor of Public Accounts shall be responsible for a financial postaudit of the  
14 books and records of the corporation. The postaudit shall be conducted in  
15 accordance with generally accepted accounting principles, shall be paid for by the  
16 corporation, and shall be completed within ninety (90) days of the close of the  
17 corporation's fiscal year. The Auditor of Public Accounts shall contract with an  
18 independent, certified public accountant who meets the qualifications existing to do  
19 business within the Commonwealth of Kentucky to perform the corporation  
20 postaudit. The Auditor of Public Accounts shall remain responsible for the annual  
21 postaudit and the corporation shall pay all audit costs. The Auditor of Public  
22 Accounts may at any time conduct additional audits, including performance audits,  
23 of the corporation as he deems necessary or desirable. Contracts shall be entered  
24 into for audit services for a period not to exceed five (5) years and the same firm  
25 shall not receive two (2) consecutive audit contracts. All audits shall be filed with  
26 the Governor, the President of the Senate, and the Speaker of the House of  
27 Representatives. The corporation shall reimburse the Auditor of Public Accounts

1 for the reasonable costs of any audits performed by him. The corporation shall  
2 cooperate with the Auditor of Public Accounts by giving employees designated by  
3 any of them access to facilities of the corporation for the purpose of efficient  
4 compliance with their respective responsibilities. With respect to any  
5 reimbursement that the corporation is required to pay to any agency, the corporation  
6 shall enter into an agreement with that agency under which the corporation shall pay  
7 to the agency an amount reasonably anticipated to cover the reimbursable expenses  
8 in advance of the expenses being incurred.

9 (6) By no later than December 31 of each year, in an advertisement at least one-fourth  
10 (1/4) of a page in size, the Kentucky Lottery Corporation shall publish the following  
11 information in every general-circulation daily newspaper published in Kentucky:

12 (a) The statements of revenue, expenses, and changes in retained earnings as  
13 shown in the most recent annual audit report. It shall be explained that the  
14 transfer of dividends is the amount of lottery earnings transferred to the  
15 general fund;

16 (b) A statement identifying the auditing firm;

17 (c) A telephone number which citizens may call to obtain a complete copy of the  
18 annual audit report; and

19 (d) The name of the president/chief executive officer of the Kentucky Lottery  
20 Corporation and a complete list of board members.

21 The Kentucky Lottery Corporation shall pay for the cost of the advertisement.

22 ➔SECTION 41. A NEW SECTION OF KRS CHAPTER 154A IS CREATED  
23 TO READ AS FOLLOWS:

24 (1) No person shall offer online poker in the Commonwealth unless that person has  
25 received a license from the corporation.

26 (2) The corporation shall promulgate administrative regulations prescribing  
27 requirements for vendors offering online poker gaming to the citizens of the



- 1 Commonwealth. The requirements for each game or game provider shall include  
2 but not be limited to the following:
- 3 (a) Geolocation software to ensure that all online poker is conducted within the  
4 geographical confines of the state of Kentucky;
- 5 (b) Age verification to ensure that no person under the age of eighteen (18) is  
6 allowed to place wagers through online poker games;
- 7 (c) Security standards to minimize the risk of cyber theft or hacking; and  
8 (d) Accounting standards to ensure transparency and accountability of moneys  
9 including:
- 10 1. Moneys deposited by players into gaming accounts;  
11 2. Prize payouts;  
12 3. The rake the online poker vendor receives;  
13 4. Any entry or associated fees charged to players; and
- 14 (e) Conformance with all applicable federal laws.
- 15 (3) A license to conduct online poker in the Commonwealth shall not be issued by  
16 the corporation until the proposed vendor has demonstrated to the satisfaction of  
17 the corporation that:
- 18 (a) All the requirements of subsection (2) of this section have been met;  
19 (b) The vendor has not been convicted of a violation of the Unlawful Internet  
20 Gambling Enforcement Act of 2006, as provided in Title 31 of the United  
21 States Code, sections 5361 to 5366; and
- 22 (c) An initial licensing fee of two hundred fifty thousand dollars (\$250,000) has  
23 been paid.
- 24 (4) A license issued under subsection (3) of this section shall be valid for one (1) year  
25 and may be renewed annually for a fee of ten thousand dollars (\$10,000).
- 26 (5) (a) In addition to the licensing fees imposed in subsections (3) and (4) of this  
27 section, a gaming fee of six and three-quarters percent (6.75%) of net poker

- 1 revenue shall be imposed on each online poker vendor.
- 2 (b) The gaming fee shall be paid monthly by each licensed online poker vendor  
3 to the corporation, and may be made by electronic funds transfer.
- 4 (6) Award of an online poker license under this section shall not absolve any person  
5 of any liability which has or may be incurred due to litigation with the  
6 Commonwealth over internet poker domain names.
- 7 (7) Any person who has been issued a license under this section shall have the  
8 license suspended by the corporation if a final judgment is issued against the  
9 person for the improper use of internet domain names. The license suspension  
10 shall continue until all fines and fees assessed under the judgment are fully paid.
- 11 → SECTION 42. A NEW SECTION OF KRS CHAPTER 154A IS CREATED  
12 TO READ AS FOLLOWS:
- 13 (1) A Kentucky lottery corporation online poker account is established in the State  
14 Treasury. Online poker licensing fees and the gaming fee imposed by Section 41  
15 of this Act shall be deposited in the account.
- 16 (2) The corporation is authorized to use money in the online poker account for the  
17 purposes of paying necessary expenses incurred in establishing and overseeing  
18 the online poker system.
- 19 (3) Moneys in excess of the amount needed for necessary expenses shall be deposited  
20 annually into the wagering administration fund established by Section 4 of this  
21 Act to be used for the purposes established in subparagraph (1)(b)2. of Section 4  
22 of this Act.
- 23 (4) Notwithstanding KRS 45.229, fund amounts not expended at the close of a fiscal  
24 year shall not lapse but shall be carried forward into the next fiscal year.
- 25 (5) All moneys held in the fund shall be invested by the corporation in accordance  
26 with the corporation's investment practices, and all earnings from the  
27 investments shall accrue to the benefit of the fund.

- 1           ➔Section 43. KRS 154A.600 is amended to read as follows:
- 2       (1) The corporation may purchase, lease, or lease-purchase such goods or services as  
3           are necessary for effectuating the purposes of this chapter. Applicable leases,  
4           purchases, and lease-purchases shall be reported to the capital projects and bond  
5           oversight committee for its review and determination in accordance with the  
6           provisions of KRS 45.750 to 45.810. The corporation shall not contract with any  
7           person or entity for the total operation and administration of the state lottery, but  
8           may make procurements which integrate functions such as lottery game design,  
9           lottery ticket distribution to retailers, the operation of online poker games, supply  
10          of goods and services, and advertising. In all procurement decisions, the corporation  
11          shall take into account the particularly sensitive nature of the state lottery and  
12          online poker games and shall act to promote and ensure security, honesty, fairness  
13          and integrity in the operation and administration of the lottery and online poker  
14          games and the objectives of raising net proceeds for the benefit of the public  
15          purpose described in this chapter and Section 4 of this Act.
- 16       (2) The corporation shall investigate the financial responsibility, security, and integrity  
17          of any person who submits a bid, proposal or offer as part of a major procurement  
18          or who applies for licensure under Section 41 of this Act. At the time of  
19          submitting such bid, proposal, license application, or offer to the corporation, the  
20          corporation may require the following items:
- 21           (a) A disclosure of the vendor's name and address and, as applicable, the name  
22               and address of the following:
- 23               1. If the vendor is a corporation, the officers, directors, and each  
24                 stockholder in such corporation; except that, in the case of owners of  
25                 equity securities of a publicly traded corporation, only the names and  
26                 addresses of those known to the corporation to own beneficially five  
27                 percent (5%) or more of such securities need be disclosed;

- 1           2. If the vendor is a trust, the trustee and all persons entitled to receive  
2           income or benefit from the trust;
- 3           3. If the vendor is an association, the members, officers, and directors; and  
4           4. If the vendor is a partnership or joint venture, all of the general partners,  
5           limited partners, or joint venturers.
- 6           (b) A disclosure of all the states and jurisdictions in which the vendor does  
7           business, and the nature of the business for each such state or jurisdiction.
- 8           (c) A disclosure of all the states and jurisdictions in which the vendor has  
9           contracts to supply gaming goods or services, including, but not limited to,  
10          lottery goods and services, and the nature of the goods or services involved for  
11          each such state or jurisdiction.
- 12          (d) A disclosure of all the states and jurisdictions in which the vendor has applied  
13          for, has sought renewal of, has received, has been denied, has pending, or has  
14          had revoked a gaming license of any kind, and the disposition of such in each  
15          such state or jurisdiction. If any gaming license has been revoked or has not  
16          been renewed or any gaming license application has been either denied or is  
17          pending and has remained pending for more than six (6) months, all of the  
18          facts and circumstances underlying the failure to receive such a license shall  
19          be disclosed.
- 20          (e) A disclosure of the details of any finding of guilt, in a state or federal court,  
21          against the vendor for any felony or any other criminal offense other than a  
22          traffic violation.
- 23          (f) A disclosure of the details of any bankruptcy, insolvency, reorganization, or  
24          any pending litigation of the vendor.
- 25          (g) Such additional disclosures and information as the corporation may determine  
26          to be appropriate for the procurement involved. If the vendor subcontracts any  
27          substantial portion of the work to be performed under the contract to a

1 subcontractor, the vendor shall disclose all of the information required by this  
2 subsection for the subcontractor as if the subcontractor were itself a vendor.

3 (3) (a) A contract for a procurement with any vendor subject to subsection (2) of this  
4 section who has not complied with the disclosure requirements described in  
5 subsection (2) of this section shall not be entered into, and any contract with  
6 such a vendor is unenforceable.

7 (b) A license for online poker services with any vendor subject to subsection (2)  
8 of this section who has not complied with the disclosure requirements  
9 described in subsection (2) of this section shall not be issued.

10 (c) Any contract or license with a vendor who does not comply with~~such~~  
11 requirements for periodically updating~~such~~ disclosures during the tenure of  
12 the contract or license as may be specified in the~~such~~ contract or license  
13 shall be terminated by the corporation.

14 (d) This subsection and subsection (2) of this section shall be construed broadly  
15 and liberally to achieve the ends of full disclosure of all information necessary  
16 to allow for a full and complete evaluation by the corporation of the  
17 competence, integrity, background and character of vendors for major  
18 procurements or online poker services.

19 (4) A contract shall not be entered into with any vendor who has been found guilty of a  
20 felony committed within the preceding ten (10) years, unless the corporation  
21 determines that:

22 (a) The vendor has been pardoned or the vendor's civil rights have been restored;  
23 and

24 (b) Subsequent to such findings of guilt the vendor has engaged in the kind of  
25 law-abiding commerce and good citizenship that would reflect well upon the  
26 integrity of the lottery; or

27 (c) If the vendor is a firm, association, partnership, trust, corporation or other

1           entity, the vendor has terminated its relationship with the individual whose  
2           actions directly contributed to the vendor's guilt.

3 (5) Each vendor shall, at the execution of the contract with the corporation, post a  
4 performance bond or letter of credit from a bank acceptable to the corporation, in an  
5 amount equal to the full amount estimated to be paid annually to the vendor under  
6 the contract. In lieu of the bond, a vendor may, to assure the faithful performance of  
7 its obligations, deposit and maintain with the State Treasurer securities that are  
8 interest bearing or accruing and that, with the exception of those specified in  
9 paragraph (a) or (b) of this subsection, are rated in one (1) of the three (3) highest  
10 classifications by an established nationally recognized investment rating service.

11 Securities eligible under this subsection are limited to:

12 (a) Certificates of deposit issued by solvent banks or savings associations  
13 organized and existing under the laws of this state or under the laws of the  
14 United States and having their principal place of business in this state;

15 (b) United States bonds, notes, and bills for which the full faith and credit of the  
16 government of the United States is pledged for the payment of principal and  
17 interest;

18 (c) General obligation bonds and notes of any political subdivision of the state; or

19 (d) Corporate bonds of any corporation that is not an affiliate or subsidiary of the  
20 depositor. Such securities shall be held in trust and shall have at all times a  
21 market value at least equal to the full amount estimated to be paid annually to  
22 the lottery vendor under contract.

23 (6) Every contract entered into by the corporation pursuant to this section shall contain  
24 a provision for payment of liquidated damages to the corporation for any breach of  
25 contract by the vendor.

26 (7) Each vendor shall be qualified to do business in this state and shall file appropriate  
27 tax returns as provided by the laws of this state. All contracts under this section

1 shall be governed by the laws of this state.

2 →Section 44. KRS 243.500 is amended to read as follows:

3 Any license may be revoked or suspended for the following causes:

4 (1) Conviction of the licensee or the licensee's agent, servant, or employee for selling  
5 any illegal alcoholic beverages on the licensed premises.

6 (2) Making any false, material statements in an application or renewal application for a  
7 license or supplemental license.

8 (3) Conviction of the licensee or any of the licensee's agents, servants, or employees of:

9 (a) Two (2) violations of the terms and provisions of KRS Chapters 241 to 244,  
10 or any act regulating the manufacture, sale, and transportation of alcoholic  
11 beverages within two (2) consecutive years;

12 (b) Two (2) misdemeanors directly or indirectly attributable to the use of  
13 alcoholic beverages within two (2 ) consecutive years; or

14 (c) Any felony.

15 (4) Failure or default of a licensee to pay an excise tax or any part of the tax or any  
16 penalties imposed by or under the provisions of any statutes, ordinances, or Acts of  
17 Congress relative to taxation, or for a violation of any related administrative  
18 regulations promulgated by the Department of Revenue.

19 (5) Revocation of any license or permit provided in KRS 243.060, 243.070, 243.600,  
20 and 243.610, or granted under any Act of Congress relative to the regulation of the  
21 manufacture, sale, and transportation of alcoholic beverages.

22 (6) Setting up, conducting, operating, or keeping, on the licensed premises, any  
23 gambling game, device, machine, contrivance, lottery, gift enterprise, handbook, or  
24 facility for betting or transmitting bets on horse races; or permitting to be set up,  
25 conducted, operated, kept, or engaged in, on the licensed premises, any gambling  
26 game, device, machine, contrivance, lottery, gift enterprise, handbook, or facility.

27 This subsection shall not apply to:

- 1 (a) The sale of lottery tickets sold under the provisions of KRS Chapter 154A;
- 2 (b) The operation of a pari-mutuel system for betting, or the operation of sports
- 3 wagering where authorized by law;
- 4 (c) The conduct of charitable gaming by a charitable organization licensed or
- 5 permitted under KRS Chapter 238;~~or~~
- 6 (d) Special temporary raffles of alcoholic beverages under KRS 243.036;
- 7 (e) The conduct of online poker licensed under Section 41 of this Act.
- 8 (7) Conviction of the licensee, the licensee's agents, servants, or employees for:
- 9 (a) The trafficking or possession upon the licensed premises of controlled or
- 10 illegal substances described in KRS Chapter 218A, including synthetic drugs;
- 11 (b) Knowingly permitting the trafficking or possession by patrons upon the
- 12 licensed premises of controlled or illegal substances described in KRS
- 13 Chapter 218A, including synthetic drugs; or
- 14 (c) Knowingly receiving stolen property upon the licensed premises.
- 15 (8) Failure to comply with the terms of a final order of the board.
- 16 →Section 45. KRS 525.090 is amended to read as follows:
- 17 (1) A person is guilty of loitering when he or she:
- 18 (a) Loiters or remains in a public place for the purpose of gambling with cards,
- 19 dice or other gambling paraphernalia, except that the provisions of this section
- 20 shall not apply if the person is participating in charitable gaming defined by
- 21 KRS 238.505, or is engaged in sports wagering licensed under KRS Chapter
- 22 230 and Section 19 of this Act; or
- 23 (b) Loiters or remains in a public place for the purpose of unlawfully using a
- 24 controlled substance; or
- 25 (c) Loiters or remains in or about a school, college or university building or
- 26 grounds, not having any reason or relationship involving custody of or
- 27 responsibility for a pupil or student or any other specific legitimate reason for

7           ➔Section 46. KRS 528.010 is amended to read as follows:

8           The following definitions apply in this chapter unless the context otherwise requires:

9           (1) "Advancing gambling activity" -- A person "advances gambling activity" when,  
10           acting other than as a player, he engages in conduct that materially aids any form of  
11           gambling activity not licensed under KRS Chapter 239, KRS Chapter 154A, or  
12           KRS Chapter 230. The conduct shall include, but is not limited to, conduct directed  
13           toward the establishment of the particular game, contest, scheme, device, or activity  
14           involved; toward the acquisition or maintenance of premises, paraphernalia,  
15           equipment, or apparatus therefor; toward the solicitation or inducement of persons  
16           to participate therein; toward the actual conduct of the playing phases thereof;

27           (3) "Charitable gaming" means games of chance conducted by charitable organizations

- 1 licensed and regulated under the provisions of KRS Chapter 238;
- 2 (4) (a) "Gambling" means staking or risking something of value upon the outcome of  
3 a contest, game, gaming scheme, or gaming device which is based upon an  
4 element of chance, in accord with an agreement or understanding that  
5 someone will receive something of value in the event of a certain outcome. A  
6 contest or game in which eligibility to participate is determined by chance and  
7 the ultimate winner is determined by skill shall not be considered to be  
8 gambling.
- 9 (b) Gambling shall not mean charitable gaming which is licensed and regulated  
10 under the provisions of KRS Chapter 238, *fantasy sports wagering licensed*  
11 *under KRS Chapter 239, or activities licensed under KRS Chapter 154A or*  
12 *KRS Chapter 230*;
- 13 (5) "Gambling device" means:
- 14 (a) Any so-called slot machine or any other machine or mechanical device an  
15 essential part of which is a drum or reel with insignia thereon, and which  
16 when operated may deliver, as a result of the application of an element of  
17 chance, any money or property, or by the operation of which a person may  
18 become entitled to receive, as the result of the application of an element of  
19 chance, any money or property;
- 20 (b) Any mechanical or electronic device permanently located in a business  
21 establishment, including a private club, that is offered or made available to a  
22 person to play or participate in a simulated gambling program in return for  
23 direct or indirect consideration, including but not limited to consideration paid  
24 for Internet access or computer time, or a sweepstakes entry, which when  
25 operated may deliver as a result of the application of an element of chance,  
26 any money or property, or by the operation of which a person may become  
27 entitled to receive, as the result of the application of an element of chance, any

1 money or property; or

2 (c) Any other machine or any mechanical or other device, including but not  
3 limited to roulette wheels, gambling tables and similar devices, designed and  
4 manufactured primarily for use in connection with gambling and which when  
5 operated may deliver, as the result of the application of an element of chance,  
6 any money or property, or by the operation of which a person may become  
7 entitled to receive, as the result of the application of an element of chance, any  
8 money or property;

9 (d) But, the following shall not be considered gambling devices within this  
10 definition:

- 11 1. Devices dispensing or selling combination or French pools on licensed,  
12 regular racetracks during races on said tracks;
- 13 2. Devices dispensing or selling combination or French pools on historical  
14 races at licensed, regular racetracks as lawfully authorized by the  
15 Kentucky Horse Racing Commission;
- 16 3. Electro-mechanical pinball machines specially designed, constructed, set  
17 up, and kept to be played for amusement only. Any pinball machine  
18 shall be made to receive and react only to the deposit of coins during the  
19 course of a game. The ultimate and only award given directly or  
20 indirectly to any player for the attainment of a winning score or  
21 combination on any pinball machine shall be the right to play one (1) or  
22 more additional games immediately on the same device at no further  
23 cost. The maximum number of free games that can be won, registered,  
24 or accumulated at one (1) time in operation of any pinball machine shall  
25 not exceed thirty (30) free games. Any pinball machine shall be made to  
26 discharge accumulated free games only by reactivating the playing  
27 mechanism once for each game released. Any pinball machine shall be

1 made and kept with no meter or system to preserve a record of free  
 2 games played, awarded, or discharged. Nonetheless, a pinball machine  
 3 shall be a gambling device if a person gives or promises to give money,  
 4 tokens, merchandise, premiums, or property of any kind for scores,  
 5 combinations, or free games obtained in playing the pinball machine in  
 6 which the person has an interest as owner, operator, keeper, or  
 7 otherwise; ~~or~~

8 4. Devices used in the conduct of charitable gaming;

9 5. Devices used in the conduct of fantasy sports wagering licensed under  
 10 KRS Chapter 239;

11 6. Devices used in the conduct of online poker licensed under KRS  
 12 Chapter 154A; or

13 7. Devices used in the conduct of sports wagering licensed under KRS  
 14 Chapter 230;

15 (6) "Lottery and gift enterprise" means:

16 (a) A gambling scheme in which:

17 1. The players pay or agree to pay something of value for chances,  
 18 represented and differentiated by numbers or by combinations of  
 19 numbers or by some other media, one (1) or more of which are to be  
 20 designated the winning ones; and

21 2. The ultimate winner is to be determined by a drawing or by some other  
 22 method based upon the element of chance; and

23 3. The holders of the winning chances are to receive something of value;  
 24 and

25 (b) A gift enterprise or referral sales plan which meets the elements of a lottery  
 26 listed in paragraph (a) of this subsection is to be considered a lottery under  
 27 this chapter;

- 1 (7) "Mutuel" or "the numbers games" means a form of lottery in which the winning  
2 chances or plays are not determined upon the basis of a drawing or other act on the  
3 part of persons conducting or connected with the scheme, but upon the basis of the  
4 outcome or outcomes of a future contingent event or events otherwise unrelated to  
5 the particular scheme;
- 6 (8) "Player" means a person who engages in any form of gambling solely as a  
7 contestant or bettor, without receiving or becoming entitled to receive any profit  
8 therefrom other than personal gambling winnings, and without otherwise rendering  
9 any material assistance to the establishment, conduct, or operation of the particular  
10 gambling activity. A person who engages in "bookmaking" as defined in subsection  
11 (2) of this section is not a "player." The status of a "player" shall be a defense to any  
12 prosecution under this chapter;
- 13 (9) "Profiting from gambling activity" -- A person "profits from gambling activity"  
14 when, other than as a player, he or she accepts or receives or agrees to accept or  
15 receive money or other property pursuant to an agreement or understanding with  
16 any person whereby he or she participates or is to participate in the proceeds of  
17 gambling activity not licensed by KRS Chapter 239, KRS Chapter 154A, or KRS  
18 Chapter 230;
- 19 (10) "Simulated gambling program" means any method not licensed under KRS  
20 Chapter 239, KRS Chapter 154A, or KRS Chapter 230 intended to be used by a  
21 person playing, participating, or interacting with an electronic device that may,  
22 through the application of an element of chance, either deliver money or property or  
23 an entitlement to receive money or property; and
- 24 (11) "Something of value" means any money or property, any token, object, or article  
25 exchangeable for money or property, or any form of credit or promise directly or  
26 indirectly contemplating transfer of money or property or of any interest therein, or  
27 involving extension of a service, entertainment, or a privilege of playing at a game

1 or scheme without charge.

2 →Section 47. KRS 528.020 is amended to read as follows:

3 (1) A person is guilty of promoting gambling in the first degree when he or she  
4 knowingly advances or profits from unlawful gambling activity not authorized by  
5 KRS Chapter 239, KRS Chapter 154A, or KRS Chapter 230 by:

6 (a) Engaging in bookmaking to the extent that he or employs or utilizes three or  
7 more persons in a bookmaking activity and receives or accepts in any one day  
8 bets totaling more than \$500; or

9 (b) Receiving in connection with a lottery or mutuel scheme or enterprise:

10 1. Money or written records from a person other than a player whose  
11 chances or plays are represented by such money or records; or

12 2. More than \$500 in any one day of money played in the scheme or  
13 enterprise; or

14 (c) Setting up and operating a gambling device.

15 (2) Promoting gambling in the first degree is a Class D felony.

16 →Section 48. KRS 528.070 is amended to read as follows:

17 (1) A person is guilty of permitting gambling when, having possession or control of  
18 premises which he knows are being used to advance gambling activity not licensed  
19 under KRS Chapter 239, KRS Chapter 154A, or KRS Chapter 230, he fails to halt  
20 or abate or attempt to halt or abate such use within a reasonable period of time.

21 (2) Permitting gambling is a Class B misdemeanor.

22 →Section 49. KRS 528.080 is amended to read as follows:

23 (1) A person is guilty of possession of a gambling device when, with knowledge of the  
24 character thereof, he manufactures, sells, transports, places or possesses a gambling  
25 device or conducts or negotiates any transaction affecting or designed to affect  
26 ownership, custody or use of any gambling device not authorized under KRS  
27 Chapter 239, KRS Chapter 154A, or KRS Chapter 230, believing that it is to be

1           used in the advancement of unlawful gambling activity.

2   (2)   Possession of a gambling device is a Class A misdemeanor.

3           ➔Section 50. If any provision of this Act or the application thereof to any person  
4   or circumstance is held invalid, the invalidity shall not affect other provisions or  
5   applications of the Act that can be given effect without the invalid provision or  
6   application, and to this end the provisions of this Act are severable.
