804 KAR 4:415. Direct shipper license.

RELATES TO: KRS **241.060(1)**, 243.027[, **241.060(1)**][243.028, 243.029]

STATUTORY AUTHORITY: KRS 241.060, 243.027

NECESSITY, FUNCTION, AND CONFORMITY: KRS 243.027(4) requires the Department of Alcoholic Beverage Control to <u>establish</u>[set forth][the requirements and]the form for a direct shipper license application. In relation to the direct shipper license, KRS 241.060(1) authorizes the Department only to promulgate an administrative regulation to establish the license application. This administrative regulation establishes the <u>application for</u> direct shipper <u>Type A</u> and Type B licenses [license application].

Section 1. Qualifications. To qualify for a direct shipper <u>Type A or Type B</u> license, the applicant shall:

- (1) <u>For a direct shipper Type A license</u>, hold a current license, permit, or other authorization to manufacture <u>or supply</u> alcoholic beverages in the state where it is located or a current license in this state under KRS 243.212 or 243.215 to supply alcoholic beverages; <u>or</u>
- (2) <u>For a direct shipper Type B license, hold a current license, permit, or other authorization to manufacture or supply cannabis-infusted beverages in the state where the applicant is located;</u>
- (3) Submit to the department their[Provide a] current license, permit, or other authorization to manufacture, store, or supply alcoholic beverages <u>or cannabis-infused beverages</u> in the state where the applicant is located <u>through[via]</u> the department's online portal at https://abcportal.ky.gov/BELLEExternal;
- (4)[(3)] Complete the online New[direct_shipper] License Application through[via] the department's online[licensing] portal at https://abcportal.ky.gov/BELLEExternal; and
 - (5)[(4)] [Provide the address of the applicant's premises; and]
 - [(5)] Pay the annual license fee established in KRS 243.030(33) or (39).
