


## **CVS/Caremark and KEHP**

- Currently, KEHP uses Caremark for their Pharmacy Benefit Manager (PBM)
- KEHP is one of the largest employers of Kentucky families
- Caremark drives prescriptions, revenue, and jobs OUT of the state
  All mail and specialty Rx's required to go through Caremark
- Historically, PBMs like Caremark tell large self-funded employers that they are using their size and buying power to get the best price

### Example 1: rosuvastatin (Crestor™) KEHP: #20 of Top 25 Drugs by Cost







## **Generic Utilization**



## "Rebates"

A **rebate** is a discount on the medication a drug manufacturer gives a PBM in return for agreeing to cover their drug or product.

Only a portion of "rebates" are shared with the employer and the PBM pockets the rest.
