<u>PURPOSE OF MEASURE</u>: The purpose of the measure is to provide a salary increment for state government employees and to provide funding for job classification reviews which must be completed by November 1, 2023, and reported to the Interim Joint Committee on Appropriations and Revenue.

FISCAL EXPLANATION: The measure transfers previously appropriated General Fund moneys to provide for a six percent salary increment for Executive and Legislative Branch employees, and a \$2,000 adjustment followed by a six percent salary increment for Judicial Branch employees and elected officials. Other fund sources are also appropriated to effectuate those increments. The measure also provides \$500,000 in General Fund in FY 2024 to the Personnel Cabinet for job classification review work which must be completed by November 1, 2023, and reported to the Interim Joint Committee on Appropriations and Revenue.
