

1 AN ACT relating to the Teachers' Retirement System.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS 161.220 TO 161.710 IS CREATED
4 TO READ AS FOLLOWS:

5 *(1) Individuals who become nonuniversity members of the Teachers' Retirement*
6 *System on or after January 1, 2022, shall be provided a foundational plan, which*
7 *shall be known as the foundational benefit component, a supplemental benefit*
8 *component established by Section 3 of this Act, and retiree health benefits as*
9 *provided by KRS 161.675. For purposes of this section, the foundational benefit*
10 *component includes all benefits provided by KRS 161.220 to 161.716 for*
11 *individuals who become nonuniversity members of the Teachers' Retirement*
12 *System on or after January 1, 2022, with the exception of the supplemental*
13 *benefit component established by Section 3 of this Act and retiree health benefits*
14 *established by KRS 161.675.*

15 *(2) Notwithstanding KRS 161.220 to 161.716, the actuary designated by the board of*
16 *trustees under Section 12 of this Act shall, as part of the annual valuation of the*
17 *pension fund, assess the funding levels, unfunded liabilities, and the actuarially*
18 *required employer contribution rates payable solely on behalf of individuals who*
19 *first become nonuniversity members on or after January 1, 2022. Computation of*
20 *the employer contribution rate payable shall be based upon amortizing unfunded*
21 *liabilities using the level-dollar amortization method.*

22 *(3) If, on the basis of the valuation assessment required under subsection (2) of this*
23 *section, the funding level for the foundational benefit component payable on*
24 *behalf of individuals who first become nonuniversity members on or after*
25 *January 1, 2022, falls below ninety percent (90%), the board shall,*
26 *notwithstanding any other provision of KRS 161.220 to 161.716 to the contrary,*
27 *make one (1) or more of the following changes to maintain the funding level and*

1 to contain pension and life insurance benefit costs within the maximum statutory
 2 employer contribution rate for the foundational benefit component of eight
 3 percent (8%) of annual compensation as provided by subsection (1)(d)1. of
 4 Section 8 of this Act:

5 (a) Utilize moneys from the stabilization reserve account for nonuniversity
 6 membership and employers established by subsection (10)(a) of Section 13
 7 of this Act;

8 (b) Utilize prospective mandatory employee and employer contributions to the
 9 supplemental benefit component as provided by Section 3 of this Act to
 10 provide funding for the foundational benefit component; or

11 (c) Prospectively adjust for individuals who become nonuniversity members on
 12 or after January 1, 2022, one (1) or more of the following parts of the
 13 foundational benefit component:

14 1. Regular interest rate established by subsection (13)(c) of Section 6 of
 15 this Act;

16 2. The retirement factors established by subsection (1)(f) of Section 10 of
 17 this Act;

18 3. The age and service requirements to retire as established by subsection
 19 (2) of Section 9 of this Act;

20 4. The cost-of-living adjustment established by subsection (2) of Section
 21 10 of this Act; or

22 5. The age and service requirements and the retirement allowance
 23 provided during the entitlement period under Section 37 of this Act.

24 Notwithstanding any other provision of KRS 161.220 to 161.716 to the
 25 contrary, the board of trustees may utilize any and all of the above
 26 adjustments at any time on all individuals who become nonuniversity
 27 members on or after January 1, 2022, in order to maintain the funding level

1 of the foundational benefit component and employer costs as provided by
 2 this subsection.

3 (4) For purposes of this section, "funding level" means the actuarial value of assets
 4 divided by the actuarially accrued liability expressed as a percentage that is
 5 determined and reported by the system's actuary in the system's actuarial
 6 valuation.

7 (5) This section shall only apply to individuals who became nonuniversity members
 8 of the Teachers' Retirement System on or after January 1, 2022.

9 (6) The provisions of this section shall not be construed to authorize the board to
 10 retroactively restore benefits or eligibility for benefits in the foundational benefit
 11 component or supplemental benefit that were previously reduced by the board
 12 pursuant to subsection (3)(b) and (c) of this section.

13 ➔SECTION 2. A NEW SECTION OF KRS 161.220 TO 161.710 IS CREATED
 14 TO READ AS FOLLOWS:

15 (1) Individuals who become university members of the Teachers' Retirement System
 16 on or after January 1, 2022, shall be provided a foundational plan, which shall
 17 be known as the foundational benefit component, a supplemental benefit
 18 component established by Section 4 of this Act, and retiree health benefits as
 19 provided by KRS 161.675. For purposes of this section, the foundational benefit
 20 component includes all benefits provided by KRS 161.220 to 161.716 for
 21 individuals who become university members of the Teachers' Retirement System
 22 on or after January 1, 2022, with the exception of the supplemental benefit
 23 component established by Section 4 of this Act and retiree health benefits
 24 established by KRS 161.675.

25 (2) Notwithstanding KRS 161.220 to 161.716, the actuary designated by the board of
 26 trustees under Section 12 of this Act shall, as part of the annual valuation of the
 27 pension fund, assess the funding levels, unfunded liabilities, and the actuarially

1 required employer contribution rates payable solely on behalf of individuals who
 2 first become university members on or after January 1, 2022. Computation of the
 3 employer contribution rate payable shall be based upon amortizing unfunded
 4 liabilities using the level-dollar amortization method.

5 (3) If, on the basis of the valuation assessment required under subsection (2) of this
 6 section, the funding level for the foundational benefit component payable on
 7 behalf of individuals who first become university members on or after January 1,
 8 2022, falls below ninety percent (90%), the board shall, notwithstanding any
 9 other provision of KRS 161.220 to 161.716 to the contrary, make one (1) or more
 10 of the following changes to maintain the funding level and to contain pension
 11 and life insurance benefit costs within the maximum statutory employer
 12 contribution rate for the foundational benefit component of five and seven
 13 hundred seventy-five thousandths percent (5.775%) of annual compensation as
 14 provided by subsection (1)(e)1. of Section 8 of this Act:

15 (a) Utilize moneys from the stabilization reserve account for university
 16 membership and employers established by subsection (10)(b) of Section 13
 17 of this Act;

18 (b) Utilize prospective mandatory employee and employer contributions to the
 19 supplemental benefit component as provided by Section 4 of this Act to
 20 provide funding for the foundational benefit component; or

21 (c) Prospectively adjust for individuals who become university members on or
 22 after January 1, 2022, one (1) or more of the following parts of the
 23 foundational benefit component:

24 1. Regular interest rate established by subsection (13)(c) of Section 6 of
 25 this Act;

26 2. The retirement factors established by subsection (1)(g) of Section 10 of
 27 this Act;

- 1 3. The age and service requirements to retire as established by subsection
 2 (2) of Section 9 of this Act;
- 3 4. The cost-of-living adjustment established by subsection (2) of Section
 4 10 of this Act; or
- 5 5. The age and service requirements and the retirement allowance
 6 provided during the entitlement period under Section 37 of this Act.
- 7 Notwithstanding any other provision of KRS 161.220 to 161.716 to the
 8 contrary, the board of trustees may utilize any and all of the above
 9 adjustments at any time on all individuals who become university members
 10 on or after January 1, 2022, in order to maintain the funding level of the
 11 foundational benefit component and employer costs as provided by this
 12 subsection.
- 13 (4) For purposes of this section, "funding level" means the actuarial value of assets
 14 divided by the actuarially accrued liability expressed as a percentage that is
 15 determined and reported by the system's actuary in the system's actuarial
 16 valuation.
- 17 (5) This section shall only apply to individuals who became university members of
 18 the Teachers' Retirement System on or after January 1, 2022.
- 19 (6) The provisions of this section shall not be construed to authorize the board to

- 23 ➔SECTION 3. A NEW SECTION OF KRS 161.220 TO 161.710 IS CREATED
 24 TO READ AS FOLLOWS:
- 25 (1) An individual who becomes a nonuniversity member of the Teachers' Retirement
 26 System on or after January 1, 2022, shall receive the retirement benefits provided
 27 by this section in addition to the retirement benefits provided under Section 10 of

1 this Act. The retirement benefits provided by this section shall be known as the
 2 supplemental benefit component.

3 (2) The supplemental benefit component shall provide a benefit based upon a
 4 member's accumulated account balance which shall include:

5 (a) Mandatory contributions made by the member as provided by subsection
 6 (1)(c)2. of Section 7 of this Act;

7 (b) Voluntary contributions made by the member, which may include lump-
 8 sum payments;

9 (c) Mandatory contributions made by the employer as provided by subsection
 10 (1)(d)2. of Section 8 of this Act;

11 (d) Voluntary employer contributions; and

12 (e) Regular interest, which shall be credited to the member's account annually
 13 on June 30 of each fiscal year, by multiplying the member's accumulated
 14 account balance in the supplemental benefit component on June 30 of the
 15 preceding fiscal year by the regular interest rate.

16 (3) (a) Member contributions and employer contributions as provided by
 17 subsection (2)(a) to (d) of this section shall be credited to the member's
 18 account at least monthly as contributions are reported and posted to the
 19 system in accordance with KRS 161.560.

20 (b) No employer contributions or interest shall be provided to a member who
 21 has taken a refund of his or her accumulated account balance as provided
 22 by Section 14 of this Act or who has retired and annuitized his or her
 23 accumulated account balance as authorized by this section.

24 (4) (a) Upon termination of employment, a member who has less than five (5)
 25 years of service credited under Section 16 of this Act, who elects to take a
 26 refund of his or her accumulated account balance as provided by Section 14
 27 of this Act, shall forfeit the accumulated employer contribution, and shall

1 only receive a refund of his or her accumulated contributions.

2 (b) Upon termination of employment, a member who has five (5) or more years
 3 of service credited under Section 16 of this Act, who elects to take a refund
 4 of his or her accumulated account balance as provided by Section 14 of this
 5 Act, shall receive a full refund of his or her accumulated account balance.

6 (5) A nonuniversity member eligible to retire under subsection (2) of Section 9 of this
 7 Act may upon retirement, in addition to the other benefits provided by Section 10
 8 of this Act, elect to:

9 (a) Have his or her accumulated account balance in the supplemental benefit
 10 component annuitized into a lifetime monthly retirement allowance by the
 11 system in accordance with the actuarial assumptions and actuarial methods
 12 adopted by the board for the supplemental benefit component and in effect
 13 on the member's retirement date;

14 (b) Receive the actuarial equivalent of his or her retirement allowance
 15 calculated under paragraph (a) of this subsection payable under one (1) of
 16 the options established by the board pursuant to Section 36 of this Act;

17 (c) Take a distribution of the accumulated account balance in the supplemental
 18 benefit component over a period certain as authorized by the board; or

19 (d) Take a full or partial refund of his or her accumulated account balance as
 20 provided by Section 14 of this Act.

21 A member participating in the supplemental benefit component shall not be
 22 required to take a distribution or annuitize his or her accumulated account
 23 balance in the supplemental benefit component when he or she begins drawing a
 24 retirement allowance from the foundational benefit component and may instead
 25 choose to begin drawing a distribution or annuitize his or her accumulated
 26 account balance in the supplemental benefit component at any date following his
 27 or her retirement date from the foundational benefit component.

1 (6) This section only applies to individuals who become nonuniversity members of
 2 the Teachers' Retirement System on or after January 1, 2022.

3 (7) The board of trustees shall have the authority to utilize or establish any plan or
 4 plans authorized under the Internal Revenue Code to provide the benefits set
 5 forth in this section.

6 ➔SECTION 4. A NEW SECTION OF KRS 161.220 TO 161.710 IS CREATED
 7 TO READ AS FOLLOWS:

8 (1) An individual who becomes a university member of the Teachers' Retirement
 9 System on or after January 1, 2022, shall receive the retirement benefits provided
 10 by this section in addition to the retirement benefits provided under Section 10 of
 11 this Act. The retirement benefits provided by this section shall be known as the
 12 supplemental benefit component.

13 (2) The supplemental benefit component shall provide a benefit based upon a
 14 member's accumulated account balance which shall include:

15 (a) Mandatory contributions made by the member as provided by subsection
 16 (1)(d)2. of Section 7 of this Act;

17 (b) Voluntary contributions made by the member, which may include lump-
 18 sum payments;

19 (c) Mandatory contributions made by the employer as provided by subsection
 20 (1)(e)2. of Section 8 of this Act;

21 (d) Voluntary employer contributions; and

22 (e) Regular interest, which shall be credited to the member's account annually
 23 on June 30 of each fiscal year, by multiplying the member's accumulated
 24 account balance in the supplemental benefit component on June 30 of the
 25 preceding fiscal year by the regular interest rate.

26 (3) (a) Member contributions and employer contributions as provided by
 27 subsection (2)(a) to (d) of this section shall be credited to the member's

1 account at least monthly as contributions are reported and posted to the
 2 system in accordance with KRS 161.560.

3 (b) No employer contributions or interest shall be provided to a member who
 4 has taken a refund of his or her accumulated account balance as provided
 5 by Section 14 of this Act or who has retired and annuitized his or her
 6 accumulated account balance as authorized by this section.

7 (4) (a) Upon termination of employment, a member who has less than five (5)
 8 years of service credited under Section 16 of this Act, who elects to take a
 9 refund of his or her accumulated account balance as provided by Section 14
 10 of this Act, shall forfeit the accumulated employer contribution, and shall
 11 only receive a refund of his or her accumulated contributions.

12 (b) Upon termination of employment, a member who has five (5) or more years
 13 of service credited under Section 16 of this Act, who elects to take a refund
 14 of his or her accumulated account balance as provided by Section 14 of this
 15 Act, shall receive a full refund of his or her accumulated account balance.

16 (5) A university member eligible to retire under subsection (2) of Section 9 of this Act
 17 may upon retirement, in addition to the other benefits provided by Section 10 of
 18 this Act, elect to:

19 (a) Have his or her accumulated account balance in the supplemental benefit
 20 component annuitized into a lifetime monthly retirement allowance by the
 21 system in accordance with the actuarial assumptions and actuarial methods
 22 adopted by the board for the supplemental benefit component and in effect
 23 on the member's retirement date;

24 (b) Receive the actuarial equivalent of his or her retirement allowance
 25 calculated under paragraph (a) of this subsection payable under one (1) of
 26 the options established by the board pursuant to Section 36 of this Act;

27 (c) Take a distribution of the accumulated account balance in the supplemental

1 benefit component over a period certain as authorized by the board; or
2 (d) Take a full or partial refund of his or her accumulated account balance as
3 provided by Section 14 of this Act.

4 A member participating in the supplemental benefit component shall not be
5 required to take a distribution or annuitize his or her accumulated account
6 balance in the supplemental benefit component when he or she begins drawing a
7 retirement allowance from the foundational benefit component and may instead
8 choose to begin drawing a distribution or annuitize his or her accumulated
9 account balance in the supplemental benefit component at any date following his
10 or her retirement date from the foundational benefit component.

11 (6) This section only applies to individuals who become university members of the
12 Teachers' Retirement System on or after January 1, 2022.

13 (7) The board of trustees shall have the authority to utilize or establish any plan or
14 plans authorized under the Internal Revenue Code to provide the benefits set
15 forth in this section.

16 ➔ Section 5. KRS 161.155 is amended to read as follows:

17 (1) As used in this section:

18 (a) "Teacher" shall mean any person for whom certification is required as a basis
19 of employment in the common schools of the state;

20 (b) "Employee" shall mean any person, other than a teacher, employed in the
21 public schools, whether on a full or part-time basis;

22 (c) "Immediate family" shall mean the teacher's or employee's spouse, children
23 including stepchildren and foster children, grandchildren, daughters-in-law
24 and sons-in law, brothers and sisters, parents and spouse's parents, and
25 grandparents and spouse's grandparents, without reference to the location or
26 residence of said relative, and any other blood relative who resides in the
27 teacher's or employee's home;

- 1 (d) "Sick leave bank" shall mean an aggregation of sick leave days contributed by
2 teachers or employees for use by teachers or employees who have exhausted
3 all sick leave and other available paid leave days; and
- 4 (e) "Assault" shall mean an act that intentionally causes injury so significant that
5 the victim is determined to be, by certification of a physician or surgeon duly
6 qualified under KRS Chapter 342, incapable of performing the duties of his or
7 her job.
- 8 (2) Each district board of education shall allow to each teacher and full-time employee
9 in its common school system not less than ten (10) days of sick leave during each
10 school year, without deduction of salary. Sick leave shall be granted to a teacher or
11 employee if he or she presents a personal affidavit or a certificate of a physician
12 stating that the teacher or employee was ill, that the teacher or employee was absent
13 for the purpose of attending to a member of his or her immediate family who was
14 ill, or for the purpose of mourning a member of his or her immediate family. The
15 ten (10) days of sick leave granted in this subsection may be taken by a teacher or
16 employee on any ten (10) days of the school year and shall be granted in addition to
17 accumulated sick leave days that have been credited to the teacher or employee
18 under the provisions of subsection (4) of this section.
- 19 (3) A school district shall coordinate among the income and benefits from workers'
20 compensation, temporary disability retirement, and district payroll and benefits so
21 that there is no loss of income or benefits to a teacher or employee for work time
22 lost because of an assault while performing the teacher's or employee's assigned
23 duties for a period of up to one (1) year after the assault. In the event a teacher or
24 employee suffers an assault while performing his or her assigned duties that results
25 in injuries that qualify the teacher or employee for workers' compensation benefits,
26 the district shall provide leave to the teacher or employee for up to one (1) year after
27 the assault with no loss of income or benefits under the following conditions:

- 1 (a) The district shall pay the salary of the teacher or employee between the time
2 of the assault and the time the teacher's or employee's workers' compensation
3 income benefits take effect, or the time the teacher or employee is certified to
4 return to work by a physician or surgeon duly qualified under KRS Chapter
5 342, whichever is sooner;
- 6 (b) The district shall pay, for up to one (1) year from the time of the assault, the
7 difference between the salary of the teacher or employee and any workers'
8 compensation income benefits received by the teacher or employee resulting
9 from the assault. Payments by the district shall include payments for
10 intermittent work time missed as a result of the assault during the one (1) year
11 period. If the teacher's or employee's workers' compensation income benefits
12 cease during the one (1) year period after the assault, the district shall also
13 cease to make payments under this paragraph;
- 14 (c) The Commonwealth, through the Kentucky Department of Education, shall
15 make the employer's health insurance contribution during the period that the
16 district makes payments under paragraphs (a) and (b) of this subsection;
- 17 (d) The Commonwealth, through the Kentucky Department of Education, shall
18 make the employer's contribution to the retirement system in which the
19 teacher or employee is a member during the period that the district makes
20 payments under paragraphs (a) and (b) of this subsection; and
- 21 (e) Payments to a teacher or employee under paragraphs (a) and (b) of this
22 subsection shall be coordinated with workers' compensation benefits under
23 KRS Chapter 342, disability retirement benefits for teachers under KRS
24 161.661 to 161.663, and disability retirement benefits for employees under
25 KRS 61.600 to 61.621 and 78.545 so that the teacher or employee receives
26 income equivalent to his or her full contracted salary, but in no event shall the
27 combined payments exceed one hundred percent (100%) of the teacher's or

- 1 employee's full contracted salary.
- 2 (4) Days of sick leave not taken by an employee or a teacher during any school year
3 shall accumulate without limitation and be credited to that employee or teacher.
4 Accumulated sick leave may be taken in any school year. Any district board of
5 education may, in its discretion, allow employees or teachers in its common school
6 system sick leave in excess of the number of days prescribed in this section and may
7 allow school district employees and teachers to use up to three (3) days' sick leave
8 per school year for emergency leave pursuant to KRS 161.152(3). Any accumulated
9 sick leave days credited to an employee or a teacher shall remain so credited in the
10 event he or she transfers his or her place of employment from one (1) school district
11 to another within the state or to the Kentucky Department of Education or transfers
12 from the Department of Education to a school district.
- 13 (5) Accumulated days of sick leave shall be granted to a teacher or employee if, prior to
14 the opening day of the school year, an affidavit or a certificate of a physician is
15 presented to the district board of education, stating that the teacher or employee is
16 unable to commence his or her duties on the opening day of the school year, but will
17 be able to assume his or her duties within a period of time that the board determines
18 to be reasonable.
- 19 (6) Any school teacher or employee may repurchase previously used sick leave days
20 with the concurrence of the local school board by paying to the district an amount
21 equal to the total of all costs associated with the used sick leave.
- 22 (7) A district board of education may adopt a plan for a sick leave bank. The plan may
23 include limitations upon the number of days a teacher or employee may annually
24 contribute to the bank and limitations upon the number of days a teacher or
25 employee may annually draw from the bank. Only those teachers or employees who
26 contribute to the bank may draw upon the bank. Days contributed will be deducted
27 from the days available to the contributing teacher or employee. The sick leave bank

1 shall be administered in accordance with a policy adopted by the board of
2 education.

3 (8) (a) A district board of education shall establish a sick leave donation program to
4 permit teachers or employees to voluntarily contribute sick leave to teachers
5 or employees in the same school district who are in need of an extended
6 absence from school. A teacher or employee who has accrued more than
7 fifteen (15) days' sick leave may request the board of education to transfer a
8 designated amount of sick leave to another teacher or employee who is
9 authorized to receive the sick leave donated. A teacher or employee may not
10 request an amount of sick leave be donated that reduces his or her sick leave
11 balance to less than fifteen (15) days.

12 (b) A teacher or employee may receive donations of sick leave if:

13 1. a. The teacher or employee or a member of his or her immediate
14 family suffers from a medically certified illness, injury,
15 impairment, or physical or mental condition that has caused or is
16 likely to cause the teacher or employee to be absent for at least ten
17 (10) days; or

18 b. The teacher or employee suffers from a catastrophic loss to his or
19 her personal or real property, due to either a natural disaster or fire,
20 that either has caused or will likely cause the employee to be
21 absent for at least ten (10) consecutive working days;

22 2. The teacher's or employee's need for the absence and use of leave are
23 certified by a licensed physician for leave requested under subparagraph
24 1.a. of this subsection;

25 3. The teacher or employee has exhausted his or her accumulated sick
26 leave, personal leave, and any other leave granted by the school district;
27 and

- 1 4. The teacher or employee has complied with the school district's policies
2 governing the use of sick leave.
- 3 (c) While a teacher or employee is on sick leave provided by this section, he or
4 she shall be considered a school district employee, and his or her salary,
5 wages, and other employee benefits shall not be affected.
- 6 (d) Any sick leave that remains unused, is not needed by a teacher or employee,
7 and will not be needed in the future shall be returned to the teacher or
8 employee donating the sick leave.
- 9 (e) The board of education shall adopt policies and procedures necessary to
10 implement the sick leave donation program.
- 11 (9) A teacher or employee may use up to thirty (30) days of sick leave following the
12 birth or adoption of a child or children. Additional days may be used when the need
13 is verified by a physician's statement.
- 14 (10) (a) After July 1, 1982, ~~and except as otherwise provided by this subsection,~~ a
15 district board of education may compensate, at the time of retirement or upon
16 the death of a member in active contributing status at the time of death who
17 was eligible to retire by reason of service, an employee or a teacher, or the
18 estate of an employee or teacher, for each unused sick leave day. The rate of
19 compensation for each unused sick leave day shall be based on a percentage of
20 the daily salary rate calculated from the employee's or teacher's last annual
21 salary, not to exceed thirty percent (30%).
- 22 **(b) Except as provided in paragraph (c) of this subsection,** payment for unused
23 sick leave days **under this subsection**, ~~not to exceed the amount based upon~~
24 ~~the unused sick leave days accrued as of December 31, 2018,~~ shall be
25 incorporated into the **annual salary** ~~annual compensation~~ of the final year of
26 service for inclusion in the calculation of the employee's or teacher's
27 retirement allowance only at the time of his or her initial retirement, ~~;~~

1 provided that the member makes the regular retirement contribution for
 2 members on the sick leave payment. The accumulation of these days includes
 3 unused sick leave days held by the employee or teacher at the time of
 4 implementation of the program.

5 **(c) For a teacher or employee who becomes a nonuniversity member of the**
 6 **Teachers' Retirement System on or after January 1, 2022, as provided by**
 7 **Section 6 of this Act, payment for unused sick leave days under this**
 8 **subsection shall not be incorporated into the annual compensation used to**
 9 **calculate the teacher's or employee's retirement allowance in the**
 10 **foundational benefit component as described by Section 1 of this Act but**
 11 **may be deposited into the nonuniversity member's supplemental benefit**
 12 **component as provided by Section 3 of this Act.**

13 ~~(d)~~~~(b)~~ For a teacher or employee who begins employment with a local school
