


No funding comes from the Prosecutor's Advisory Council (PAC)

Child Support: A Great Return on Investment

Kentucky

- \$6.33 returned for every \$1.00 spent
- Ranked 11th

Tools for Enforcement

Administrative Enforcement

- Wage Withholdings
- Fed/State Tax Offsets
- Liens
- Passport denials
- Bank levy (FIDM)
- License Revocations

Judicial Enforcement

- Civil Contempt
- Misdemeanor Non-Support
- Felony Flagrant Non-Support

Federal Requirements for Child Support Enforcement

Establish a state agency to administer the IV-D program and collect and disburse child support payments

Every state must adopt child support guidelines

All orders must provide for health care coverage

Uniform Interstate Family Support Act (UIFSA) must pursue out of state cases

Why do we need to change the guidelines?

- Must be reviewed every 4 years
 - 45 CFR § 302.56(e)
- Consider economic data on cost of raising children, etc

Shared Parenting

Already seeing increase in shared parenting orders

Expect trend to continue with 2018 shared parenting legislation

Shared Parenting - Challenges

- Making sure child support attorneys and staff aren't drawn into custody matters
- At 50/50 shared parenting, the guidelines may not be a perfect fit, and deviation from the guidelines is likely required
- Currently using the off-set model for shared parenting cases
- Daycare and/or medical expenses are important factors in setting all child support
