

1 AN ACT relating to disabled license plates.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 186.042 is amended to read as follows:

- 4 (1) For the purposes of this section, "persons with disabilities which limit or impair the
5 ability to walk" means persons who:
- 6 (a) Cannot walk two hundred (200) feet or sixty-one (61) meters without stopping
7 to rest;
 - 8 (b) Cannot walk without the use of, or assistance from, a brace, cane, crutch,
9 another person, prosthetic device, wheelchair, or other assistant device;
 - 10 (c) Are restricted by lung disease to the extent that the person's forced respiratory
11 and expiratory volume for one (1) second, when measured by spirometry, is
12 less than one (1) liter, or the arterial oxygen tension is less than sixty (60)
13 mm/hg on room air at rest;
 - 14 (d) Use portable oxygen;
 - 15 (e) Have a cardiac condition to the extent that the person's functional limitations
16 are classified in severity as Class III or Class IV according to standards set by
17 the American Heart Association; or
 - 18 (f) Are severely limited in their ability to walk due to an arthritic, neurological, or
19 orthopedic condition.
- 20 (2) On the application of any person with disabilities which limit or impair the ability to
21 walk, who has lost the use of an arm or both arms, or who is blind, the
22 Transportation Cabinet shall issue the person with a disability, ***the parent or***
23 ***guardian of a disabled minor, or the parent or guardian of a disabled adult,*** an
24 accessible parking registration plate or renewal decal designating the vehicle
25 licensed as being owned by or leased by a person with a disability ***or their parent or***
26 ***guardian.*** The license plate or renewal decal may be issued for a passenger car as
27 set forth in KRS 186.050(1), for a motorcycle as set forth in KRS 186.050(2), or for

1 a commercial vehicle as set forth in KRS 186.050(3)(a). The registration plates
 2 issued shall bear the international symbol of access adopted by Rehabilitation
 3 International in 1969, reading from left to right and shall be followed by numbers or
 4 letters the cabinet finds expedient. **Except as provided in this subsection,** the
 5 cabinet shall not issue the registration plates so designated to any person other than
 6 a person with a disability as described above. The fee for a disabled license plate
 7 shall be as established in KRS 186.162.

8 (3) The application for a license plate for a person with a disability shall be made on a
 9 form prepared by the Transportation Cabinet. For every person seeking this
 10 accessible parking license plate, proof of the disability shall be required by:

11 (a) The county clerk issuing the license plate ascertaining that the applicant **or the**
 12 **applicant's minor or adult child** is obviously disabled as described in this
 13 section; or

14 (b) A statement from a licensed physician, physician assistant, chiropractor, or
 15 advanced practice registered nurse that the applicant **or the applicant's minor**
 16 **or adult child** is a person with disabilities which limit or impair the ability to
 17 walk, a person who has lost the use of an arm, or any person who is blind.

18 (4) When a motor vehicle bearing plates issued **under** ~~to a person with a disability as~~
 19 ~~prescribed in~~ this section is being operated by or for the benefit of the person with
 20 a disability, who is in the motor vehicle when the motor vehicle is being operated,
 21 the motor vehicle may be parked for a period of two (2) hours in excess of the legal
 22 parking period permitted by local authorities, except if local ordinances or police
 23 regulations prohibit parking on a highway for the purpose of creating a fire lane; if
 24 the ordinances or police regulations provide for the accommodation of heavy traffic
 25 during morning, afternoon, or evening hours; or if the motor vehicle is parked in
 26 such a manner as to clearly be a traffic hazard.

27 (5) Registration under this section shall expire July 31.
