## 21RS HB 89

AN ACT relating to intimidation of a sports official.

Sponsor Representative Randy Bridges

Create a new section of KRS Chapter 518 to create the crime of intimidation of a sports official as a Class A misdemeanor.

## 21RS HB 126

AN ACT relating to crimes and punishments.

Sponsor Representative C. Ed Massey

Amend KRS 194A.990, 205.8463, 238.995, 341.990, 434.650, 434.655, 434.690, 514.030, 514.040, 514.050, 514.060, 514.070, 514.080, 514.090, and 514.110 to increase the felony threshold for theft and fraud offenses to \$1,000; create a Class B misdemeanor level for theft and fraud offenses; amend the Class A misdemeanor level to be \$500 or more but less than \$1,000; enhance the penalty for three convictions of a Class A misdemeanor to a Class D felony if the convictions occur within a five year period; allow offenses that occur within 90 days to be aggregated into one offense.

## 21RS HB 229

AN ACT relating to the protection of livestock.

Sponsor Representative Matthew Koch

Amend KRS 512.010 to include "livestock" as defined in KRS 150.010 in the definition of "property" for the purposes of criminal damage to property offenses.

## 21RS HB 273

AN ACT relating to public records and declaring an emergency.

Sponsor Representative Chris Freeland

Amend KRS 61.878 to exclude from the Open Records Act photographs or videos that depict a person's death, killing, rape, or sexual assault or abuse; cite as the Bailey Holt-Preston Cope Victims Privacy Act;
