2018 General Assembly Budget Update

CPAB PROJECT RECOMMENDATIONS - MAINTENANCE

The Capital Planning Advisory Board's (CPAB) 2018-2024 Statewide Capital Improvements Plan recommended that maintenance of existing state facilities be considered as the highest priority for funding in the 2018-20 Executive Budget, and specifically referenced state agency maintenance pools. The 2018-2020 Executive Branch Budget includes an **overall increase of 60% in funding for agency miscellaneous maintenance pools (Attachment A)**. Maintenance pool appropriations for several agencies increased this budget cycle, those agencies receiving increases include the Department of Education, Operations and Support; the Finance and Administration Cabinet; the Justice Cabinet, Kentucky State Police; and the Tourism, Arts, and Heritage Cabinet, Department of Parks. Maintenance pool funding for the Department of Education, General Administration and Support, decreased from \$4,350,000 in the last budget to \$800,000 in the current budget.

A significant deviation during this budget period is the authorization of a \$6 million bond-funded maintenance pool for the Kentucky State Fair Board. In its last capital plan, the Fair Board notes that declining revenues and greater capital obligations significantly and adversely impacted their ability to address capital needs, and as a result, one of the Fair Board's highest priorities during the budget cycle was the authorization of a maintenance pool. Additionally, the Department of Military Affairs received authorization for an \$8 million Armory Modernization Pool (\$6 million federal; \$2 million bond funds). In testimony to the board last year, the Department of Military Affairs reported an opportunity to leverage additional federal dollars for such a pool.

CPAB PROJECT RECOMMENDATIONS

The 2018-20 Executive and Judicial Branch Budgets authorize several of the specific capital projects recommended by CPAB in its 2018-2024 Statewide Capital Improvements Plan.

The 2018-20 Executive Budget contains three projects for the Kentucky State Fair Board that were not included the Tourism, Arts and Heritage Cabinet's last capital plan.

Construct Agri-Plex at Exposition Center - Authorization to pursue the construction of an Agri-Plex Center at the Kentucky Exposition Center. This would be a 100,000-200,000 square foot facility dedicated to the agribusiness and livestock industries.

Construct Gate One Hotel at Kentucky Exposition Center - Authorization to pursue gate one hotel development at the Kentucky Exposition Center. A third party developer would operate and maintain the hotel.

Construct Hotel Development at Exposition Center - Authorization to pursue a hotel development at the Kentucky Exposition Center. A third party developer would operate and maintain the hotel.

The Judicial Branch budget contains one project for the Kentucky Court of Justice not included their last capital plan.

Renovation/Addition-Oldham County-\$22,590,000 Local bonds, \$1,600,000 General Fund use allowance – The scope of work will include renovation of the existing facility, and construction of an addition. The total square footage will be about 71,000 square feet.

The budget also includes authorization for two of the largest capital projects included in the 2018-2024 Statewide Capital Improvements Plan:

Finance Cabinet - Department of Revenue Integrated Tax System - \$92,500,000 bond funds

Justice Cabinet - Kentucky State Police 2-Way Radio System Replacement, Phase I - \$35,100,000 bond funds
