AGENCY MISSION AND PROGRAMS

As one of the nation's 76 land-grant institutions, the University of Kentucky serves as the Commonwealth's flagship for higher education, research and healthcare. As Kentucky's university, we are anchored in our mission to educate, innovate, heal and serve.

Our mission has evolved, but our sense of responsibility and vision of service remain the same. UK has a broad range of resources centered on a single campus in the heart of the Bluegrass, but with a presence in every county of the state.

Our wide array of program fosters engagement and collaboration across colleges, programs and research endeavors.

UK is home to nearly 33,000 students and approximately 25,000 employees, including almost 2,800 full-time faculty, and operates and annual budget of \$6.8 billion.

The state's flagship university consists of 16 academic and professional, degree-granting colleges where students can choose from more than 200 majors and degree programs and the undergraduate and graduate levels. UK is one of eight universities in the United States that has colleges of agriculture, engineering, medicine and pharmacy on a single campus, leading to groundbreaking discoveries and unique interdisciplinary collaboration.

This large populace of students and professionals place persistent and considerable demands on institutional facilities, requiring continuous maintenance and renovation. Additionally, rapid advances in technology and society are constantly reshaping the University's curricula and the means of delivering programs and services. The University's planning and resource allocation are designed to provide the technology infrastructure, equipment and personnel support systems necessary to ensure student success, support substantial research activities and ensure the effective and efficient delivery of programs and services.

Leading the University of Kentucky's priorities for this Capital Plan are projects that speak to the rich heritage of our campus and our quest to serve the state through education, research, healthcare and innovation.

The first of these priorities is our continuing commitment to Asset Preservation, a multiphase effort to preserve existing campus buildings and infrastructure so that they may continue to serve well into the future. The second is an ambitious plan for the growth of our Edith Martin and Harry W. Gatton, Sr. College of Agriculture, Food and Environment (CAFÉ).

The University's current asset preservation list includes needed improvements to several of our highly critical facilities: the Multi-Disciplinary Science Building which serves the Colleges of Nursing and Health Sciences, design renovations of the widely used White Hall Classroom Building, renovations to Pence Hall and Miller Hall, renovation of two floors of the Patterson Office Tower, renovations to the Peterson Services Building, as well as campus utility infrastructure and building-systems projects.

The preservation of our facilities would not have been possible without the decades of investment by the state in the University of Kentucky. These investments have made possible the University's stewardship of vital state resources.

Our second priority in this Capital Plan speaks to the very roots of UK as one of the nation's few land-grant universities.

CAFÉ has been a beacon of knowledge and support for a state where agriculture has been a lifeline for many Kentucky families over the generations. Today, CAFÉ finds itself challenged by its aging buildings and the need to prepare for a future much different from the past. Additionally, UK HealthCare will be expanding the Chandler campus and supporting infrastructure to add 500 patient beds and a state-of-the-art cancer and ambulatory care facility. To make way for this needed expansion and to move CAFÉ into position to better meet the current and future needs of the Commonwealth, this Capital Plan proposes the renovation and renewal of current facilities and construction of multiple new buildings to provide new classrooms, laboratories, greenhouses, research, and support space to CAFÉ which sits at the heart of all we do at the University of Kentucky.

The University's Capital Plan addresses our key areas: academics, quality of life and community, healthcare, and infrastructure. The goal for each project is the same - providing the Commonwealth with an educated, nimble workforce capable of leading the state toward a prosperous, healthy future. This Plan will continue our path as good stewards of our facilities and to grow strategically and purposefully to continue to lead and support the needs of the Commonwealth as its flagship university.

1 Asset Preservation Pool

\$200,000,000

- Asset Preservation projects may include projects to update and replace building systems and infrastructure that supports the education and general programs/facilities and state-owned and operated residence halls as those systems are at or past the end of their expected life cycles.
- UK Capital Project Management Division estimated the project scope using project cost data of past similar university projects and/or other similar higher education facility building projects. Those costs were brought forward in time using data from multiple sources including R.S. Means data.

2 Construct Research Facility

\$450,000,000

This project will construct an approximately 300,000 gross square foot science research facility that will provide state-of-the-art research space for disciplines including health sciences, chemistry, physics, earth sciences, psychology, bio-medical engineering, nutrition, material science and/or nanotechnology. In support of modern research, a percentage of this facility may be assigned to a data center role. (C-O)
