Upgrade Technology 600,000 GF

The office of the Attorney General did not have an electronic case management system nor data collection system. The OAG relied on various means to docket cases, manage legal files, and collect data through various Excel spreadsheets and two legacy programs, Genserv and Agenda. These legacy systems are not stable in their viability for maintenance and security through COT. COT confirmed the immediate need of the electronic case management system to migrate these programs and data. The electronic case management and data system is necessary for the efficacy, effectiveness and data preservation. Additional funding is needed for these systems to include the statutorily mandated new programs and offices reorganized that were not included in the original project. (IT)

- This is additional funding for an existing project. The current project was authorized for \$2,000,000 in FY 2020 and is approximately 80% complete.
- Additional funds are needed due to reorganizations and new programs statutorily mandated to the Office that were not previously budgeted in the original project.
