

1 AN ACT relating to reorganization.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 42 IS CREATED TO
4 READ AS FOLLOWS:

5 **(1) The Office of Fleet Management pursuant to Section 3 of this Act shall be**
6 **generally responsible for all technical and administrative services related to the**
7 **Commonwealth's fleet of vehicles, including but not limited to:**

8 **(a) Procuring vehicles;**

9 **(b) Maintaining and repairing vehicles;**

10 **(c) Reserving, assigning, and distributing vehicles;**

11 **(d) Reporting fleet mileage; and**

12 **(e) Performing any additional administrative functions and duties the secretary**
13 **may assign.**

14 **(2) There shall be established in the Office of Fleet Management the following**
15 **divisions which shall be headed by a division director who shall report to the**
16 **executive director of the Office of Fleet Management:**

17 **(a) Division of Maintenance; and**

18 **(b) Division of Operations and Administration.**

19 **(3) The division directors appointed under this section shall be appointed by the**
20 **secretary with the approval of the Governor under KRS 12.050. There may be, if**
21 **needed, sections assigned to specific areas of work, responsible directly to the**
22 **executive director of the Office of Fleet Management.**

23 ➔Section 2. KRS 12.020 is amended to read as follows:

24 Departments, program cabinets and their departments, and the respective major
25 administrative bodies that they include are enumerated in this section. It is not intended
26 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
27 bureau, interstate compact, commission, committee, conference, council, office, or any

1 other form of organization shall be included in or attached to the department or program
 2 cabinet in which they are included or to which they are attached by statute or statutorily
 3 authorized executive order; except in the case of the Personnel Board and where the
 4 attached department or administrative body is headed by a constitutionally elected officer,
 5 the attachment shall be solely for the purpose of dissemination of information and
 6 coordination of activities and shall not include any authority over the functions,
 7 personnel, funds, equipment, facilities, or records of the department or administrative
 8 body.

12 of the cabinet, including but not limited to providing administrative assistance;
13 managing and preparing the cabinet's budget; performing general accounting;
14 managing fiscal, personnel, and payroll functions of the cabinet; providing
15 statewide postal and printing services; providing administrative support to boards
16 and commissions; and performing any additional administrative functions and
17 duties the secretary may assign.

18 (2) There shall be established in the Office of Administrative Services:

26 this section, including a life-cycle cost comparison, and a projected timetable
27 to replace motor vehicles in the state motor pool as provided in subsection (1)

2 (b) The strategy for increased use of ethanol, cellulosic ethanol, biodiesel, and
3 alternative transportation fuels, including the targeted amount and the dates by
