

1           A JOINT RESOLUTION designating honorary names for various roads and  
2 bridges.

3           WHEREAS, from time to time, the General Assembly has seen fit to honor various  
4 Kentuckians by naming portions of state highways and erecting commemorative roadway  
5 signs in their honor; and

6           WHEREAS, these Kentuckians have come from all walks of life, held a multitude  
7 of jobs, and had a variety of accomplishments that made them deserving of the honor;  
8 and

9           WHEREAS, these individuals have included former Governors, former members of  
10 the General Assembly, decorated veterans, slain law enforcement officers, local elected  
11 officials, astronauts, doctors, educators, distinguished athletes, and civic leaders; and

12           WHEREAS, every citizen of the Commonwealth owes a great debt of gratitude to  
13 the patriotic men and women killed and wounded in service to their country in times of  
14 great need; and

15           WHEREAS, the General Assembly has often honored the veterans of this state by  
16 naming portions of several roads, from interstates to small two-lane country roads, in  
17 their honor; and

18           WHEREAS, the General Assembly again sees fit to honor a group of individuals  
19 who have made the lives of their fellow Kentuckians better and brought honor and  
20 respect to the Commonwealth;

21           NOW, THEREFORE,

22 ***Be it resolved by the General Assembly of the Commonwealth of Kentucky:***

23           ➔Section 1. The Transportation Cabinet shall designate the portion of Kentucky  
24 Route 293, within the city limits of Princeton, as the "Chief Deputy Jody Wayne Cash  
25 Memorial Highway" and shall, within 30 days of the effective date of this Resolution,  
26 erect appropriate signs denoting this designation.

27           ➔Section 2. The Transportation Cabinet shall designate the bridges on United

1 States Route 23, at mile point 11.272 (Bridge ID# 58B00050L and Bridge ID#  
2 58B00050R) in Johnson County, as the "Representative Hubert and Bea Collins  
3 Memorial Bridges" and shall, within 30 days of the effective date of this Resolution, erect  
4 appropriate signs denoting this designation.

5 ➔Section 3. The Transportation Cabinet shall designate Kentucky Route 371 in  
6 Kenton County, from its intersection with Anderson Road to its intersection with Western  
7 Reserve Road, as the "Michael Scott 'Bubba' Wilson Memorial Highway" and shall,  
8 within 30 days of the effective date of this Resolution, erect appropriate signs denoting  
9 this designation.

10 ➔Section 4. The Transportation Cabinet shall designate the portion of Kentucky  
11 Route 49 in Marion County, from West Marion Elementary School (mile point 25.531)  
12 north to Hughes Lane (mile point 26.253), as the "Tom Brahm Memorial Highway" and  
13 shall, within 30 days of the effective date of this Resolution, erect appropriate signs  
14 denoting this designation.

15 ➔Section 5. The Transportation Cabinet shall designate the bridge on Kentucky  
16 Route 3091 crossing the Louie B. Nunn Cumberland Parkway in Pulaski County (Bridge  
17 ID# 100B00121N) as the "Reverend C.E. Jacobs Memorial Bridge" and shall, within 30  
18 days of the effective date of this Resolution, erect appropriate signs denoting this  
19 designation.

20 ➔Section 6. The Transportation Cabinet shall designate the bridge on United  
21 States Route 27 in Pulaski County, crossing Pitman Creek (Bridge ID# 100B00107L and  
22 Bridge ID# 100B00032R), as the "Jim and Mary Jo Sharpe Memorial Bridge" and shall,  
23 within 30 days of the effective date of this Resolution, erect appropriate signs denoting  
24 this designation.

25 ➔Section 7. The Transportation Cabinet shall honor the accomplishments of  
26 Richie Weems and the Continental Five by inclusion on the Country Music Highway on  
27 United States Highway 23 in Pike County and shall, within 30 days of the effective date

1 of this Resolution, erect appropriate signs denoting this designation.

2 ➔Section 8. The Transportation Cabinet shall designate the portion of Kentucky  
3 Route 292 in Martin County, from the intersection with Kentucky Route 3213  
4 (approximately mile point 26.1) to the intersection with Kentucky Route 3 (mile point  
5 28.9), as the "PFC Larry Gene Ratliff Memorial Highway" and shall, within 30 days of  
6 the effective date of this Resolution, erect appropriate signs denoting this designation.

7 ➔Section 9. The Transportation Cabinet shall designate the portion of Kentucky  
8 Route 2049 in Jefferson County, from its intersection with Kentucky Route 1934 to mile  
9 point 1.7, as the "Cozy and Linnes Chester Memorial Highway" and shall, within 30 days  
10 of the effective date of this Resolution, erect appropriate signs denoting this designation.

11 ➔Section 10. The Transportation Cabinet shall designate the bridge on Kentucky  
12 Route 122 in Floyd County at mile point 23.334 (Bridge ID# 036B00006N) as the "L.G.  
13 Frazier Memorial Bridge" and shall, within 30 days of the effective date of this  
14 Resolution, erect appropriate signs denoting this designation.

15 ➔Section 11. The Transportation Cabinet shall designate the bridge on Kentucky  
16 Route 192 in Laurel County crossing the CSX Railroad at mile point 21.030 (Bridge ID#  
17 063B00098N) as the "Christopher Hubbard Memorial Bridge" and shall, within 30 days  
18 of the effective date of this Resolution, erect appropriate signs denoting this designation.

19 ➔Section 12. The Transportation Cabinet shall designate the Mine Fork bridge on  
20 Kentucky Route 1081 in Magoffin County at mile point 14.95 as the "Berry Caudill  
21 Memorial Bridge" and shall, within 30 days of the effective date of this Resolution, erect  
22 appropriate signs denoting this designation.

23 ➔Section 13. The Transportation Cabinet shall designate the Salyersville bridge  
24 on Kentucky Route 7 in Magoffin County at mile point 25.055 as the "Julian Patrick  
25 Memorial Bridge" and shall, within 30 days of the effective date of this Resolution, erect  
26 appropriate signs denoting this designation.

27 ➔Section 14. The Transportation Cabinet shall designate the portion of Kentucky

1 Route 7 in Magoffin County, from mile point 1.08 to mile point 2.50, as the "Claude  
2 Howard Memorial Highway" and shall, within 30 days of the effective date of this  
3 Resolution, erect appropriate signs denoting this designation.

4 ➔Section 15. The Transportation Cabinet shall designate the portion of Kentucky  
5 Route 2020 in Magoffin County, from mile point 0.00 to mile point 0.07, as the "Robert  
6 Cheek Memorial Highway" and shall, within 30 days of the effective date of this  
7 Resolution, erect appropriate signs denoting this designation.

8 ➔Section 16. The Transportation Cabinet shall designate the portion of Kentucky  
9 Route 1593 in Magoffin County, from mile point 3.22 to mile point 3.63, as the "Oliver  
10 Lykins Memorial Highway" and shall, within 30 days of the effective date of this  
11 Resolution, erect appropriate signs denoting this designation.

12 ➔Section 17. The Transportation Cabinet shall designate the portion of Kentucky  
13 Route 867 in Magoffin County, from mile point 3.28 to mile point 3.74, as the "Winford  
14 Arnett Memorial Highway" and shall, within 30 days of the effective date of this  
15 Resolution, erect appropriate signs denoting this designation.

16 ➔Section 18. The Transportation Cabinet shall designate the portion of Kentucky  
17 Route 1471 in Magoffin County, from mile point 3.27 to mile point 4.16, as the "Henry  
18 Bailey Memorial Highway" and shall, within 30 days of the effective date of this  
19 Resolution, erect appropriate signs denoting this designation.

20 ➔Section 19. The Transportation Cabinet shall designate the portion of Kentucky  
21 Route 1593 in Magoffin County, from mile point 2.157 to mile point 2.569, as the "Oval  
22 Gray Amyx Memorial Highway" and shall, within 30 days of the effective date of this  
23 Resolution, erect appropriate signs denoting this designation.

24 ➔Section 20. The Transportation Cabinet shall designate the bridge located at  
25 Midway on Bull Creek, crossing the Hal Rogers Parkway between the Hyden Spur and  
26 the big bridge at Dryhill, in Leslie County as the "Amos and Twila Osborne Memorial  
27 Bridge" and shall, within 30 days of the effective date of this Resolution, erect

1 appropriate signs denoting this designation.

2 →Section 21. The Transportation Cabinet shall honor the accomplishments of  
3 Julie Reeves Davis by inclusion on the Country Music Highway on United States  
4 Highway 23 in Boyd County near Ashland and shall, within 30 days of the effective date  
5 of this Resolution, erect appropriate signs denoting this designation.

6 →Section 22. The Transportation Cabinet shall designate the portion of Kentucky  
7 Route 1 in Carter County, from United States Route 60 at mile point 10.646 to the  
8 Interstate 64 overpass at mile point 11.546, as the "Assistant Fire Chief Duane Suttles  
9 Memorial Highway" and shall, within 30 days of the effective date of this Resolution,  
10 erect appropriate signs denoting this designation.

11 →Section 23. The Transportation Cabinet shall designate the bridge on Kentucky  
12 Route 227, on the Owen-Carroll County line over Eagle Creek (Bridge ID#  
13 094B00029N), as the "Staff Sergeant Christopher Stout Memorial Bridge" and shall,  
14 within 30 days of the effective date of this Resolution, erect appropriate signs denoting  
15 this designation.

16 →Section 24. The Transportation Cabinet shall designate the bridge on Kentucky  
17 Route 82 crossing the Red River in Powell County (Bridge ID# 099B00050N), as the  
18 "Marion Brewer Memorial Bridge" and shall, within 30 days of the effective date of this  
19 Resolution, erect appropriate signs denoting this designation.

20 →Section 25. The Transportation Cabinet shall designate the bridge on Kentucky  
21 Route 213, crossing the Red River in Powell County (Bridge ID# 099B00103N), as the  
22 "John Cox Memorial Bridge" and shall, within 30 days of the effective date of this  
23 Resolution, erect appropriate signs denoting this designation.

24 →Section 26. The Transportation Cabinet shall designate Kentucky Route 192 in  
25 Laurel County, from mile point 7.313 to mile point 12.59, as the "Dan Hale Memorial  
26 Highway" and shall, within 30 days of the effective date of this Resolution, erect  
27 appropriate signs denoting this designation.

1           ➔Section 27. The Transportation Cabinet shall designate the bridge on Kentucky  
2 Route 52 crossing the Dix River at the Boyle-Garrard County line (Bridge ID#  
3 011B00048N) as the "James 'Jim' Herring Memorial Bridge" and shall, within 30 days of  
4 the effective date of this Resolution, erect appropriate signs denoting this designation.

5           ➔Section 28. The Transportation Cabinet shall designate Kentucky Route 117 in  
6 Christian County, from United States Route 41A to its intersection with Kentucky Route  
7 107, as the "Valor Memorial Highway" and shall, within 30 days of the effective date of  
8 this Resolution, erect appropriate signs denoting this designation.

9           ➔Section 29. The Transportation Cabinet shall designate the bridge on Kentucky  
10 Route 194 crossing over Brushy Fork at the Floyd-Pike County line (Bridge ID#  
11 036B00155N) as the "Pete McCoy Memorial Bridge" and shall, within 30 days of the  
12 effective date of this Resolution, erect appropriate signs denoting this designation.

13           ➔Section 30. The Transportation Cabinet shall designate the bridge on Kentucky  
14 Route 40 crossing Mudlick Creek in Johnson County (Bridge ID# 058B00064N) as the  
15 "Bud and John Blanton Memorial Bridge" and shall, within 30 days of the effective date  
16 of this Resolution, erect appropriate signs denoting this designation.

17           ➔Section 31. The Transportation Cabinet shall designate the bridge on Kentucky  
18 Route 52 crossing Pottinger Creek in Nelson County (Bridge ID# 090B00097N) as the  
19 "New Hope Veterans Memorial Bridge" and shall, within 30 days of the effective date of  
20 this Resolution, erect appropriate signs denoting this designation.

21           ➔Section 32. The Transportation Cabinet shall designate the bridge on Kentucky  
22 Route 358 crossing Hanley Creek in Ballard County (Bridge ID# 004B00025N) as the  
23 "Morris Crain Memorial Bridge" and shall, within 30 days of the effective date of this  
24 Resolution, erect appropriate signs denoting this designation.

25           ➔Section 33. The Transportation Cabinet shall designate the bridge on Kentucky  
26 Route 15 crossing Lost Creek in Breathitt County (Bridge ID# 013B00032N) as the  
27 "Floyd Watts Memorial Bridge" and shall, within 30 days of the effective date of this

1 Resolution, erect signs denoting this designation.

2 ➔Section 34. The Transportation Cabinet shall designate the entirety of United  
3 States Route 62 in Scott County as the "Deputy Sheriff Caleb Conley Memorial  
4 Highway" and shall, within 30 days of the effective date of this Resolution, erect  
5 appropriate signs denoting this designation. This designation shall supersede any  
6 previous honorary designation made for this section of highway.

7 ➔Section 35. The Transportation Cabinet shall designate Kentucky Route 67 in  
8 Greenup County as the "Don Gullett Memorial Highway" and shall, within 30 days of the  
9 effective date of this Resolution, erect appropriate signs denoting this designation.

10 ➔Section 36. The Transportation Cabinet shall designate Kentucky Route 503 in  
11 Greenup County, from the intersection with Kentucky Route 207 (mile point 5.481) to  
12 the intersection with Kentucky Route 3105 (mile point 9.287) as the "PFC Ernie West  
13 Memorial Highway" and shall, within 30 days of the effective date of this Resolution,  
14 erect appropriate signs denoting this designation. Signs erected under this section shall  
15 indicate that PFC Ernie West was a Medal of Honor recipient. This designation shall  
16 supersede any previous honorary designation made for this section of highway.

17 ➔Section 37. The Transportation Cabinet shall designate the portion of United  
18 States Route 62 in Anderson County, from mile point 18.276 to mile point 18.825, as  
19 "The Healing Field Memorial Highway" and shall, within 30 days of the effective date of  
20 this Resolution, erect appropriate signs denoting this designation.

21 ➔Section 38. The Transportation Cabinet shall designate Kentucky Route 140 in  
22 Daviess County, from the intersection with Red Hill-Maxwell Road (mile point 7.325) to  
23 the intersection with United States Route 231 (mile point 10.038), as the "Captain Alan  
24 Kurre Elliott Memorial Highway" and shall, within 30 days of the effective date of this  
25 Resolution, erect appropriate signs denoting this designation.

26 ➔Section 39. The Transportation Cabinet shall designate Kentucky Route 1088 in  
27 Perry County, from its intersection with Kentucky Route 476 to mile point 5, as the

1 "Donald Loren 'Doc' Holliday Memorial Highway" and shall, within 30 days of the  
2 effective date of this Resolution, erect appropriate signs denoting this designation.

3 ➔Section 40. The Transportation Cabinet shall designate the roundabout at the  
4 intersection of Kentucky Route 686 and Kentucky Route 713 in Montgomery County as  
5 the "Emilee Grace Collins Memorial Roundabout" and shall, within 30 days of the  
6 effective date of this Resolution, erect appropriate signs denoting this designation in  
7 advance of the roundabout in each direction.

8 ➔Section 41. The Transportation Cabinet shall honor the accomplishments of  
9 "JoJo Hall and Teddi Leigh Cyrus as JoLeigh" by inclusion on the Country Music  
10 Highway on United States Route 23 in Floyd County and shall, within 30 days of the  
11 effective date of this Resolution, erect appropriate signs denoting this designation.

12 ➔Section 42. The Transportation Cabinet shall designate the bridge on United  
13 States Route 421 crossing Poor Fork Cumberland River in Harlan County (Bridge ID#  
14 048B00129N) as the "Clark 'Sparky' Middleton Memorial Bridge" and shall, within 30  
15 days of the effective date of this Resolution, erect appropriate signs denoting this  
16 designation.

17 ➔Section 43. The Transportation Cabinet shall designate the portion of Kentucky  
18 Route 2054 in Jefferson County, from its intersection with Kentucky Route 1934 to its  
19 intersection with Winkler Avenue, as the "Anne and Carl Braden Memorial Highway"  
20 and shall, within 30 days of the effective date of this Resolution, erect appropriate signs  
21 denoting this designation.

22 ➔Section 44. The Transportation Cabinet shall designate the portion of Kentucky  
23 Route 1934 in Jefferson County, from its intersection with Kentucky Route 1727 to its  
24 end at Wilson Avenue (mile point 11.5), as the "Andrew and Charlotte Wade Memorial  
25 Highway" and shall, within 30 days of the effective date of this Resolution, erect  
26 appropriate signs denoting this designation.

27 ➔Section 45. The Transportation Cabinet shall designate the portion of Kentucky



1 Route 52 in Garrard County, from the eastern city limits of the city of Lancaster to the  
2 Garrard-Madison County line, as the "Representative Lonnie Napier Memorial Highway"  
3 and shall, within 30 days of the effective date of this Resolution, erect appropriate signs  
4 denoting this designation.

5 →Section 46. The Transportation Cabinet shall designate the bridge on Kentucky  
6 Route 1214 crossing the Western Kentucky Parkway in Grayson County (Bridge ID#  
7 043B00060N) as the "James 'Spike' Johnston Memorial Bridge" and shall, within 30 days  
8 of the effective date of this Resolution, erect appropriate signs denoting this designation.

9 →Section 47. The Transportation Cabinet shall designate the bridge on Kentucky  
10 Route 107 crossing the Western Kentucky Parkway in Todd County (Bridge ID#  
11 043B00060N) as the "Sgt. Major Robert 'Bob' Murphy Memorial Bridge" and shall,  
12 within 30 days of the effective date of this Resolution, erect appropriate signs denoting  
13 this designation.

14 →Section 48. The Transportation Cabinet shall honor the accomplishments of  
15 Yvonne Jordan by inclusion on the Country Music Highway on United States Route 23 in  
16 Lawrence County and shall, within 30 days of the effective date of this Resolution, erect  
17 appropriate signs denoting this designation.
