It shall 5 6 include but is not limited to the following information: 7 The name and present resident address of the licensee; (a) 8 (b) The licensee's photograph; 9 A physical description of the licensee including sex, height, weight, and eye (c) 10 color; 11 The licensee's date of birth; (d) 12 The licensee's signature; (e) (f) The class or type of commercial motor vehicle or vehicles that the person is 13 14 authorized to drive together with any endorsements or restrictions; 15 The name of this state: (g) 16 (h) The dates between which the license is valid; and 17 (i) Any other information required by the cabinet, except for a person's Social 18 Security number. 19 (2)A commercial driver's license issued under this chapter shall contain a denotation 20 that either: 21 (a) The commercial driver's license is a voluntary travel ID identity document 22 that complies with the security standards set forth by Pub. L. No. 109-13, 23 Title II, and may be used for identification for federal purposes; or 24 The commercial driver's license shall not be used for federal identification (b) 25 purposes. 26 (3) A commercial driver's license shall be issued with classifications, endorsements,

and restrictions. Vehicles that require an endorsement shall not be driven unless the

6		allowed to operate a school bus or a vehicle transporting hazardous material in
7		intrastate commerce].
8	<u>(8)</u> [(	7)] The holder of a commercial driver's license shall be considered to hold a valid
9		Kentucky driver's license issued under the provisions of KRS 186.4102 and
10		186.412.
11		→ Section 2. KRS 281A.185 is amended to read as follows:
12	(1)	The Commonwealth shall not mask, defer imposition of judgment, or allow an
13		individual to enter into a diversion program that would prevent a CLP or CDL
14		holder's conviction for any violation, in any type of motor vehicle, of a state or local
15		traffic control law from appearing on the CDLIS driver record, whether the <u>driver's</u>
16		conviction was [driver was convicted] for an offense committed in the
17		Commonwealth or another state.
18	(2)	This section shall not apply to the following violations:
19		(a) Parking;
20		(b) Vehicle weight; or
21		(c) Vehicle defect.
22	<u>(3)</u>	When any actions under subsection (1) of this section occur, the conviction must
23		be reported from the court to the licensing agency to be recorded on the driver's
24		record and trigger any appropriate disqualifying action.
