STATEMENT OF EMERGENCY

30 KAR 5:031E

This emergency administrative regulation is being promulgated in order to meet an imminent threat to public health, safety, or welfare. This regulation is necessary pursuant to KRS 355.9-526 to ensure continued compliance with state law, to protect the public welfare by maintaining Uniform Commercial Code secured transaction filing procedures that are congruent with the actual filing practices of the Office of the Secretary of State, and are in harmony with the rules and practices of filing offices in other jurisdictions that enacted Article 9 of the Uniform Commercial Code and the International Association of Commercial Administrators (IACA) Model Administrative Rules for filing under that article. This emergency administrative regulation will be replaced by an ordinary administrative regulation once the ordinary regulation becomes effective. The ordinary administrative regulation is identical to this emergency administrative regulation.

6 RELATES TO: KRS. KRS 355.9-513A, 355.9-515, 355.9-516, 355.9-516A, 355.9-520 and
7 KRS Chapter 446.030.

8 STATUTORY AUTHORITY: KRS 355.9-526(1).

9 NECESSITY, FUNCTION, AND CONFORMITY: KRS 355.9-526(1) requires the Secretary
10 of State to promulgate administrative regulations implementing KRS Chapter 355.9. This
11 administrative regulation establishes the requirements relating to the acceptance and refusal of
12 records.

13 Section 1. The filing office shall refuse to accept a UCC record for any reason, or multiple
14 reasons pursuant to KRS 355.9-516. The filing office may refuse to accept a UCC record pursuant
15 to KRS 355.9-516A.

16 Section 2. Except for UCC records rejected under KRS 355.9-516A of this regulation, the
17 duties and responsibilities of the filing office with respect to the administration of the UCC shall
18 be ministerial. In accepting for filing or refusing to file a UCC record the filing office shall not:

- 19 (1) Determine the legal effect of the UCC record;
20 (2) Determine that information in the record is correct or incorrect, in whole or in part; or
21 (3) Create a presumption that information in the record is correct or incorrect, in whole or in part.

1 Section 3. (1) A continuation statement may be filed:

2 1. Six (6) months preceding the month in which the financing statement would lapse and
3 on the date that corresponds with the date the financing statement would lapse or if there is no
4 corresponding date, on the last day of that month.

5 (2) The last day on which a continuation statement may be filed shall be the date upon which the
6 related financing statement lapses, or the next business day the filing office is open for business.

7 Section 4. (1) If the filing office finds grounds to refuse a UCC record, the filing office shall
8 refund the filing fee and return the record or a copy of the record in accordance with KRS 355.9-
9 520(2).

10 (2) The reason or reasons for the refusal and other related information shall be made to the filer as
11 soon as practicable, but no later than two (2) business days after the refused UCC record was
12 received by the filing office. This information shall be provided by the same method by which the
13 UCC record was communicated to the filing office, by mail, or by a more expeditious means.


14 (3) Records of refusal, including a copy of the refused UCC record and the grounds for refusal,
15 shall be maintained until the first anniversary of the lapse date that applies or would have applied
16 to the related financing statement, assuming that the refused record had been accepted and filed.

17 Section 5. (1) The filing office may communicate to a filer that the filing office noticed potential
18 defects in a UCC record, whether or not it was filed or refused for filing.

19 Section 6. If a filer believes that a UCC record that was refused for filing should not have been
20 refused, the filer may contact the filing office to request a review of the refusal decision. The filer
21 shall provide a copy of the refused record and a statement of the basis for the belief that the filing
22 office wrongfully refused to file the record. Upon receipt of a request for review, the filing office
23 shall investigate the claim. If the filing office confirms that the record should have been refused,

1 the filing office shall provide a written explanation of the grounds for refusal. If it is determined
2 that the filing office refused to accept the record in error, the filing office shall file the UCC record
3 with the filing date and time the UCC record was originally communicated for filing. A filing
4 office statement relating to the relevant financing statement shall be placed in the UCC information
5 management system on the date that the corrective action was taken. The filing office statement
6 shall provide the date of the correction and explain the nature of the corrective action taken. The
7 record shall be preserved for so long as the record of the financing statement maintained in the
8 UCC information management system.

PUBLIC HEARING AND PUBLIC COMMENT PERIOD

A public hearing on this administrative regulation shall be held on December 28, 2021, at 9:00 a.m. EST, at Office of the Secretary of State. Individuals interested in being heard at this hearing shall notify this agency in writing by five (5) work days prior to the hearing, of their intent to attend. If no notification of intent to attend the hearing is received by that date, the hearing may be cancelled. A transcript of the public hearing will not be made unless a written request for a transcript is made. If you do not wish to be heard at the public hearing, you may submit written comments on the proposed administrative regulation. Written comments shall be accepted until December 31, 2021. Send written notification of intent to be heard at the public hearing or written comments on the proposed administrative regulation to the contact person.

(a) What this administrative regulation does: This administrative regulation establishes procedures governing the acceptance and refusal of UCC records submitted for filing with the Office of the Secretary of State.

(b) The necessity of this administrative regulation: This administrative regulation is necessary to comply with KRS 355.9-526 by establishing filing office rules.

(c) How this administrative regulation conforms to the content of the authorizing statutes: The administrative regulation conforms to the authorizing statutes by establishing filing office rules consistent with KRS Chapter 355, Article 9, and model UCC regulations.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation assists with the effective administration of Article 9 of KRS Chapter 355 by establishing filing office rules and providing uniformity and certainty with regard to the acceptance or refusal of UCC records submitted for filing.

(2) If this is an amendment to an existing administrative regulation, provide a brief summary of:

(a) How the amendment will change this existing administrative regulation: N/A

(b) The necessity of the amendment to this administrative regulation: N/A

(c) How the amendment conforms to the content of the authorizing statutes: N/A

(3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: This amendment affects any individual, business, organization, or governmental entity that files UCC records.

(c) As a result of compliance, what benefits will accrue to the entities identified in question (3): The regulation provides uniformity and certainty as to the acceptance or refusal of UCC filings made with the Office of the Secretary of State.

(5) Provide an estimate of how much it will cost to implement this administrative regulation:

(a) Initially: There will be no cost to implement this administrative regulation.

(b) On a continuing basis: There is no cost to implement this administrative regulation on a continuing basis.

(6) What is the source of the funding to be used for the implementation and enforcement of this administrative regulation: If any costs were to be identified, existing appropriations and fund sources for the Office of the Secretary of State would be utilized.

(7) Provide an assessment of whether an increase in fees or funding will be necessary to implement this administrative regulation, if new, or by the change, if it is an amendment: An increase in fees or funding will not be necessary to implement this administrative regulation.

(8) State whether or not this administrative regulation establishes any fees or directly or indirectly increases any fees: This administrative regulation neither establishes nor increases any fees.

(9) TIERING: Is tiering applied? Tiering was not appropriate in this administrative regulation because any potential tiering would be inconsistent with the article it implements and model UCC regulations.

This letter accompanies 30 KAR 5:031E as documentary evidence to satisfy the requirements of KRS 13A.190(1)(a) and (8)(a)(3).

KRS 355.9-526 (1) requires the Secretary of State to promulgate administrative regulations to implement Article 9 of the UCC after consulting the most recent version of the model rules promulgated by the International Association of Corporate Administrators (IACA), while also taking into consideration the regulations and technology used in other jurisdictions.

The Office of the Secretary of State has conducted a careful review of its internal filing procedures, the UCC regulations and technology adopted in other jurisdictions, KRS Chapter 13A, and the IACA model rules. That review has concluded that much of IACA model rule language conflicts with drafting rules established in KRS Chapter 13A.

Specifically, the IACA model rules adopt an informal style of regulatory language and restate statutory language in violation of KRS 13A.120(2)(e) and (i), as well as KRS 13A.222(4) (prohibiting the restatement of statutory requirements, regulations contradicting statutory requirements, prohibitions against ambiguous language, and prohibitions against the use of particular words.) Where possible, the IACA language was retained or modified to reflect the apparent intent.

This regulation retains the core provisions of the relevant IACA model rules; it is consistent with other UCC jurisdictions; and it satisfies KRS Chapter 13A. It is promulgated as an emergency regulation to maintain that certainty and prevent an imminent threat to public welfare and to satisfy the statutory requirements of KRS 355.9-526.
