**Effective date of an ordinary regulation** | Until June 26, 2019: [{KRS 13A.331}](#) | Beginning June 27, 2019: [{Ky Acts Ch. 192}](#)

- (1) Upon adjournment of a meeting of an interim joint committee if:
  - (a) The administrative regulation was on the meeting agenda; and
  - (b) A quorum was present;
- (2) Upon adjournment of a meeting of a joint standing committee if:
  - (a) The administrative regulation was on the meeting agenda; and
  - (b) A quorum was present;
- (3) Upon adjournment of a meeting of a House or Senate standing committee if:
  - (a) The administrative regulation was on its meeting agenda;
  - (b) A quorum was present; and
  - (c) The administrative regulation has previously been on a meeting agenda of the other standing committee when a quorum was present.

**NOTE: Emergency regulations** go into effect at the time they are filed with the Regulations Compiler's office. [{KRS 13A.190\(2\)}](#)
