NOTE: If a regulation does not receive comments, it will tentatively be scheduled for the ARRS meeting held during the same month the Notice to the Compiler is due.

If a regulation receives comments, it will tentatively be scheduled for the ARRS meeting the month after the SOC is filed. (The agency may request a deferral from that tentatively scheduled meeting.)

For a regulation to go into effect during a session of the General Assembly {[KRS 13A.331](#)}

- (1) LRC refers an administrative regulation to a House Standing Committee AND a Senate Standing Committee that has jurisdiction over the subject matter of the administrative regulation.
- (2) An administrative regulation will go into effect:
 - (a) 30 days after the date of referral; or
 - (b) Upon adjournment of the second committee that meets (or upon adjournment of a joint meeting of the House and Senate committees) if:
 1. The administrative regulation is placed on both committees' agendas;
 2. Both committees have a quorum; and
 3. The administrative regulation is not deferred or found deficient.

For a regulation to go into effect outside of a session of the General Assembly {[KRS 13A.330](#)}

- (1) LRC refers an administrative regulation to a committee that has jurisdiction over the subject matter of the administrative regulation, typically an Interim Joint Committee.
- (2) An administrative regulation will go into effect:
 - (a) 30 days after the date of referral; or
 - (b) Upon adjournment of the committee that meets if:
 1. The administrative regulation is placed on the committee's agenda;
 2. The committee has a quorum; and
 3. The administrative regulation is not deferred or found deficient.

NOTE: Emergency administrative regulations go into effect at the time they are filed with the Regulations Compiler's office. {[KRS 13A.190\(2\)](#)}
