Minutes of the 3rd Meeting of the 2024 Interim

August 21, 2024

Call to Order and Roll Call

The 3rd meeting of the Budget Review Subcommittee on General Government, Finance, Personnel, and Public Retirement was held on August 21, 2024, at 9:00 AM in Room 131 of the Capitol Annex. <Member>, <member position>, called the meeting to order, and the secretary called the roll.

Approval of Minutes (June 5, 2024 & July 17, 2024)

Due to an unmet quorum, the approval was passed to the next meeting.

Office of the Attorney General

Richard Ferretti, Commissioner of the Department of Criminal Investigations, gave a brief overview of the Body Armor Grant Program.

Responding to a question from Representative Bridges, Mr. Ferretti stated that the minimum safety equipment budget per officer is \$2,000.

Responding to a question from Representative Johnson, Mr. Ferretti said the definition of a rifle plate is a soft body armor plate that enables an officer to survive an assault.

In response to Senator Mills' question, Mr. Ferretti said this program's priority is to cover the 20 percent budget gap, and other equipment, such as tasers and body cameras, are last to be covered due to the expense. Body armor is functional after the expiration date and is also helpful in auto accidents.

Responding to a question from Representative Bowling, Mr. Ferretti stated that body armor

stays with the assigned officer. Each officer can be tracked by his/her Police Officer Professional Standards (POPS)-certification number as required by the Kentucky Law Enforcement Council (KLEC). The Attorney General's Office is collaborating with the Kentucky Chief's Association and the Kentucky Sheriff's Association to encourage all agencies to have a mandatory-wear policy. However, it is ultimately up to each agency to decide.

Mr. Ferretti responded that there are approximately 8,000 POPS certified officers in Kentucky to answer Representative Fleming's questions. Louisville Metro Police Department (LMPD) does not have a mandatory-wear policy.

In response to questions from Senator Nemes, Mr. Ferretti said written exceptions could be added to the agencies' policies, such as undercover officers. The Attorney General's Office only controls the funds it provides.

Responding to Chair Freeland's questions, Mr. Ferretti stated that the 20 percent funding gap is covered before additional equipment requests are met.

In response to Senator Mills' question, Mr. Ferretti said that body armor is replaced if an officer is shot, and the officer gets to meet the person who signed off on the manufacturing of the vest.
