ADMINISTRATIVE REGULATION REVIEW SUBCOMMITTEE Minutes of October 14, 2025

In response to Chair West, Eddie Slone, Executive Director, KBEMS, stated the scope of care for paramedics is developed as a guidance document published by the National Highway Traffic Safety Administration. Antivenom standards relate to native snakes and likely situations. The board is pursuing an exception protocol.

In response to Chair West, John Wood, Counsel, KBEMS, stated a new regulation is not required to establish the exception protocol.

In response to Chair West, John Holder, Chair, KBEMS, stated the exception protocol would be approved in advance by the medical oversight committee, followed by the full board. Mr. Holder explained there is a certain type of paramedic authorized to administer antivenom.

In response to Chair West, Director Slone stated the exception protocol is estimated to take four to six months to develop.

In response to Chair West, Leanne Diakov, General Counsel, KBML, stated the standards for prescribing buprenorphine for the treatment of substance use disorder have been amended several times since 2015. The amendment clarifies requirements and establishes exceptions in certain settings, such as in emergency rooms or for cancer treatment.

In response to Chair West, Mike Rodman, Executive Director, KBML, explained the board received a request in November 2023 from the Kentucky Society of Addiction

Medicine to relax the regulation requirements. In response, the board formed a committee, including stakeholders and consultants. The board sent amendment drafts to 10 to 15 organizations for feedback, and the regulation had three open comment periods.

In response to Senator Raque Adams, Ms. Diakov stated changes were made in response to the comments. The joint letter submitted by stakeholders to subcommittee members contains consistently repeated comments, which were considered by the board.

In response to Senator Raque Adams, William Chase Thornbury, Jr., MD, President, KBML, explained the regulation provides standards for front-line physicians with little or no experience in providing this care. Kentucky-specific empiric data should be considered over national statistics or other states' experience because Kentucky has a different risk factor. Kentucky overdoses are down considerably from three years ago. Access to care is not a problem because there has been an increase in providers and the option of telehealth. There is a line of patient safety the board is not willing to cross.

In response to Chair West, Benjamin Bowling, Medical Student, stated he grew up in Bell County, where there is first-hand experience with substance use disorder and lack of access to care. The regulation is more strict with buprenorphine than other Schedule III drugs. It requires excessive drug screens and rigid visit schedules, and limits the dose below FDA-approved thresholds. The regulation is outdated and should be repealed or substantially updated to align with federal standards. Buprenorphine is a proven, evidence-based medication that reduces overdose deaths and allows patients to become stable, productive members of society.

In response to Chair West, Benjamin Wright, Combat Veteran and Business Owner, stated he was overprescribed opioid medications in 2010, and buprenorphine is an integral part of his recovery. Mr. Wright discussed concerns about future access to buprenorphine.

In response to Chair West, Colleen Ryan, MD, President, KYSAM, stated she is supported in her testimony by the Kentucky Society of Addiction Medicine and the American Society of Addiction Medicine. The standards in the regulation are federal recommendations, which should be guidelines and not rules, because physicians need flexibility in treating these patients. Dr. Ryan quoted a letter submitted by stakeholder organizations outlining standards that should be amended. The regulation is not needed as much now due to existing regulations for Schedule II and Schedule III substances, as well as current data on substance use disorder treatment. The drop in the overdose rate is a national trend with debatable causes, and there is no connection between the regulation and this decrease.

In response to Chair West, Andrew Micciche, MD, stated he is a medical toxicologist and practitioner of addiction medicine who has studied buprenorphine thoroughly. Buprenorphine is safe and efficient in treating substance use disorder, but there are difficult barriers to accessing the drug. These include the inability to provide

buprenorphine in certain settings, such as immediately following an overdose, and physician uncertainty concerning the legality of prescribing it.

In response to Chair West, James Murphy, MD, stated he is a pain and addiction specialist, an anesthesiologist, and a professor at the University of Louisville School of Medicine. Dr. Murphy stated the board does not desire to make further changes to this regulation. The board consists of five members who may have conflicts of interest and have disregarded medical experts in the field of addiction. Many national and state organizations, representing approximately 500,000 people, are calling for this regulation to be overhauled or repealed. Dr. Murphy requested the regulation be sent back to the board for further review.

In response to Representative Marzian, Dr. Murphy explained suboxone is typically taken once daily in pill or film form. Patients receiving suboxone do not require monitoring by addiction specialists. This regulation makes it more difficult for individuals to receive treatment.

In response to Chair West, Dr. Murphy stated the board made a few improvements and clarifications, but in some respects, the amendment is more difficult, for example, requiring more drug screenings.

In response to Senator Raque Adams, Dr. Ryan stated compromise is possible if a larger workgroup is created to represent more stakeholders.

In response to Senator Raque Adams, Dr. Micciche noted there are issues that have not been addressed, such as paramedics' ability to provide buprenorphine after an overdose.

In response to Chair West, Ms. Diakov stated the board cannot regulate paramedics, as they are not licensees of the board. The regulation was deferred from last month's subcommittee meeting for further consideration of specific stakeholder feedback, but that feedback consisted mostly of requests for repeal. The agency amendment includes two specific changes that were requested.

In response to Chair West, Mark George, MD, Board Consultant, KBML, explained the regulation is updated regularly to make changes responding to advances in evidence-based treatments. He reviews complaints related to the prescription of buprenorphine, and physicians need prescribing guidelines. Telehealth could assist in access to treatment.

Dr. Thornbury stated the regulation is needed to help protect individuals with substance use disorder, as suboxone is frequently diverted. The drug tests are necessary for the physician to best know how to help the patient. Suboxone can still cause a substantial amount of withdrawal symptoms, and the combination with certain other drugs can be unsafe.

In response to Chair West, Ms. Diakov stated the board is open to deferring the regulation if stakeholders submit specific change requests other than repeal.

A motion was made and seconded to approve the following amendments: (1) to amend Sections 1(3) and 3(1)(b) to comply with the drafting requirements of KRS Chapter

13A; (2) to amend Section 3(2) to allow buprenorphine-mono-product to be prescribed to a patient diagnosed with opioid use disorder if the patient is transitioning from a full opioid agonist to buprenorphine, limited to a period of no longer than 30 days; and (3) to amend Section 3(4) to allow physicians certified in addiction medicine by the American Board of Preventive Medicine to be included among others qualified to provide specialty consult for patients. Without objection, and with agreement from the agency, the amendments were approved.

In response to Chair West, Dr. Thornbury stated the board agreed to defer consideration of this regulation to the November subcommittee meeting. Without objection, and with agreement of the agency, the regulation was deferred.
