Welcome

Nicole George, Deputy Mayor, Louisville Metro, welcomed the committee to Louisville. She stated that Louisville showcases Kentucky agriculture products and its people through the Kentucky State Fair and other annual events. It has a successful economic partnership between urban and rural areas.

Report of the Kentucky State Fair Board

David Beck, President and CEO, Kentucky Venues, stated that the Kentucky Exposition Center has a long tradition of hosting approximately 240 events and competitions each year, comprising of the North American International Livestock Show, the Farm Machinery Show, concerts, and sport competitions. He stated that attendance is projected to be around 600,000 people.

Mr. David Wallace, Kentucky State Fair Board member, said the board is currently implementing plans for Phase One to support infrastructure at the Kentucky Exposition Center, and will host a groundbreaking ceremony for construction of a 400,000 square foot agriculture building.

Representative Graham introduced Dr. Marcus Bernard, Dean, College of Agriculture, Health, and Natural Resources and Director of Land Grant Programs.
