EXEMPTION REQUESTS:

KENTUCKY DEPARTMENT OF AGRICULTURE:

The Kentucky Department of Agriculture requested an exemption from Committee Policy Statement #99-4 which prohibits contracts and agreements from extending beyond the biennium for eight grant recipients for the purpose of researching, training, and promoting specialty crop farming techniques in Kentucky. A motion was made by Senator Douglas to grant the request to September 29, 2026. Representative Hart seconded the motion, which passed without objection.

KENTUCKY DEPARTMENT OF AGRICULTURE:

The Kentucky Department of Agriculture requested an exemption from Committee Policy Statement #99-4 which prohibits contracts and agreements from extending beyond the biennium for the purpose of reimbursing food banks for receipt, storage, and distribution of USDA Foods. A motion was made by Senator Douglas to grant the request to December 31, 2024. Representative Hart seconded the motion, which passed without objection.

ENERGY & ENVIRONMENT CABINET:

The Energy & Environment Cabinet, Division of Forestry requested an exemption from Committee Policy Statement #99-4, which prohibits contracts and agreements from extending beyond the biennium for the Development of the Kentucky Urban and Community Forestry Assistance Program. A motion was made by Senator Douglas to grant the request to June 26, 2028. Representative Hart seconded the motion, which passed without objection.

ENERGY & ENVIRONMENT CABINET:

The Energy & Environment Cabinet, Division of Water requested an exemption from Committee Policy Statement #99-4, which prohibits contracts and agreements from extending beyond the biennium for the Map Modernization Management Support and Risk Mapping Grant. A motion was made by Senator Douglas to grant the request to

September 30, 2027. Representative Hart seconded the motion, which passed without objection.
