Justice and Public Safety Cabinet, Department of Justice Administration requests an exemption from the current two-year budget biennial contracting restrictions for the purpose of executing 20 subawards for the Byrne State Crisis Intervention Program in the amount of \$4,313,690; 100% Federal Funds to expire September 30, 2027.

11. Exemption Request

Justice and Public Safety Cabinet, Department of Justice Administration requests an exemption from the current two-year budget biennial contracting restrictions for the purpose of executing 10 subawards for the Project Safe Neighborhoods (PSN) Formula Grant Program in the amount of \$400,000; 100% Federal Funds to expire September 30, 2027.

Justice and Public Safety Cabinet, Department of Justice Administration requests an exemption from the current two-year budget biennial contracting restrictions for the purpose of executing 30 subawards for the Violence Against Women Act (VAWA) STOP Formula Program in the amount of \$2,169,000; 100% Federal Funds to expire December 31, 2026.

Justice and Public Safety Cabinet, Department of Justice Administration requests an exemption from the current two-year budget biennial contracting restrictions for the purpose of executing 12 subawards for the Edward Byrne Memorial Justice Assistance Grant (JAG) Program in the amount of \$1,663,000; 100% Federal Funds to expire September 30, 2026.

Justice and Public Safety Cabinet, Department of Justice Administration requests an exemption from the current two-year budget biennial contracting restrictions for the purpose of executing 100 subawards for the Victims of Crime Act (VOCA) in the amount of \$15,000,000; 100% Federal Funds to expire September 30, 2027.

Energy and Environment Cabinet, Division of Abandoned Mine Lands (DAML) requests an exemption from Committee Policy Statement #99-4 which prohibits contracts and agreements from extending beyond the biennium AND an exemption from routine Government Contract Review Committee process for the AML Bipartisan Infrastructure Law (BIL) Program and will provide quarterly reports; 100% Federal Funds to expire December 31, 2032. (Renewal)

Energy and Environment Cabinet, Division of Abandoned Mine Lands (DAML) requests an exemption from Committee Policy Statement #99-4 which prohibits contracts and agreements from extending beyond the biennium AND an exemption from routine Government Contract Review Committee process for the AML Economic Revitalization Program (AMLER) and will provide quarterly reports; 100% Federal Funds to expire December 31, 2028. (Renewal)

Kentucky State Police, Commercial Vehicle Enforcement Division requests an exemption from Committee Policy Statement #99-4 which prohibits contracts and agreements from extending beyond the biennium for the purpose of executing four (4) subawards for the Federal Motor Carrier Safety Administration's Motor Carrier Safety Assistance Program; 100% Federal funds to expire September 30, 2027.
