The Efficient and Effective School District Governance Task Force has four citizen-member positions to be appointed by the Legislative Research Commission (LRC). Those positions are:

- <u>TEACHER MEMBER</u> One member who is a certified teacher currently employed as a classroom teacher in a school district with enrollment greater than 75,000 who has at least five years of experience working in the district.

- 1. A letter of intent that includes:
 - a. Contact information for the applicant;
 - b. The position sought (Resident-Parent, Business, or Teacher);
 - c. An explanation of how the applicant meets the requirements for the position; and
 - d. Three potential references; and
- 2. A resume detailing the applicant's work experience and education history.

Selected citizen members will be expected to attend and participate in all task force meetings and will receive mileage and a per diem for each meeting attended.
