

A RESOLUTION adjourning the House of Representatives in honor and loving memory of Menifee County Judge/Executive James Darrell "J.D." Trimble.

WHEREAS, Judge Trimble was born in Frenchburg on September 3, 1944, the beloved son of the late Henry and Carma Trimble; and

WHEREAS, Judge Trimble was a graduate of Morehead State University. He worked in the Menifee County School System for 30 years as a teacher, principal, girls' basketball coach, athletic director, and bus driver. After retiring in 1994, he worked for the Frenchburg Job Corps; and

WHEREAS, Judge Trimble served as the Menifee County Judge/Executive from 2003 to 2006 and from 2010 to 2014, and was Judge Elect in January 2015; and

WHEREAS, in September 2014, Judge Trimble was recognized by the United States House of Representatives for his efforts to better the Menifee County community. The House acknowledged Judge Trimble's attempts to reduce the county's debt, his implementation of a new 911 system, and the development of a new Senior Citizens Center; and

WHEREAS, Judge Trimble was a member of the Frenchburg/Menifee County Chamber of Commerce, the Kentucky Colonels, the Cattlemen's Association, the Beef Producers, the Shiftmasters Car Club, and the Menifee County Retired Teachers; and

WHEREAS, Judge Trimble was a proud member of the Frenchburg Baptist Church, where he served as a deacon and adult Sunday school teacher and conducted Wednesday night prayer service; and

WHEREAS, Judge Trimble departed this earthly life and entered the gates of Heaven on January 21, 2015, leaving his family, friends, and all those whose lives he had touched as an educator, coach, and public official in solemn mourning; and

WHEREAS, Judge Trimble was preceded in death by his parents and his granddaughter, Katie Miller. He is survived by his cherished wife of 49 years, Lucille Coldiron Trimble; his daughter, Jami Miller and her husband, Brian; his son, Jimmy

Trimble and his wife, Natasha; his grandchildren, Travis Trimble and Kyle and Bryce Miller; and his sister, Margret Issac and her husband, Robert;
