

A RESOLUTION recognizing and honoring the many 4-H members who are focusing on civic engagement and public policy by participating in the Kentucky 4-H: A Capitol Experience.

WHEREAS, hundreds of 4-H students are converging on the State Capital this week to take part in multiple educational activities aimed at enhancing their understanding of the legislative process and history of this great Commonwealth; and

WHEREAS, while in the seat of state government, the 4-H members will have the opportunity see their government in action, they will visit with legislators, attend committee meetings, and, in turn, will make this General Assembly more aware of the importance of Kentucky's 4-H program; and

WHEREAS, Kentucky 4-H: A Capitol Experience has the support of a number of organizations, the 4-H Youth Development Program, the Cooperative Extension Service, the land-grant universities, the University of Kentucky and Kentucky State University, and Kentucky's Touchstone Energy Cooperatives, the presenting sponsor; and

WHEREAS, 4-H in Kentucky has a long and rich history beginning in the early 1900s when farm youth in the state were given the opportunity to try new practices on a small portion of the family farm; and

WHEREAS, the 4-H Youth Development Program sponsors 4-H clubs in both rural and urban areas of Kentucky, reaching more than 256,345 youth from ages 5 to 19; and

WHEREAS, 4-H offers diverse programs that include agriculture, workforce development, science, engineering, technology, and practical life skills. In short, the program contributes to the development of well-rounded youth and future leaders of this great Commonwealth; and

WHEREAS, 19,400 adult citizens contribute to the success of the program, volunteering in endeavors aimed at enhancing the skills of these young people; and

WHEREAS, the 2015, Kentucky state 4-H officers represent areas across the state: Jordan Stone, State President, Lyon County; Haley Coppage, State Vice President, Ohio

County; Breanna Howell, State Secretary, Lawrence County; and Julia Scott, State Treasurer, Hart County;

NOW, THEREFORE,

*Be it resolved by the House of Representatives of the General Assembly of the Commonwealth of Kentucky:*

➔Section 1.
