SUMMARY OF LEGISLATION: Amend KRS 311.1911 to extend the coverage of the Uniform Anatomical Gift Act to a fetus that was the subject of an induced abortion. STATE IMPACT: Class A, B & C felonies are based on an average daily prison rate of \$61.09. Most Class D felons are housed in one of 78 full service jails for up to 5 years. DOC's cost to incarcerate a felony inmate in a jail is \$31.92 per day (includes jail per diem, medical & central office costs), not including substance abuse treatment. Projections are based on the daily rate x 365 x number of years. NONE MINIMAL MODERATE SIGNIFICANT **Projected Impact: Potential Cost:** The proposed legislation changes several class D felonies related to Abortion making the charges Class C felonies. Under those statues, the Department of Corrections currently has no one incarcerated. Records show that only 2 people have ever been convicted under those statues. One case was probated and the other served out of prison in 2006. The proposed legislation creates a Class C felony for any person who sells or makes charge for all or part of a fetus that was the subject of an induced abortion. As this is a new crime the it is impossible to tell how large an impact this would have. However the impact is expected to be small. A Class C Felony sentence is 5 to 10 years. 1 Class C Felon costs Ky. \$111,489 to \$222,979. 10 Class C Felons cost \$1.1M to \$2.2M. 100 Class C Felons cost \$11M to \$22M. LOCAL IMPACT: Local governments are responsible for the cost of incarcerating individuals charged with Class A or B misdemeanors and felony defendants until disposition of the case. While the expense varies by jail, this estimated impact will be based on \$31.34 per day, which equals the per diem and medical that DOC pays jails to house felony offenders. Projected Impact: NONE □MINIMAL MODERATE SIGNIFICANT Creates no new misdemeanor offenses.
