SUBJECT: .AN ACT relating to shock probation.

SUMMARY OF LEGISLATION: Amend KRS 439.265 to prohibit shock probation if a person is convicted of violating KRS 507.040, relating to manslaughter in the second degree, or KRS 507.050, relating to reckless homicide, and a violation of KRS 189A.010, relating to driving under the influence, arising from the same incident.

STATE IMPACT: Class A, B & C felonies are based on an average daily prison rate of \$61.09. Most Class D felons are housed in one of 78 full service jails for up to 5 years. DOC's cost to incarcerate a felony inmate in a jail is \$31.92 per day (includes jail per diem, medical & central office costs), not including substance abuse treatment. Projections are based on the daily rate x 365 x number of years.

Projected Impact: NONE MINIMAL MODERATE SIGNIFICANT

Potential Impact: Section Prohibits shock probation for defendants convicted of DUI in combination with manslaughter second degree or reckless homicide. Data reflects a total of 6 inmates serving on Manslaughter II or Reckless Homicide have been released on shock probation in 2015. However it should be noted that only 4 of those convicted of Reckless Homicide or Manslaughter II had an accompanying DUI Conviction. While there is no way to estimate the number of individuals who will be affected by this bill, it is expected to have minimal impact on Department of Corrections.

LOCAL IMPACT: Local governments are responsible for the cost of incarcerating individuals charged with Class A or B misdemeanors and felony defendants until disposition of the case. While the expense varies by jail, this estimated impact will be based on \$31.34 per day, which equals the per diem and medical that DOC pays jails to house felony offenders.
