

At the same time that copies of the budget of a school district are filed with the clerk of the tax levying authority for the district, as provided in Section 1 of this Act[KRS 160.470], the board of education of the district shall cause the budget to be advertised for the district by publishing a copy of the budget in a newspaper and on the district's website."; and

Renumber the subsequent section accordingly.






