

1 AN ACT relating to crimes and punishments and making an appropriation therefor.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 453.190 is amended to read as follows:

- 4 (1) A court shall allow a poor person residing in this state to file or defend any action or
5 appeal therein without paying costs, whereupon he shall have any counsel that the
6 court assigns him and shall have from all officers all needful services and process,
7 including the preparation of necessary transcripts for appeal, without any fees,
8 except such as are included in the costs recovered from the adverse party, and shall
9 not be required to post any bond except in an amount and manner reasonable under
10 the circumstances of his poverty.
- 11 (2) A "poor person" means a person who ***has an income at or below one hundred***
12 ***percent (100%) on the sliding scale of indigency established by the Supreme***
13 ***Court of Kentucky by rule or*** is unable to pay the costs and fees of the proceeding
14 in which he is involved without depriving himself or his dependents of the
15 necessities of life, including food, shelter, or clothing.
- 16 (3) Application to proceed without payment of costs and fees, pursuant to subsection
17 (1) herein, shall be made by motion supported by the affidavit of the applicant
18 stating the reasons that he is unable to pay the costs and fees or give security
19 therefor.
- 20 (4) No inmate shall be automatically allowed to proceed through the courts in forma
21 pauperis by virtue of his status as an inmate, nor shall his incarceration lead to a
22 presumption of impoverishment, or constitute evidence of a rebuttable presumption
23 of impoverishment.
- 24 (5) A court may consider the value of all of the benefits an inmate receives by virtue of
25 his incarceration and for which the inmate has not monetarily reimbursed the
26 Commonwealth, including, among other things, the value of his room, board,
27 medical care, dental care, recreational programming, educational opportunities

1 offered to the inmate, legal services provided to the inmate without cost, clothing,
 2 laundry, guard protection services, or any other benefit similarly conferred upon the
 3 inmate.

4 ➔Section 2. KRS 23A.205 is amended to read as follows:

- 5 (1) Court costs for a criminal case in the Circuit Court shall be one hundred dollars
 6 (\$100).
- 7 (2) The taxation of court costs against a defendant, upon conviction in a case, shall be
 8 mandatory and shall not be subject to probation, suspension, proration, deduction,
 9 or other form of nonimposition in the terms of a plea bargain or otherwise, unless
 10 the court finds that the defendant is a poor person as defined by KRS 453.190(2)
 11 and that he or she is unable to pay court costs and will be unable to pay the court
 12 costs in the foreseeable future.
- 13 (3) If the court finds that the defendant does not meet the standard articulated in
 14 subsection (2) of this section and that the defendant is nonetheless unable to pay the
 15 full amount of the court costs, ~~and~~ fees, or fines at the time of sentencing, then the
 16 court ~~shall establish a show cause date by which time the court costs, fees, and~~
 17 ~~finer shall be paid and~~ may establish an installment payment plan in accordance
 18 with Section 4 of this Act ~~whereby the defendant pays the full amount of the court~~

25 ➔Section 3. KRS 24A.175 is amended to read as follows:

- 26 (1) Court costs for a criminal case in the District Court shall be one hundred dollars
 27 (\$100), regardless of whether the offense is one for which prepayment is permitted.

- 1 (2) There shall be no court costs for a parking citation when:
- 2 (a) The fine is paid to the clerk before the trial date in the same manner as
- 3 provided for speeding citations under KRS 189.394(3); and
- 4 (b) The citation does not involve parking in a fire lane or blocking the traveled
- 5 portion of the highway.
- 6 (3) The taxation of court costs against a defendant, upon conviction in a case, including
- 7 persons sentenced to state traffic school as provided under KRS 186.574, shall be
- 8 mandatory and shall not be subject to probation, suspension, proration, deduction,
- 9 or other form of nonimposition in the terms of a plea bargain or otherwise, unless
- 10 the court finds that the defendant is a poor person as defined by KRS 453.190(2)
- 11 and that he or she is unable to pay court costs and will be unable to pay the court
- 12 costs in the foreseeable future.
- 13 (4) If the court finds that the defendant does not meet the standard articulated in
- 14 subsection (3) of this section and that the defendant is nonetheless unable to pay the
- 15 full amount of the court costs, fees, ~~or~~~~and~~ fines at the time of sentencing, then the
- 16 court ~~shall establish a show cause date by which time court costs, fees, and fines~~

- 25 (5) Notwithstanding any other provision to the contrary, the court shall not adjudicate a
- 26 traffic violation involving a defendant who is under the age of eighteen (18), unless
- 27 the person that assumed liability of the minor under the provisions of KRS 186.590

1 is present. This subsection shall not apply to emancipated minors.

2 ➔Section 4. KRS 534.020 is amended to read as follows:

3 (1) When a defendant is sentenced to pay **court costs, fees, or fines**~~[a fine]~~, the court
4 may provide for payment to be made within a specified period of time or in
5 specified installments. If no such provision is made a part of the sentence, then the
6 **court costs, fees, or fines**~~[fine]~~ shall be payable forthwith.

7 (2) **If the court establishes an installment payment plan for a defendant to pay the**
8 **full amount of court costs, fees, or fines:**

9 (a) **The defendant shall be given notice of the total amount due, the payment**
10 **frequency, and the date by which all payments must be made. The notice**
11 **shall indicate that if the defendant has not complied with the installment**
12 **payment plan by the scheduled date, he or she shall appear on that date to**
13 **show good cause as to why he or she is unable to satisfy the obligations.**
14 **This notice shall be given to the defendant in writing on a form provided by**
15 **the Administrative Office of the Courts;**

16 (b) **Except as provided in subsection (3) of this section, all court costs, fees, and**
17 **fees shall be paid within one (1) year of the date of sentencing**
18 **notwithstanding any remaining restitution or other monetary penalty owed**
19 **by the defendant and arising out of the conviction; and**

20 (c) **Installment payments shall be applied first to court costs, then to restitution,**
21 **then to fees, and then to fines.**

22 (3) (a) **If a defendant is required to appear at a show cause hearing pursuant to**
23 **subsection (2)(a) of this section, the court shall determine whether the**
24 **defendant's default in payment of court costs, fees, or fines is:**

25 **1. Excusable due to an inability to pay, and if so, the court may enter an**
26 **order allowing additional time for payment, reducing the amount of**
27 **each installment, or modifying the manner of payment in any other**

1 way; or

2 2. Willful and not due to an inability to pay, and if so, the court may
 3 order the defendant to jail on the condition that the defendant shall be
 4 released upon payment or completion of daily credit pursuant to
 5 Section 6 of this Act.

6 (b) If the defendant fails to appear at the show cause hearing, the court may
 7 issue a warrant for the defendant's arrest. Any warrant for arrest issued for
 8 nonpayment of court costs, fees, or fines pursuant to this subsection shall
 9 include a notice to the jailer that the defendant shall be released upon
 10 payment or completion of daily credit pursuant to Section 6 of this Act.

11 (4) When a defendant is sentenced to pay court costs, fees, or fines~~[a fine]~~, an
 12 alternative sentence of imprisonment that is to be served in the event the court
 13 costs, fees, or fines are~~[fine is]~~ not paid shall not be imposed at the same time. The
 14 response of a court to nonpayment~~[of a fine]~~ shall be determined only after:

15 (a) The court costs, fees, or fines have~~[fine has]~~ not been paid; and~~[,]~~

16 (b) 1. The show cause hearing has been held pursuant to subsections (2)(a)
 17 and (3)(a) of this section; or

18 2. The defendant has failed to appear at the show cause hearing as
 19 outlined in subsection (3)(b) of this section~~[and as provided in KRS~~
 20 ~~24A.175 or 534.060].~~

21 (5) Court costs, fees, or fines being paid under an installment payment plan that is
 22 actively monitored by the court shall not be reported as part of the inventory of
 23 liquidated debt pursuant to KRS 45.241.

24 ➔Section 5. KRS 534.060 is amended to read as follows:

25 ~~[(1) When an individual sentenced to pay a fine defaults in the payment of the fine or~~
 26 ~~any installment, the court upon motion of the prosecuting attorney or upon its own~~
 27 ~~motion may require him to show cause why he should not be imprisoned for~~

1 ~~nonpayment. The court may issue a warrant of arrest or a summons for his~~
 2 ~~appearance.~~

3 ~~(2) Following an order to show cause under subsection (1) of this section, unless the~~
 4 ~~defendant shows that his default was not attributable to an intentional refusal to~~
 5 ~~obey the sentence of the court and not attributable to a failure on his part to make a~~
 6 ~~good faith effort to obtain the necessary funds for payment, the court may order the~~
 7 ~~defendant imprisoned for a term not to exceed:~~

8 ~~(a) Six (6) months, if the fine was imposed for the conviction of a felony; or~~

9 ~~(b) One third (1/3) of the maximum authorized term of imprisonment for the~~
 10 ~~offense committed, if the fine was imposed for conviction of a misdemeanor;~~

 16 ~~modifying the manner of payment in any other way.~~

17 ~~(4) When a fine is imposed on a corporation, it is the duty of the person or persons~~
 18 ~~authorized to make disbursement of the assets of the corporation and their superiors to~~
 19 ~~pay the fine from assets of the corporation. The failure of such persons to do so shall~~
 20 ~~render them subject to imprisonment under subsections (1) and (2) of this section.~~

21 ~~[(5) Following a default in the payment of a fine or any installment thereof, the fine may~~
 22 ~~be collected by any means authorized for the enforcement of money judgments~~
 23 ~~rendered in favor of the Commonwealth.]~~

24 ➔ Section 6. KRS 534.070 is amended to read as follows:

25 (1) A defendant who has been sentenced to jail for failure to pay ~~{a fine or }~~ court costs,
 26 fees, or fines or for failure to appear in court on a date set for the sole purpose of
 27 addressing nonpayment of ~~{a fine or }~~ court costs, fees, or fines shall receive credit

1 against the ~~court~~~~[fine and]~~ costs, fees, or fines owed for each day the defendant
2 spends in jail at the following rates:

3 (a) Fifty dollars (\$50) per day if the defendant does not work at a community
4 service or community labor program; or

5 (b) One hundred dollars (\$100) per day if the defendant works eight (8) hours per
6 day at a community service or community labor program. If the defendant
7 works less than eight (8) hours in a community service or community labor
8 program, the defendant shall be allowed an amount of one-eighth (1/8) of the
9 one hundred dollars (\$100) for each hour worked in a community service or
10 community labor program.

11 (2) Credit against~~[a fine or]~~ court costs, fees, or fines earned by a defendant pursuant
12 to this section shall prohibit the collection of any part of ~~court~~~~[a fine or]~~ costs, fees,
13 or fines which has been credited pursuant to this section, and that portion of the
14 ~~court~~~~[fine or]~~ costs, fees, or fines shall be considered paid.

15 (3) (a) The jailer shall be responsible for monitoring a defendant's community service
16 and tracking the number of days to be served to pay any outstanding~~[fine or]~~
17 court costs, fees, or fines.

18 (b) Unless the defendant is incarcerated pursuant to orders in other cases, upon
19 the service of sufficient days in jail to have sufficient credit to satisfy the
20 court costs, fees, or fines, the defendant shall be released from jail.

21 (4) If a partial payment is made by the defendant or on behalf of a defendant, that
22 payment shall be applied first to court costs, then to fees, and then to fines pursuant
23 to Section 4 of this Act~~[KRS 23A.205 or 24A.175]~~ prior to the application of any
24 credit earned pursuant to this section. Credit earned pursuant to this section shall
25 not be applied to restitution.

26 ➔Section 7. KRS 45.237 is amended to read as follows:

27 (1) As used in KRS 45.237 to 45.239:

- 1 (a) "Agency" means an organizational unit or administrative body in the
2 executive branch of state government as defined in KRS 12.010;
- 3 (b) "Cabinet" means the Finance and Administration Cabinet;
- 4 (c) "Court of Justice" means the Administrative Office of the Courts, all courts,
5 and all clerks of the courts;
- 6 (d) "Debt" means:
- 7 1. For agencies, a sum certain which has been certified as due and owing;
- 8 2. For local governments, a sum certain which has been certified as due
9 and owing, including but not limited to any delinquent taxes or fees
10 other than delinquent real and personal property taxes; and
- 11 3. For the Court of Justice, a legal debt, including any fine, fee, court costs,
12 or restitution due the Commonwealth, which have been imposed by a
13 final sentence of a trial court of the Commonwealth and for which the
14 time permitted for payment pursuant to Section 4 of this Act~~[KRS~~
15 ~~23A.205(3) or 24A.175(4)]~~ has expired;
- 16 (e) "Department" means the Department of Revenue;
- 17 (f) "Improper payment" means a payment made to a vendor, provider, or recipient
18 due to error, fraud, or abuse; and
- 19 (g) "Local government" means any city, county, urban-county government,
20 consolidated local government, charter county government, or unified local
21 government of the Commonwealth.
- 22 (2) The cabinet shall develop for the executive branch of state government a system of
23 internal controls and preaudit policies and procedures applicable to disbursement
24 transactions for the purpose of prevention and detection of errors or fraud and abuse
25 prior to the issuance of a check or warrant. The initial policies and procedures shall
26 focus first on programs or activities that expend the most federal and general fund
27 dollars. The cabinet shall develop preaudit procedures that meet the unique needs of

1 each agency.

2 (3) In establishing these systems of internal control and preaudit policies and
3 procedures, the cabinet shall:

4 (a) Consult with each agency within the executive branch to ascertain its unique
5 fraud risks;

6 (b) Establish policies and procedures for agency-level oversight of fraud risks,
7 including risk assessment, risk tolerance, and management policies, and fraud-
8 prevention processing controls;

9 (c) Establish systems and procedures for detecting both unintentional errors and
10 fraudulent misrepresentations that may have occurred in vendor invoices
11 submitted for payment, applications submitted for benefits, claims for refunds
12 of amounts previously paid or withheld, and other disbursements;

13 (d) Establish systems and procedures for preventing and detecting unintentional
14 errors and the fraudulent disbursement of funds by state government
15 employees in the processing, approving, and paying of invoices, refunds,
16 vouchers, benefit payments, and other disbursements; and

17 (e) Consult with the state Auditor of Public Accounts, the Commonwealth Office
18 of Technology, the American Institute of Certified Public Accountants, the
19 Association of Certified Fraud Examiners, law enforcement agencies, or any
20 other entity with knowledge and expertise in the detection and prevention of
21 fraud.

22 (4) Each agency shall diligently attempt to collect amounts paid to a vendor, provider,
23 or recipient due to error, fraud, or abuse for sixty (60) days after the improper
24 payment is discovered. If the improper payment has not been recovered after sixty
25 (60) days, the agency shall certify the improper payment as a debt of the agency and
26 shall refer all certified debts to the department.

27 (5) A local government may, after making reasonable efforts to collect its debts, by

1 ordinance, resolution, or otherwise pursuant to law, certify its debts that have been
2 due and owing for more than ninety (90) days to the department for collection. The
3 department may, by administrative regulation promulgated in accordance with KRS
4 Chapter 13A, prescribe the form and format of, and the information required in,
5 referrals by a local government, which may be required to be made electronically.

6 (6) Any funds recovered by an agency within the sixty (60) day collection period
7 allowed under subsection (4) of this section and prior to referral to the department
8 shall be allocated to the fund from which the improper payment was expended.

9 (7) Each agency shall submit annual summaries of debts due to error, fraud, or abuse,
10 improper payments discovered, and certified debts referred to the department to the
11 Legislative Research Commission. These summaries shall include but not be
12 limited to:

13 (a) Debts owed the Commonwealth that have been identified by the agency, in
14 accordance with the preaudit procedures established under this section, as
15 those resulting from error, fraud, or abuse, of either the payee or the state
16 agency;

17 (b) The aggregate amount of money collected by the agency on those debts during
18 the sixty (60) day period allowed under subsection (4) of this section; and

19 (c) The aggregate amount of certified debts that the agency referred to the
20 department.

21 (8) Each agency shall provide information about each debt due to error, fraud, or abuse
22 that is certified under this section to the State Treasurer for the Treasurer's action
23 under KRS 44.030(1).

24 (9) Each local government shall, where feasible, provide information about each debt
25 that is certified pursuant to this section to the State Treasurer for the Treasurer's
26 action under KRS 44.030(1).

27 ➔Section 8. KRS 45.241 is amended to read as follows:

- 1 (1) As used in this section:
- 2 (a) "Debt" means:
- 3 1. For agencies, a sum certain which has been certified by an agency as due
- 4 and owing; and
- 5 2. For local governments, a sum certain which has been certified by a local
- 6 government as due and owing, including but not limited to any
- 7 delinquent taxes or fees other than delinquent real and personal property
- 8 taxes;
- 9 (b) "Liquidated debt" means:
- 10 1. For agencies, a legal debt for a sum certain which has been certified by
- 11 an agency as final due and owing, all appeals and legal actions having
- 12 been exhausted;
- 13 2. For local governments, a legal debt for a sum certain which has been
- 14 certified by a local government as final due and owing, all appeals and
- 15 legal actions having been exhausted, including but not limited to any
- 16 delinquent taxes or fees other than delinquent real and personal property
- 17 taxes; and
- 18 3. For the Court of Justice, a legal debt including any fine, fee, court costs,
- 19 or restitution due the Commonwealth, which have been imposed by a
- 20 final sentence of a trial court of the Commonwealth and for which the
- 21 time permitted for payment pursuant to the provisions of Section 4 of
- 22 this Act~~[KRS 23A.205(3) or 24A.175(4)]~~ has expired;
- 23 (c) "Agency" means an organizational unit or administrative body in the
- 24 executive branch of state government, as defined in KRS 12.010;
- 25 (d) "Department" means the Department of Revenue;
- 26 (e) "Court of Justice" means the Administrative Office of the Courts, all courts,
- 27 and all clerks of the courts;

- 1 (f) "Forgivable loan agreement" means a loan agreement entered into between an
2 agency and a borrower that establishes specific conditions, which, if satisfied
3 by the borrower, allows the agency to forgive a portion or all of the loan;
- 4 (g) "Improper payment" means a payment made to a vendor, provider, or recipient
5 due to error, fraud, or abuse; and
- 6 (h) "Local government" means any city, county, urban-county government,
7 consolidated local government, charter county, or unified local government of
8 the Commonwealth.
- 9 (2) Each agency and the Court of Justice shall develop, maintain, and update in a timely
10 manner an ongoing inventory of each debt owed to it, including debts due to
11 improper payments, and shall make every reasonable effort to collect each debt.
12 Within sixty (60) days after the identification of a debt, each agency shall begin
13 administrative action to collect the debt.
- 14 (3) The Auditor of Public Accounts shall review each agency's debt identification and
15 collection procedures as part of the annual audit of state agencies.
- 16 (4) An agency shall not forgive any debt owed to it unless that agency has entered into a
17 forgivable loan agreement with a borrower, or unless otherwise provided by statute.
- 18 (5) For those agencies without statutory procedures for collecting debts, the Department
19 of Revenue shall promulgate administrative regulations in accordance with KRS
20 Chapter 13A to prescribe standards and procedures with which those agencies shall
21 comply regarding collection of debts, notices to persons owing debt, information to
22 be monitored concerning the debts, and an appeals process.
- 23 (6) (a) Each agency and the Court of Justice shall identify all liquidated debts,
24 including debts due to improper payments, and shall submit a list of those
25 liquidated debts in the form and manner prescribed by the department to the
26 department for review. The department shall review the information submitted
27 by the agencies and the Court of Justice and shall, within ninety (90) days of

1 receipt of the information, determine whether it would be cost-effective for
2 the department to further pursue collection of the liquidated debts.

3 (b) A local government, after making reasonable efforts to collect its debts, may
4 by ordinance, resolution, or otherwise pursuant to law, submit a list of its
5 liquidated debts that have been due and owing for more than ninety (90) days
6 to the department for review to determine whether it would be cost-effective
7 for the department to pursue collection of the liquidated debts. The
8 department shall review the information submitted by a local government and
9 shall, within ninety (90) days of receipt of the information, determine whether
10 it would be cost-effective for the department to further pursue collection of the
11 liquidated debts.

12 (c) The department may, after consultation with the agency, Court of Justice, or a
13 local government, return the liquidated debt to the entity submitting the
14 liquidated debt if:

- 15 1. The request for review contains insufficient information; or
- 16 2. The debt is not feasible to collect.

17 Any return of a liquidated debt shall be in writing, and shall state why the debt
18 is being returned.

19 (d) The department shall identify in writing to the submitting agency, Court of
20 Justice, or local government, the liquidated debts it has determined that it can
21 pursue in a cost-effective manner, and the agency, Court of Justice, or local
22 government shall officially refer the identified liquidated debts to the
23 department for collection.

24 (e) The agency, Court of Justice, and local government shall retain a complete
25 record of all liquidated debts referred to the department for collection until the
26 debt is collected, forgiven, or returned as uncollectible.

27 (f) Each agency, the Court of Justice, and local government shall make

1 appropriate accounting of any uncollected debt as prescribed by law.

2 (7) (a) If the agency recovers the debt funds prior to referral to the department, the
3 agency shall retain the collected funds in accordance with its statutory
4 authority.

5 (b) 1. Upon referral of a liquidated debt to the department, the liquidated debt
6 shall accrue the following amounts:

7 a. Interest on the total amount of the debt plus legal accruals at the
8 tax interest rate provided in KRS 131.183, from the time of referral
9 until paid; and

10 b. A one (1) time twenty-five percent (25%) collection fee on the
11 total amount of the debt plus legal accruals, as of the time of
12 referral;

13 unless the interest and collection fee are waived by the department.

14 2. The interest and collection fee shall be in addition to any other costs
15 accrued prior to the time of referral.

16 3. The department may deduct and retain from the liquidated debt
17 recovered an amount equal to the lesser of the collection fee or the
18 actual expenses incurred in the collection of the debt.

19 4. In the case of agencies and the Court of Justice, any funds recovered by
20 the department after the deduction of the department's cost of collection
21 expenses may, at the discretion of the secretary of the Finance and
22 Administration Cabinet, be returned to the agency identifying the
23 liquidated debt or to the Court of Justice for allocation as otherwise
24 provided by law. If the recovered funds and interest are not returned to
25 the agency or Court of Justice, the amounts shall be deposited in the
26 general fund, except for Medicaid benefits funds and funds required by
27 law to be remitted to a federal agency, which shall be remitted as

1 required by law.

2 5. In the case of local governments, any funds recovered by the department
3 after the deduction of the department's cost of collection expenses shall
4 be returned to the local government referring the liquidated debt, for
5 allocation as provided by ordinance, resolution, or as otherwise provided
6 by law.

7 (c) Nothing in this section shall prohibit the department from entering into a
8 memorandum of agreement with an agency pursuant to KRS 131.130(11), for
9 collection of debts prior to liquidation. If an agency enters into an agreement
10 with the department, the agency shall retain funds collected according to the
11 provisions of the agreement.

12 (d) This section shall not affect any agreement between the department and an
13 agency entered into under KRS 131.130(11) that is in effect on July 13, 2004,
14 that provides for the collection of liquidated debts by the department on behalf
15 of the agency.

16 (e) This section shall not affect the collection of delinquent taxes by sheriffs or
17 county attorneys under KRS 91A.070 or 134.504.

18 (f) This section shall not affect the collection of performance or reclamation
19 bonds.

20 (8) Upon receipt of a referred liquidated debt and after its determination that the debt is

 20 by the officer. The failure of the supervised individual to comply with a sanction
 21 shall constitute a violation of community supervision.

22 (4) If the supervised individual objects to the imposition of the sanction or sanctions,
 23 then:

24 (a) If the supervised individual is serving a period of parole or post-release
 25 supervision from prison or jail, then the administrative process promulgated
 26 under KRS 439.3107(3) shall apply; or

27 (b) If the supervised individual is on probation, then the provisions of KRS

1 533.050 shall apply.

2 (5) If the graduated sanction involves confinement in a correctional or detention
3 facility, confinement shall be approved by the probation and parole district
4 supervisor, but the supervised individual may be taken into custody for up to four
5 (4) hours while such approval is obtained. If the supervised individual is employed,
6 the probation and parole officer shall, to the extent feasible, impose this sanction on
7 weekend days or other days and times when the supervised individual is not
8 working.

9 (6) A sanction that confines a supervised individual in a correctional or detention
10 facility for a period of more than ten (10) consecutive days, or extends the term of
11 community supervision, shall not be imposed as a graduated sanction, except
12 pursuant to an order of the court or the board.

13 (7) Upon successful completion of a graduated sanction or sanctions, a court may not
14 revoke the term of community supervision or impose additional sanctions for the
15 same violation.

16 (8) If a probation and parole officer modifies the conditions of community supervision
17 by imposing a graduated sanction, the officer shall:

18 (a) Deliver a copy of the modified conditions to the supervised individual;

19 (b) File a copy of the modified conditions with the sentencing court or releasing
20 authority; and

21 (c) Note the date of delivery of the copy in the supervised individual's file or case
22 management system.

23 ➔Section 15. KRS 439.3406 is amended to read as follows:

24 (1) The board shall order mandatory reentry supervision six (6) months prior to the
25 projected completion date of an inmate's sentence for an inmate who has not been
26 granted discretionary parole.

27 (2) The provisions of subsection (1) of this section shall not apply to an inmate who:

- 1 (a) Is not eligible for parole by statute;
- 2 (b) Has been convicted of a capital offense or a Class A felony;
- 3 (c) Has a maximum or close security classification as defined by administrative
4 regulations promulgated by the department;
- 5 (d) Has been sentenced to two (2) years or less of incarceration;
- 6 (e) Is subject to the provisions of KRS 532.043;~~or~~
- 7 (f) Has six (6) months or less to be served after his or her sentencing by a court or
8 recommitment to prison for a violation of probation, shock probation, parole,
9 or conditional discharge;
- 10 **(g) If recommitted to prison for a violation of probation, shock probation,**
11 **parole, or conditional discharge, has not served at least six (6) months since**

- 13 **(h) Has twice been released on mandatory reentry supervision.**
- 14 (3) An inmate granted mandatory reentry supervision pursuant to this section may be
15 returned by the board to prison for violation of the conditions of supervision and
16 shall not again be eligible for mandatory reentry supervision during the same period
17 of incarceration.
- 18 (4) An inmate released to mandatory reentry supervision shall be considered to be
19 released on parole.
- 20 (5) Mandatory reentry supervision is not a commutation of sentence or any other form
21 of clemency.
- 22 (6) No hearing shall be required for the board to order an inmate to mandatory reentry
23 supervision pursuant to subsection (1) of this section. Terms of supervision for
24 inmates released on mandatory reentry supervision shall be established as follows:
- 25 (a) The board shall adopt administrative regulations establishing general
26 conditions applicable to each inmate ordered to mandatory reentry supervision
27 pursuant to subsection (1) of this section. If an inmate is ordered to mandatory

1 reentry supervision, the board's order shall set forth the general conditions and
2 shall require the inmate to comply with the general conditions and any
3 requirements imposed by the department in accordance with this section;

4 (b) Upon intake of an inmate ordered to mandatory reentry supervision by the
5 board, the department shall use the results of the risk and needs assessment
6 administered pursuant to KRS 439.3104(1) to establish appropriate terms and
7 conditions of supervision, taking into consideration the level of risk to public
8 safety, criminal risk factors, and the need for treatment and other
9 interventions. The terms and conditions imposed by the department under this
10 paragraph shall not conflict with the general conditions adopted by the board
11 pursuant to paragraph (a) of this subsection; and

12 (c) The powers and duties assigned to the commissioner in relation to probation
13 or parole under KRS 439.470 shall be assigned to the commissioner in
14 relation to mandatory reentry supervision.

15 (7) Subject to subsection (3) of this section, the period of mandatory reentry
16 supervision shall conclude upon completion of the individual's minimum expiration
17 of sentence.

18 (8) If the board issues a warrant for the arrest of an inmate for absconding from
19 supervision during the mandatory reentry supervision period, and the inmate is
20 subsequently returned to prison as a violator of conditions of supervision for
21 absconding, the inmate shall not receive credit toward the remainder of his or her
22 sentence for the time spent absconding.

23 (9) The department shall report the results of the mandatory reentry supervision
24 program to the Interim Joint Committee on Judiciary by February 1, 2015.

25 ➔Section 16. KRS 17.510 is amended to read as follows:

26 (1) The cabinet shall develop and implement a registration system for registrants which
27 includes creating a new computerized information file to be accessed through the

1 Law Information Network of Kentucky.

2 (2) A registrant shall, on or before the date of his or her release by the court, the parole
3 board, the cabinet, or any detention facility, register with the appropriate local
4 probation and parole office in the county in which he or she intends to reside. The
5 person in charge of the release shall facilitate the registration process.

6 (3) Any person required to register pursuant to subsection (2) of this section shall be
7 informed of the duty to register by the court at the time of sentencing if the court
8 grants probation or conditional discharge or does not impose a penalty of
9 incarceration, or if incarcerated, by the official in charge of the place of confinement
10 upon release. The court and the official shall require the person to read and sign any
11 form that may be required by the cabinet, stating that the duty of the person to
12 register has been explained to the person. The court and the official in charge of the
13 place of confinement shall require the releasee to complete the acknowledgment
14 form and the court or the official shall retain the original completed form. The
15 official shall then send the form to the Information Services Center, Department of
16 Kentucky State Police, Frankfort, Kentucky 40601.

18 probation and parole office which shall obtain the person's fingerprints, DNA
19 sample, and photograph. Thereafter, the registrant shall return to the appropriate
20 local probation and parole office not less than one (1) time every two (2) years in
21 order for a new photograph to be obtained, and the registrant shall pay the cost of
22 updating the photo for registration purposes. Any registrant who has not provided a
23 DNA sample as of July 1, 2009, shall provide a DNA sample to the appropriate
24 local probation and parole office when the registrant appears for a new photograph
25 to be obtained. Failure to comply with this requirement shall be punished as set

27 (5) (a) The appropriate probation and parole office shall send the registration form

17 been convicted in a court of any state or territory, a court of the United States,
18 or a similar conviction from a court of competent jurisdiction in any other
19 country, or a court martial of the United States Armed Forces of a sex crime
20 or criminal offense against a victim who is a minor and who has been notified
21 of the duty to register by that state, territory, or court, or who has been
22 committed as a sexually violent predator under the laws of another state, laws
23 of a territory, or federal laws, or has a similar conviction from a court of
24 competent jurisdiction in any other country, shall comply with the registration
25 requirement of this section, including the requirements of subsection (4) of

1 No additional notice of the duty to register shall be required of any official

3 **(b) No person shall be required to register under this subsection for a juvenile**
4 **adjudication if such an adjudication in this Commonwealth would not**
5 **create a duty to register. This paragraph shall be retroactive.**

6 (7) **(a) Except as provided in paragraph (b) of this subsection,** if a person is
7 required to register under federal law or the laws of another state or territory,
8 or if the person has been convicted of an offense under the laws of another
9 state or territory that would require registration if committed in this
10 Commonwealth, that person upon changing residence from the other state or
11 territory of the United States to the Commonwealth or upon entering the
12 Commonwealth for employment, to carry on a vocation, or as a student shall
13 comply with the registration requirement of this section, including the
14 requirements of subsection (4) of this section, and shall register within five (5)
15 working days with the appropriate local probation and parole office in the
16 county of residence, employment, vocation, or schooling. A person required to
17 register under federal law or the laws of another state or territory shall be
18 presumed to know of the duty to register in the Commonwealth. As used in
19 this subsection, "employment" or "carry on a vocation" includes employment

22 year, whether financially compensated, volunteered, or for the purpose of

- 3 (8) The registration form shall be a written statement signed by the person which shall
4 include registrant information, including an up-to-date photograph of the registrant

7 not be considered an address.
- 8 (10) (a) If the residence address of any registrant changes, but the registrant remains in
9 the same county, the person shall register, on or before the date of the change
10 of address, with the appropriate local probation and parole office in the county
11 in which he or she resides.
- 12 (b) 1. If the registrant changes his or her residence to a new county, the person
13 shall notify his or her current local probation and parole office of the
14 new residence address on or before the date of the change of address.
- 15 2. The registrant shall also register with the appropriate local probation and
16 parole office in the county of his or her new residence no later than five
17 (5) working days after the date of the change of address.
- 18 (c) If the electronic mail address or any instant messaging, chat, or other Internet
19 communication name identities of any registrant changes, or if the registrant
20 creates or uses any new Internet communication name identities, the registrant
21 shall register the change or new identity, on or before the date of the change or
22 use or creation of the new identity, with the appropriate local probation and
23 parole office in the county in which he or she resides.
- 24 (d) 1. As soon as a probation and parole office learns of the person's new
25 address under paragraph (b)1. of this subsection, that probation and
26 parole office shall notify the appropriate local probation and parole
27 office in the county of the new address of the effective date of the new

1 address.

2 2. As soon as a probation and parole office learns of the person's new
3 address under paragraph (b)2. of this subsection or learns of the
4 registrant's new or changed electronic mail address or instant messaging,
5 chat, or other Internet communication name identities under paragraph
6 (c) of this subsection, that office shall forward this information as set
7 forth under subsection (5) of this section.

8 (11) Any person required to register under this section who knowingly violates any of
9 the provisions of this section or prior law is guilty of a Class D felony for the first
10 offense and a Class C felony for each subsequent offense.

11 (12) Any person required to register under this section or prior law who knowingly
12 provides false, misleading, or incomplete information is guilty of a Class D felony
13 for the first offense and a Class C felony for each subsequent offense.

14 (13) (a) The cabinet shall verify the addresses and the electronic mail address and any
15 instant messaging, chat, or other Internet communication name identities of
16 individuals required to register under this section. Verification shall occur at
17 least once every ninety (90) days for a person required to register under KRS
18 17.520(2) and at least once every calendar year for a person required to
19 register under KRS 17.520(3). If the cabinet determines that a person has
20 moved or has created or changed any electronic mail address or any instant
21 messaging, chat, or other Internet communication name identities used by the
22 person without providing his or her new address, electronic mail address, or
23 instant messaging, chat, or other Internet communication name identity to the

4 ➔SECTION 18. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
5 READ AS FOLLOWS:

6 (1) By March 2018, the department shall implement a reentry drug supervision pilot
7 program with the goal of restoring lives and reducing recidivism through
8 oversight and behavior modification.

9 (2) The reentry drug supervision pilot program shall last four (4) years and shall:

10 (a) Be administered and overseen by a reentry team organized under Section 19
11 of this Act;

12 (b) Be composed of inmates or parolees placed in the pilot program pursuant to
13 Section 20 of this Act;

14 (c) Consist of two (2) phases as outlined in Section 21 of this Act;

15 (d) Provide a continuum of substance use disorder treatments and
16 rehabilitative services;

17 (e) Monitor participants with frequent drug testing;

18 (f) Implement a coordinated strategy to govern the pilot program's responses to
19 participants' compliance;

20 (g) Require ongoing reentry team interaction with each participant; and

21 (h) Forge partnerships among public agencies and community-based

23 (3) The department shall monitor and evaluate the reentry drug supervision pilot
24 program to determine:

25 (a) The number of participants who complete the pilot program;

26 (b) Of the participants who complete the pilot program, the number who later
27 have their parole revoked and for what offense or, if no longer on parole,

1 the number who commit new offenses and a description of those new
2 offenses;

3 (c) The number of participants terminated from the pilot program, the reason
4 for their termination, and how long they participated in the pilot program
5 before termination; and

6 (d) Any savings associated from placing participants in the pilot program
7 versus keeping those participants incarcerated.

8 (4) For a total of seven (7) years, the department shall provide an annual report to
9 the Legislative Research Commission and to the Interim Joint Committee on
10 Judiciary by January 1 of each year the reentry drug supervision pilot program is
11 in operation as well as the following three (3) years. The report shall include the
12 data detailed in subsection (3) of this section.

13 (5) The department may promulgate administrative regulations to implement
14 Sections 17 to 24 of this Act.

15 ➔SECTION 19. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
16 READ AS FOLLOWS:

17 (1) The reentry team shall administer and oversee the reentry drug supervision pilot
18 program. The team shall consist of the following members:

19 (a) A department hearing officer shall lead the reentry team and ensure that
20 due process is followed. If reentry team members disagree on incentives or
21 sanctions, the hearing officer shall be the final decision maker;

22 (b) A parole officer who shall have regular parole officer duties, including drug
23 testing and maintaining records;

24 (c) A reentry liaison or facilitator from the Division of Probation and Parole;

25 (d) A social service clinician;

26 (e) A public defender or his or her designated representative who may or may
27 not be an attorney; and

- 1 (f) A designated representative from a community mental health center who
2 shall provide substance use disorder treatment to participants.
- 3 (2) The Administrative Office of the Courts shall train reentry team members on the
4 philosophy behind drug courts as well as their roles within the team.
- 5 (3) The reentry team may provide incentives, including but not limited to the
6 following:
- 7 (a) Promotion to the next phase as outlined in Section 21 of this Act;
8 (b) Certificates and tokens;
9 (c) Compliance credit or any other parole credit approved by the reentry team;
10 (d) Decreased supervision;
11 (e) Increased privileges and responsibilities;
12 (f) Praise from the hearing officer and reentry team;
13 (g) Extended curfews; and
14 (h) Other individual incentives approved by the reentry team.
- 15 (4) (a) Notwithstanding KRS 439.3108 or 439.340(3)(b) or any other statute to the
16 contrary, only the reentry team may impose sanctions on participants who
17 do not comply with the requirements and conditions established by the
18 reentry team. Notwithstanding KRS 439.3107 or 439.3108 or any other
19 statute to the contrary, sanctions include but are not limited to the
20 following:
- 21 1. Admonishments by the hearing officer;
22 2. Graduated sanctions similar to those adopted by the department
23 pursuant to KRS 439.3107;
24 3. Community service;
25 4. Phase demotion;
26 5. Increased pilot program requirements;
27 6. Electronic monitoring;

- 1 7. Home incarceration;
 2 8. Imprisonment in a state or local correctional or detention facility or
 3 residential center for no more than sixty (60) days in any one (1)
 4 calendar year; and
 5 9. Termination from the pilot program.

6 (b) When considering appropriate sanctions, the reentry team shall consider
 7 alternatives to incarceration.

8 (c) Notwithstanding paragraph (a) of this subsection, a parole officer may
 9 arrest a participant without first consulting the reentry team if the parole
 10 officer believes the participant poses an imminent threat to himself or
 11 herself or to others. The parole officer shall immediately notify the reentry
 12 team of the arrest. Upon receiving notification of the arrest, the reentry
 13 team shall then determine whether to impose additional sanctions.

14 (5) Reentry team proceedings shall be confidential and shall be closed unless
 15 otherwise authorized by the hearing officer. Each reentry team member shall sign
 16 a confidentiality agreement and shall comply with state and federal
 17 confidentiality laws regarding treatment information. Documents contained in a
 18 participant's pilot program case file shall be confidential and only those
 19 documents that do not violate these state and federal confidentiality laws shall be
 20 released.

21 ➔SECTION 20. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
 22 READ AS FOLLOWS:

23 (1) The department shall implement the reentry drug supervision pilot program
 24 created under Section 18 of this Act for inmates or parolees placed in the pilot
 25 program pursuant to this section.

26 (2) Inmates or parolees may be referred to the Parole Board as candidates for the
 27 pilot program by either the department's Division of Substance Abuse

1 Programming as outlined in subsection (3) of this section or the department's
2 hearing officers as outlined in subsection (4) of this section.

3 (3) (a) After sentencing, the department's Division of Substance Abuse
4 Programming shall conduct a substance abuse assessment of the following
5 inmates:

6 1. Inmates whose offense for which he or she was sentenced:

7 a. Does not qualify him or her as a violent offender as defined in
8 KRS 439.3401 or a sexual offender as defined in KRS 17.550;
9 and

10 b. Did not result in death or serious physical injury of a victim;

11 2. Inmates:

12 a. Who have been convicted of, or entered an Alford plea or plea of
13 nolo contendere to, a Class C or D felony that is:

14 i. A drug offense; or

15 ii. An offense arising from a substance use disorder; or

16 b. Whose probation or parole was revoked due to a substance use
17 disorder or those with a history of substance use disorder; and

18 3. Inmates who have not previously participated in the reentry drug
19 supervision pilot program.

20 (b) After reviewing the substance abuse assessments required under paragraph
21 (a) of this subsection, the department's Division of Substance Abuse
22 Programming shall refer to the Parole Board those inmates determined by
23 the division to be candidates for the reentry drug supervision pilot program.

24 (4) During a preliminary parole revocation hearing, if a department hearing officer
25 suspects a parolee is suffering from a substance use disorder, the hearing officer
26 may order a one (1) month deferment to allow the department's Division of
27 Substance Abuse Programming to conduct a substance abuse assessment of the

1 parolee. After evaluating the assessment, the hearing officer may recommend to
2 the Parole Board that the parolee be placed into the pilot program instead of
3 being revoked.

4 (5) (a) Upon receiving a referral from the department's Division of Substance
5 Abuse Programming pursuant to subsection (3) of this section or from the
6 department's hearing officers pursuant to subsection (4) of this section, the
7 Parole Board shall notify the inmate's or parolee's victims, if any, and
8 provide them an opportunity to submit a written victim impact statement
9 and to testify. The Parole Board shall then evaluate the referred inmate or
10 parolee to determine whether to place him or her in the reentry drug
11 supervision pilot program.

12 (b) When evaluating whether to place a referred inmate or parolee in the
13 reentry drug supervision pilot program, the Parole Board shall consider the
14 following:

15 1. Current criminal charges, if any;

16 2. Criminal convictions;

17 3. Results of the substance abuse assessment conducted pursuant to
18 subsection (3) or (4) of this section;

19 4. Plan of recovery created by the department;

20 5. Information regarding the victims, if any;

21 6. Trial court's recommendation to participate in the pilot program, if
22 any;

23 7. An inmate's or parolee's willingness to participate; and

24 8. Other relevant information as identified by the department.

25 (6) After evaluating the referred inmate or parolee pursuant to subsection (5) of this
26 section, the Parole Board shall determine whether to place an inmate or parolee
27 into the reentry drug supervision pilot program.

1 (7) (a) 1. Notwithstanding KRS 218A.1412 or 439.340 or any other statute to
 2 the contrary, if the Parole Board decides to place an inmate in the
 3 reentry drug supervision pilot program, the inmate shall immediately
 4 be paroled into the pilot program. The only conditions of parole shall
 5 be to:

6 a. Have no contact with victims, if applicable;

7 b. Pay restitution, if applicable; and

8 c. Adhere to Sections 17 to 24 of this Act and to the reentry team's
 9 requirements and conditions.

10 2. Notwithstanding any statute to the contrary, if the Parole Board
 11 decides to place a parolee in the reentry drug supervision pilot
 12 program, the parolee shall immediately be entered into the pilot
 13 program. The only conditions of parole shall be to:

14 a. Adhere to any special conditions established by the Parole
 15 Board; and

16 b. Adhere to Sections 17 to 24 of this Act and to the reentry team's
 17 requirements and conditions.

18 (b) Participants shall remain on parole until sentence completion unless the
 19 reentry team determines to terminate or administratively discharge the
 20 participant from the pilot program. If terminated from the pilot program,
 21 the reentry team shall refer the participant to the Parole Board for
 22 revocation.

23 ➔SECTION 21. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
 24 READ AS FOLLOWS:

25 (1) The reentry drug supervision pilot program shall consist of two (2) phases lasting
 26 a minimum of twelve (12) months or until sentence completion, whichever occurs
 27 first. Both phases shall occur after the participant is paroled.

- 1 (2) The first phase is an education phase. For the first phase, the participant shall at
2 a minimum:
- 3 (a) Provide at least three (3) random drug screens per week;
4 (b) Attend as many group therapy sessions per week as determined necessary by
5 a community mental health center. The community mental health center
6 shall conduct the group therapy sessions;
7 (c) Attend one (1) drug supervision session per week;

20 (b) Attend as many group therapy sessions per week as determined necessary by
21 a community mental health center. The community mental health center

24 "speech-language pathologist," "speech-language pathology," "Au.D.,"

- 26 (e) Has failed to affix the word, term, or initials specified in paragraph (d) of this
27 subsection in any sign, written communication, or advertising media in which

1 the term "doctor" or the abbreviation "Dr." is used in relation to the
2 audiologist or speech-language pathologist holding a doctoral degree; or

3 (f) Has violated any provisions of this chapter.

4 (2) The board shall deny an application for, or suspend or revoke, or impose
5 probationary conditions upon, a license as ordered by the board in any decision
6 made after hearing as provided in this chapter. One (1) year from the date of
7 revocation of a license under this chapter, application may be made to the board for
8 reinstatement. The board shall have discretion to accept or reject an application for
9 reinstatement.

10 (3) A person applying for reinstatement of licensure shall provide evidence of
11 completion of continuing professional education in speech-language pathology or
12 audiology as prescribed by the board.

13 (4) A plea or verdict of guilty or a conviction following a plea of nolo contendere made
14 to a charge of a felony is deemed to be a conviction within the meaning of this
15 chapter. At the direction of the board, *if in accordance with KRS Chapter 335B,*

25 supervisory conditions upon; impose an administrative fine; issue a written

- 1 (a) Committed any act of dishonesty or corruption, if in accordance with KRS

4 conviction of the crime, the judgment and sentence creates a rebuttable

9 reinstatement thereof;

20 (1) The board may refuse to issue a credential, or may suspend, revoke, impose
21 probationary conditions upon, impose an administrative fine, or issue a written
22 reprimand or admonishment if the credential holder has:

23 (a) Committed a dishonest or corrupt act, **if in accordance with KRS Chapter**
24 **335B**. If the act is a crime, conviction in a criminal proceeding shall not be a
25 condition precedent to disciplinary action. Upon conviction of the crime, the
26 judgment and sentence are presumptive evidence at the ensuing disciplinary
27 hearing of the guilt of the credential holder or applicant. Conviction includes

- 1 all instances in which a plea of no contest is the basis of the conviction;

7 (1) When an indeterminate term of imprisonment is imposed, the court shall commit
8 the defendant to the custody of the Department of Corrections for the term of his
9 sentence and until released in accordance with the law.

10 (2) When a definite term of imprisonment is imposed, the court shall commit the
11 defendant to the county or city correctional institution or to a regional correctional
12 institution for the term of his sentence and until released in accordance with the law.

13 ➔SECTION 86. A NEW SECTION OF KRS CHAPTER 533 IS CREATED TO

15 (1) As used in this section:

16 (a) "County jail" means all detention and penal facilities of a county, charter
 17 county, urban-county government, unified local government, or
 18 consolidated local government for adult offenders, together with all its
 19 rehabilitative facilities for adult offenders, including facilities operated by
 20 private agencies under contract with the county, charter county, urban-
 21 county government, unified local government, or consolidated local
 22 government;

23 (b) "Day reporting program" or "program" means a community-based,
 24 structured sentencing program operated by a county jail that combines
 25 enhanced community supervision with resources and services tailored to
 26 meet identified offender needs; and

27 (c) "Eligible defendant" means an individual convicted of a misdemeanor or a

1 Class D felony who is eligible to serve all or part of his or her sentence in a
2 county jail or who is found in contempt of court and who meets the intake
3 criteria established by the day reporting program to which the person would

5 (2) A court may sentence an eligible defendant as part of an alternative sentencing
6 plan or as a sentence for contempt to a local day reporting program for a period
7 of time not longer than the defendant's maximum potential period of
8 incarceration if:

9 (a) The program utilizes whenever practicable a validated screening tool based
10 on criminogenic risk factors to identify an individual's likelihood of
11 reoffending and his or her treatment needs in determining program
12 eligibility;

13 (b) The program has agreed to accept the defendant;

14 (c) The defendant agrees in writing to comply with the program's written terms
15 and conditions; and

16 (d) The defendant, if additionally required by the court or the program to do so,
17 agrees to be subject to the conditions of electronic monitoring pursuant to
18 KRS 532.210 to 532.250.

19 (3) In sentencing a defendant to a day reporting program under this section, a court
20 may authorize a temporary release from the program for any of the purposes
21 allowed for the release of a jail prisoner under KRS 439.179.

22 (4) The day reporting program shall provide a weekly report of all violations of the
23 program's terms and conditions for each program participant to the sentencing
24 court, to the prosecutor, and to the defendant in the case. If specified in the
25 program's written terms and conditions, the program may alter the terms and
26 conditions of a person's participation in the program in response to that person's
27 minor breach of the program's terms and conditions.

- 1 (5) A court may alter or revoke a defendant's participation in a day reporting
 2 program if written notice of the grounds for alteration or revocation is given to
 3 the defendant and a hearing is conducted at which the defendant is represented
 4 by counsel. Following the hearing, if the court finds that the defendant has
 5 without good cause failed to participate in the program or to comply with its
 6 terms and conditions, the court may impose any additional sentence or other
 7 sanction specified in the original sentencing order.
- 8 (6) The Administrative Office of the Courts shall prescribe forms to be utilized in the
 9 implementation of this section.
- 10 (7) A day reporting program may be referred to as a day reporting center or other
 11 appropriate nomenclature in its day-to-day operations.

12 ➔Section 87. KRS 441.005 is amended to read as follows:

13 As used in this chapter, unless the context otherwise requires:

- 14 (1) "Jail" means county jails and correctional or detention facilities, including
 15 correctional facilities defined in KRS 67B.020 and juvenile detention facilities,
 16 operated by and under the supervision of any political subdivision.
- 17 (2) "Holdover" means any jail housing prisoners for a maximum period of ninety-six
 18 (96) continuous hours and excluding times when a prisoner is released for a
 19 minimum of seven (7) hours for the purpose of working at his employment,
 20 attending an educational institution, or conducting other business pursuant to a
 21 court order, or when a prisoner is released for in court proceedings.
- 22 (3) "Prisoner" means any person confined in jail pursuant to any code, ordinance, law,
 23 or statute of any unit of government and who is:
- 24 (a) Charged with or convicted of an offense; or
 25 (b) Held for extradition or as a material witness; or

- 27 (4) "Unit of government" means that unit of government including the United States

 2 violating. If a person is imprisoned for contempt of court, the state shall be deemed
 3 the responsible unit of government.

4 (5) "Department" means the Department of Corrections.

5 (6) "Jail personnel" means deputy jailers, matrons, cooks, and other food service
 6 personnel, and other jail employees involved in the supervision, custody, care, or
 7 treatment of prisoners in jails but does not include maintenance or clerical
 8 personnel.

9 (7) "Regional jail" means a jail that may house prisoners for up to one (1) year and
 10 which is:

11 (a) Owned and operated by one (1) county and, on a regular basis, holds prisoners
 12 for another county or for the state; or

13 (b) Owned and operated by two (2) or more counties through a regional jail
 14 authority as provided in KRS 441.800.

15 (8) "Commissioner" means the Commissioner of the Department of Corrections.

16 **(9) "Reentry center" means a supervised community residential facility operated by a**
 17 **local correctional facility, county jail, or regional jail as detailed in Section 88 of**
 18 **this Act.**

19 ➔SECTION 88. A NEW SECTION OF KRS CHAPTER 441 IS CREATED TO
 20 READ AS FOLLOWS:

21 **(1) A local correctional facility, county jail, or regional jail may, with the approval of**
 22 **the Department of Corrections, operate a reentry center. Reentry centers**
 23 **established pursuant to this section shall:**

24 **(a) Employ a program coordinator responsible for oversight of the reentry**
 25 **center;**

26 **(b) Offer residents at least one (1) vocational training program approved by the**
 27 **Department of Corrections;**

- 1 (c) Offer residents at least two (2) other evidence-based programs approved by
2 the Department of Corrections;
- 3 (d) Review each participant's case with a certified alcohol and drug counselor
4 as defined in KRS 309.080;
- 5 (e) Require residents to participate in family outreach and community
6 involvement programs;
- 7 (f) Require residents to seek or maintain employment in the community. The
8 reentry center shall require ten percent (10%) of the resident's income to be
9 deposited into a savings account, shall require fifteen percent (15%) of the
10 resident's income to be directed to payment of restitution if applicable, and
11 may charge each resident a fee of not more than twenty percent (20%) of
12 the resident's income; and
- 13 (g) Report data as required by the Department of Corrections in order to allow
14 evaluation of the effectiveness of the reentry center.
- 15 (2) A person is eligible for placement in a reentry center if he or she has less than
16 twelve (12) months until the expected expiration of his or her sentence and is:
- 17 (a) A state inmate eligible for placement in a local jail pursuant to Section 85
18 of this Act;
- 19 (b) A Class B felon who is classified as low risk by the Department of
20 Corrections; or
- 21 (c) A county inmate in the jail operated by the political subdivision which
22 operates the reentry center.
- 23 (3) Residents may be assigned to a reentry center by:
- 24 (a) Administrative classification by the Department of Corrections;
- 25 (b) Administrative decision of the jailer for inmates of the jail;
- 26 (c) The court, as an alternative sentence; or
- 27 (d) The Parole Board, as a condition of parole or as a sanction for violation of

1 conditions of parole.

2 ➔SECTION 89. A NEW SECTION OF KRS CHAPTER 441 IS CREATED TO
3 READ AS FOLLOWS:

4 (1) The Department of Corrections shall, by administrative regulation, establish
5 standards for the operation of reentry centers established pursuant to Section 88
6 of this Act.

7 (2) The Department of Corrections shall utilize data reported by the reentry centers
8 pursuant to Section 88 of this Act to analyze the effectiveness of the reentry
9 centers in reducing recidivism and the engagement of residents in employment
10 and in the community.

11 (3) Placement of inmates in reentry centers by the Department of Corrections or the
12 Parole Board shall prioritize placement in higher-performing centers, as
13 determined by the Department of Corrections.

14 ➔Section 90. KRS 196.031 is amended to read as follows:

15 (1) The cabinet shall employ the personnel and operate and maintain data collection
16 and processing systems necessary to comply with the provisions of this section.

17 (2) The cabinet shall annually on July 1 of each year report to the Governor, the
18 Legislative Research Commission, and the Kentucky State Corrections Commission
19 on:

20 (a) The placement of prisoners within the Commonwealth's correctional system

5 assessment results, in prison and in the community;
- 6 (h) The percentage of felony offenders whose reassessment results demonstrate
7 reductions in criminal risk factors;
- 8 (i) The percentage of programs that demonstrate their effectiveness in reducing
9 recidivism;
- 10 (j) The percentage of felony offenders on parole or some form of post-release
11 supervision, by supervision type, who:
- 12 1. Are employed or in school within thirty (30) days, six (6) months, and
13 one (1) year of the start of supervision;
- 14 2. Have had part-time employment for a minimum of six (6) months, and
15 the percentage of offenders who have had full-time employment for a
16 minimum of six (6) months;
- 17 3. Have housing upon release from incarceration;
- 18 4. Had stable housing for at least six (6) months; and
- 19 5. Are arrested, convicted, or incarcerated within six (6) months, one (1)
20 year, and three (3) years;
- 21 (k) The percentage of admissions to prison by offenders under supervision at the
22 time of admission, including information regarding whether the violations
23 were criminal or technical; and
- 24 (l) Any other data that provides information on state-funded crime reduction and
25 recidivism reduction efforts, including caseload sizes by risk level,
26 participation in treatment and intervention programming, public safety
27 outcomes, and cost effectiveness.

- 1 (3) The cabinet shall annually report to the Governor and to the Legislative Research
2 Commission on:
- 3 (a) Numbers and types of prison beds necessary to meet current population needs
4 and six (6) year projections of those needs;
- 5 (b) Current personnel needs of the cabinet and five (5) year projections of the
6 needs; and
- 7 (c) A six (6) year projection of needed capital construction, program
8 development, and anticipated requests for appropriations.

9 ➔Section 91. KRS 439.340 is amended to read as follows:

- 10 (1) The board may release on parole persons confined in any adult state penal or
11 correctional institution of Kentucky or sentenced felons incarcerated in county jails
12 eligible for parole. All paroles shall issue upon order of the board duly adopted. As
13 soon as practicable after his or her admission to an adult state penal or correctional
14 institution or county jail if he or she is a sentenced felon, and at such intervals
15 thereafter as it may determine, the Department of Corrections shall obtain all
16 pertinent information regarding each prisoner, except those not eligible for parole.
17 The information shall include the results of his or her most recent risk and needs
18 assessment, his or her criminal record, his or her conduct, employment, and the
19 reports of physical and mental examinations that have been made. The Department
20 of Corrections shall furnish the circumstances of his or her offense, the results of his
21 or her most recent risk and needs assessment, and his or her previous social history
22 to the board. The Department of Corrections shall prepare a report on any
23 information it obtains. It shall be the duty of the Department of Corrections to
24 supplement this report with any material the board may request and submit the
25 report to the board.
- 26 (2) Before granting the parole of any prisoner, the board shall consider the pertinent
27 information regarding the prisoner, including the results of his or her most recent

1 risk and needs assessment, and shall have him or her appear before it for interview
2 and hearing. The board in its discretion may hold interviews and hearings for
3 prisoners convicted of Class C felonies not included within the definition of
4 "violent offender" in KRS 439.3401 and Class D felonies. The board in its
5 discretion may request the parole board of another state confining prisoners
6 pursuant to KRS 196.610 to interview eligible prisoners and make a parole
7 recommendation to the board. A parole shall be ordered only for the best interest of
8 society and not as an award of clemency, and it shall not be considered a reduction
9 of sentence or pardon. A prisoner shall be placed on parole only when arrangements
10 have been made for his or her proper employment or for his or her maintenance and
11 care, and when the board believes he or she is able and willing to fulfill the
12 obligations of a law abiding citizen. Notwithstanding any statute to the contrary,
13 including KRS 440.330, when a prisoner is otherwise eligible for parole and the
14 board has recommended parole for that prisoner for the reasons set forth in this
15 subsection, the board may grant parole to any prisoner wanted as a fugitive by any
16 other jurisdiction, and the prisoner shall be released to the detainer from that
17 jurisdiction. Such parole shall not constitute a relinquishment of jurisdiction over
18 the prisoner, and the board in all cases expressly reserves the right to return the
19 prisoner to confinement in a correctional institution of the Commonwealth if the
20 prisoner violates the terms of his or her parole.

21 (3) (a) A nonviolent offender convicted of a Class D felony with an aggregate
22 sentence of one (1) to five (5) years who is confined to a state penal institution
23 or county jail shall have his or her case reviewed by the Parole Board after
24 serving fifteen percent (15%) or two (2) months of the original sentence,
25 whichever is longer.

26 (b) Except as provided in this section, the board shall adopt administrative
27 regulations with respect to the eligibility of prisoners for parole, the conduct

1 of parole and parole revocation hearings and all other matters that come
2 before it, or conditions to be imposed upon parolees. Regulations governing
3 the eligibility of prisoners for parole shall be in accordance with
4 professionally accepted ideas of correction and reform and may utilize in part
5 objective, performance-based criteria and risk and needs assessment
6 information; however, nothing herein contained shall preclude the board from
7 utilizing its present regulations in conjunction with other factors involved that
8 would relate to the inmate's needs and the safety of the public.

9 (4) The board shall insure that all sentenced felons who have longer than ninety (90)
10 days to serve in state penal institutions, halfway houses, reentry centers, and county
11 jails are considered for parole not less than sixty (60) days prior to their parole
12 eligibility date, and the Department of Corrections shall provide the necessary
13 assistance and information to the board in order for it to conduct timely parole
14 reviews.

15 (5) In addition to or in conjunction with each hearing conducted under subsection (2) of
16 this section for any prisoner convicted of a Class A, B, or C felony and prior to the
17 granting of a parole to any such prisoner, the parole board shall conduct a hearing of
18 which the following persons shall receive not less than forty-five (45) nor more than
19 ninety (90) days' notice: the Commonwealth's attorney who shall notify the sheriff
20 of every county and the chief of police of every city and county in which the
21 prisoner committed any Class A, B, or C felony for which he or she is imprisoned,
22 and all identified victims of the crimes or the next of kin of any victim who is
23 deceased. Notice to the Commonwealth's attorney shall be by mail, fax, or
24 electronic means at the discretion of the board, and shall be in a manner that ensures
25 receipt at the Commonwealth attorney's business office. Notices received by chiefs
26 of police and sheriffs shall be posted in a conspicuous location where police
27 employed by the department may see it. Notices shall be posted in a manner and at a

1 time that will allow officers to make comment thereon to the Parole Board. Notice
2 to victims or their next of kin shall be made, for prisoners incarcerated prior to July
3 15, 1986, by mail, fax, or electronic means at the discretion of the board, and shall
4 be in a manner that ensures receipt by the Commonwealth's attorney, who shall
5 forward the notice promptly to the victims or their next of kin at their last known
6 address. For prisoners incarcerated on or after July 15, 1986, notice to the victims or
7 their next of kin shall be by mail from the Parole Board to their last known address
8 as provided by the Commonwealth's attorney to the Parole Board at the time of
9 incarceration of the prisoner. Notice to the victim or the next of kin of subsequent
10 considerations for parole after the initial consideration shall not be sent if the victim
11 or the next of kin gives notice to the board that he or she no longer wants to receive
12 such notices. The notice shall include the time, date, and place of the hearing
13 provided for in this subsection, and the name and address of a person to write if the
14 recipient of the notice desires to attend the hearing or to submit written comments.

15 (6) Persons receiving notice as provided for in subsection (5) of this section may
16 submit comments, in person or in writing, to the board upon all issues relating to the
17 parole of the prisoner. The board shall read and consider all comments prior to
18 making its parole decision, if they are received by the board not less than seven (7)
19 days before the date for the hearing. The board shall retain all comments in the
20 prisoner's permanent Parole Board file, and shall consider them in conjunction with
21 any subsequent parole decisions affecting the prisoner. In addition to officers listed
22 in subsection (5) of this section, the crime victims or the next of kin of any victim
23 who is deceased or who is disabled and cannot attend the hearing or the parent or
24 legal guardian of any victim who is a minor may attend the hearing provided for in
25 subsection (5) of this section and present oral and written comments upon all issues
26 relating to the parole of the prisoner, if they have advised the board, in writing
27 received by the board not less than seven (7) days prior to the date set for the

1 hearing, of their intention to attend the hearing. The board shall receive and
2 consider all comments, shall make a record of them which it shall retain in the
3 prisoner's permanent Parole Board file, and shall consider them in conjunction with
4 any subsequent parole decision affecting the prisoner. Persons appearing before the
5 Parole Board pursuant to this subsection may elect to make their presentations
6 outside of the presence of the prisoner.

7 (7) Victims of Class D felonies may submit comments in person or in writing to the
8 board upon all issues relating to the parole of a prisoner.

9 (8) Any hearing provided for in subsections (5), (6), and (7) of this section shall be
10 open to the public unless the persons having a right to appear before the board as
11 specified in those subsections request closure of hearing for reasons of personal
12 safety, in which event the hearing shall be closed. The time, date, and location of
13 closed hearings shall not be disclosed to the public.

14 (9) Except as specifically set forth in this section, nothing in this section shall be
15 deemed to expand or abridge any existing rights of persons to contact and
16 communicate with the Parole Board or any of its members, agents, or employees.

17 (10) The unintentional failure by the Parole Board, sheriff, chief of police, or any of its
18 members, agents, or employees or by a Commonwealth's attorney or any of his or
19 her agents or employees to comply with any of the provisions of subsections (5),
20 (6), and (8) of this section shall not affect the validity of any parole decision or give
21 rise to any right or cause of action by the crime victim, the prisoner, or any other
22 person.

23 (11) No eligible sexual offender within the meaning of KRS 197.400 to 197.440 shall be
24 granted parole unless he or she has successfully completed the Sexual Offender
25 Treatment Program.

26 (12) Any prisoner who is granted parole after completion of the Sexual Offender
27 Treatment Program shall be required, as a condition of his or her parole, to

1 participate in regular treatment in a mental health program approved or operated by
2 the Department of Corrections.

3 (13) When the board grants parole contingent upon completion of a program, the
4 commissioner, or his or her designee, shall determine the most appropriate
5 placement in a program operated by the department or a residential or nonresidential
6 program within the community approved by the department. If the department
7 releases a parolee to a nonresidential program, the department shall release the
8 parolee only if he or she will have appropriate community housing pursuant to KRS
9 439.3408.

10 (14) If the parole board does not grant parole to a prisoner, the maximum deferment for a
11 prisoner convicted of a non-violent, non-sexual Class C or Class D felony shall be
12 twenty-four (24) months. For all other prisoners who are eligible for parole:

13 (a) No parole deferment greater than five (5) years shall be ordered unless
14 approved by a majority vote of the full board; and

15 (b) No deferment shall exceed ten (10) years, except for life sentences.

16 (15) When an order for parole is issued, it shall recite the conditions thereof.

17 ➔Section 92. KRS 439.3407 is amended to read as follows:

18 (1) The department may promulgate administrative regulations to implement
19 conditional parole of state inmates incarcerated in state corrections institutions or
20 local correctional facilities or county jails to place those individuals closer to their
21 communities prior to release. A parolee placed on conditional parole shall serve that
22 term in a local correctional facility or county jail **or reentry center** in a county in
23 which the fiscal court has agreed to house parolees if beds are available in the local
24 correctional facility or county jail **or reentry center**.

8 relating to eligibility of an individual for conditional parole shall take into
9 consideration, at a minimum, the following information about the individual:

10 (a) The offense for which the individual was convicted and his or her
11 rehabilitation efforts while incarcerated;

12 (b) The security classification while incarcerated in the state correctional
13 institution;

14 (c) Conduct while incarcerated in the state correctional institution;

15 (d) Ability to find employment in the community; and

16 (e) The availability of additional applicable education, treatment or intervention,
17 and training for employment in the local correctional facility or county jail, if
18 needed by the individual.

19 ➔Section 93. KRS 439.3408 is amended to read as follows:

20 When considering appropriate housing options for a person considered for parole or a
21 person who is being paroled, the department shall approve any form of acceptable
22 housing, including but not limited to apartments, shelters for homeless or other persons,
23 county jails or restricted custody facilities that a county approves for parolees, educational
24 institutions with dormitories if the parolee is enrolled or accepted for enrollment at an
25 educational institution, halfway houses, reentry centers, residential treatment or other
26 programs in which the parolee is enrolled or accepted for enrollment, and other forms of
27 transitional housing meeting the requirements of applicable statutes.

17 defendant, probation with an alternative sentencing plan shall be granted unless the
18 court is of the opinion that imprisonment is necessary for the protection of the
19 public because:
