10		(b) The use of an electronic cigarette or an e-cigarette or a vaping device,
11		which creates a vapor, aerosol, or mist in any manner or in any form,
12		including alternative nicotine products or vapor products as defined in KRS
13		<u>438.305;</u>
14		(c) The use of any oral smoking device for the purpose of circumventing the
15		prohibition of tobacco use in this section; or
16		(d) The consumption or other use of a tobacco product as defined in KRS
17		<u>438.305(8)(a).</u>
18	<u>(2)</u>	A person shall not use a tobacco product in or on the campus of an elementary,
19		middle, or high school.
20	<u>(3)</u>	(a) Students, school personnel, or visitors shall not use a tobacco product on or
21		in property or vehicles that are owned, operated, leased, or contracted for
22		use by a local school board.
23		(b) A person affiliated with a school shall not use a tobacco product while
24		attending that school's sponsored trips or activities.
25	<i>(4)</i>	Tobacco use in violation of subsection (2) or (3) of this section or school policies
26		adopted pursuant to subsection (5) of this section shall be subject to penalties set
27		forth by the local school board.
