

1 AN ACT relating to early voting in-person absentee voting.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 117 IS CREATED TO  
4 READ AS FOLLOWS:

- 5 *(1) In-person absentee voting shall be conducted in the county clerk's office or other*  
6 *place designated by the county board of elections and approved by the State*  
7 *Board of Elections during normal business hours for at least twelve (12) working*  
8 *days, including two (2) Saturdays, before the Sunday prior to election day. A*  
9 *county board of elections may permit in-person absentee voting to be conducted*  
10 *on a voting machine for a period longer than the twelve (12) working days,*  
11 *including two (2) Saturdays, before the Sunday prior to election day.*
- 12 *(2) Any qualified voter in the county who chooses to vote in-person may, at any time*  
13 *during normal business hours on those days in-person absentee voting is*  
14 *conducted in the county clerk's office or other place designated by the county*  
15 *board of elections, appear in person to the county clerk or other election official*  
16 *to vote on a voting machine in the county clerk's office or other place designated*  
17 *by the county board of elections and approved by the State Board of Elections.*
- 18 *(3) Any individual qualified to appoint challengers for the day of an election may*  
19 *also appoint challengers to observe all in-person absentee voting performed at the*  
20 *county clerk's office or other place designated by the county board of elections*  
21 *and approved by the State Board of Elections, and those challengers may exercise*  
22 *the same privileges as challengers appointed for observing voting on the day of*  
23 *an election.*
- 24 *(4) The members of the county board of elections or their designees who provide*  
25 *equal representation of both political parties may serve as precinct election*  
26 *officers, without compensation, for all in-person absentee voting performed on a*  
27 *voting machine in the county clerk's office or other place designated by the*

1 county board of elections and approved by the State Board of Elections. If the  
 2 members of the county board of elections or designees serve as precinct election  
 3 officers for in-person absentee voting, they shall perform the same duties and  
 4 exercise the same authority as precinct election officers who serve on the day of  
 5 an election. If the members of the county board of elections or their designees do  
 6 not serve as precinct election officers for the in-person absentee voting, the  
 7 county clerk or deputy county clerks shall supervise the in-person absentee  
 8 voting.

9 ➔Section 2. KRS 117.085 is amended to read as follows:

- 10 (1) All requests for an application for a mail-in~~[an]~~ absentee ballot may be transmitted  
 11 by telephone, facsimile machine, by mail, by electronic mail, or in person. Except as  
 12 provided in paragraph (b) of this subsection, all applications for a mail-in~~[an]~~  
 13 absentee ballot shall be transmitted only by mail to the voter or in person at the  
 14 option of the voter, except that the county clerk shall hand an application for an  
 15 absentee ballot to a voter permitted to vote by mail-in absentee ballot who appears  
 16 in person to request the application, or shall mail the application to a voter  
 17 permitted to vote by mail-in absentee ballot who requests the application by  
 18 telephone, facsimile machine, electronic mail, or mail. The mail-in absentee ballot  
 19 application may be requested by the voter or the spouse, parents, or children of the  
 20 voter, but shall be restricted to the use of the voter. Except for qualified voters who  
 21 apply in accordance with~~[pursuant to]~~ the requirements of KRS 117.075 and  
 22 117.077, those who are incarcerated in jail but have yet to be convicted, those who  
 23 are uniformed-service voters as defined in KRS 117A.010 that are confined to a  
 24 military base on election day, and persons who qualify under paragraph (a)7. of this  
 25 subsection, mail-in absentee ballots shall not be mailed to a voter's residential  
 26 address located in the county in which the voter is registered. In the case of ballots  
 27 returned by mail, the county clerk shall provide an absentee ballot, two (2) official

1 envelopes for returning the ballot, and instructions for voting to a voter who  
2 presents a completed application for a mail-in~~an~~ absentee ballot as provided in  
3 this section and who is properly registered as stated in his or her application.

4 (a) The following voters may apply to cast their votes by mail-in absentee ballot  
5 if the application is received not later than the close of business hours seven  
6 (7) days before the election:

- 7 1. Voters permitted to vote by absentee ballot in accordance with~~pursuant~~  
8 ~~to~~ KRS 117.075;
- 9 2. Voters who are residents of Kentucky who are covered voters as defined  
10 in KRS 117A.010;
- 11 3. Voters who are students who temporarily reside outside the county of  
12 their residence;
- 13 4. Voters who are incarcerated in jail who have been charged with a crime  
14 but have not been convicted of the crime;
- 15 5. Voters who change their place of residence to a different state while the  
16 registration books are closed in the new state of residence before an  
17 election of electors for President and Vice President of the United  
18 States, who shall be permitted to cast an absentee ballot for electors for  
19 President and Vice President of the United States only;
- 20 6. Voters who temporarily reside outside the state but who are still eligible  
21 to vote in this state;
- 22 7. Voters who are prevented from voting in person at the polls on election  
23 day and from casting an absentee ballot in person in the county clerk's  
24 office on all days in-person absentee voting is conducted prior to  
25 election day because their employment location requires them to be  
26 absent from the county all hours and all days in-person absentee voting  
27 is conducted in the county clerk's office; and

1           8. Voters who are program participants in the Secretary of State's crime  
2           victim address confidentiality protection program as authorized by KRS  
3           14.312.

4           (b) Residents of Kentucky who are covered voters as defined in KRS 117A.010  
5           may apply for a mail-in~~[an]~~ absentee ballot by means of the federal post-card  
6           application, which may be transmitted to the county clerk's office by mail, by  
7           facsimile machine, or by means of the electronic transmission system  
8           established under KRS 117A.030(4). The application may be used to register,  
9           reregister, and to apply for a mail-in~~[an]~~ absentee ballot. If the federal post-  
10          card application is received at any time not less than seven (7) days before the  
11          election, the county clerk shall affix his or her seal to the application form  
12          upon receipt.

13 ~~[(c) Absentee voting shall be conducted in the county clerk's office or other place~~  
14 ~~designated by the county board of elections and approved by the State Board of~~  
15 ~~Elections during normal business hours for at least the twelve (12) working days~~  
16 ~~before the election. A county board of elections may permit absentee voting to be~~  
17 ~~conducted on a voting machine for a period longer than the twelve (12) working~~  
18 ~~days before the election.~~

19 ~~(d) Any qualified voter in the county who is not permitted to vote by absentee ballot~~  
20 ~~under paragraph (a) of this subsection who will be absent from the county on any~~  
21 ~~election day may, at any time during normal business hours on those days absentee~~  
22 ~~voting is conducted in the county clerk's office, make application in person to the~~  
23 ~~county clerk to vote on a voting machine in the county clerk's office or other place~~  
24 ~~designated by the county board of elections and approved by the State Board of~~  
25 ~~Elections.~~

26 ~~(e) The following voters may, at any time during normal business hours on those days~~  
27 ~~absentee voting is conducted in the county clerk's office, make application in person~~

1       ~~to the county clerk to vote on a voting machine in the county clerk's office or other~~  
2       ~~place designated by the county board of elections and approved by the State Board~~  
3       ~~of Elections:~~

- 4       ~~1. Voters who are residents of Kentucky who are covered voters as defined in KRS~~  
5       ~~117A.010, who will be absent from the county on any election day;~~
- 6       ~~2. Voters who are students who temporarily reside outside the county of their~~  
7       ~~residence;~~
- 8       ~~3. Voters who have surgery scheduled that will require hospitalization on election day,~~  
9       ~~and the spouse of the voter;~~
- 10      ~~4. Voters who temporarily reside outside the state but who are still eligible to vote in~~  
11      ~~this state and who will be absent from the county on any election day;~~
- 12      ~~5. Voters who are residents of Kentucky who are uniformed service voters as defined~~  
13      ~~in KRS 117A.010 confined to a military base on election day and who learn of that~~  
14      ~~confinement within seven (7) days or less of an election and are not eligible for a~~  
15      ~~paper absentee ballot under this subsection; and~~
- 16      ~~6. A voter who is a pregnant woman in her last trimester of pregnancy at the time she~~  
17      ~~wishes to vote under this paragraph. The application form for a voter under this~~  
18      ~~subparagraph shall be prescribed by the State Board of Elections, which shall~~  
19      ~~contain the woman's sworn statement that she is in fact in her last trimester of~~  
20      ~~pregnancy at the time she wishes to vote.~~
- 21      ~~(f) Voters who change their place of residence to a different state while the registration~~  
22      ~~books are closed in the new state of residence before a presidential election shall be~~  
23      ~~permitted to cast an absentee ballot for President and Vice President only, by~~  
24      ~~making application in person to the county clerk to vote on a voting machine in the~~  
25      ~~county clerk's office or other place designated by the county board of elections and~~  
26      ~~approved by the State Board of Elections.~~
- 27      ~~(g) Any member of the county board of elections, any precinct election officer~~

1 ~~appointed to serve in a precinct other than that in which he or she is registered, any~~  
2 ~~alternate precinct election officer, any deputy county clerk, any staff for the State~~  
3 ~~Board of Elections, and any staff for the county board of elections may vote on a~~  
4 ~~voting machine in the county clerk's office or other place designated by the county~~  
5 ~~board of elections, and approved by the State Board of Elections, up to the close of~~  
6 ~~normal business hours on the day before the election. The application form for those~~  
7 ~~persons shall be prescribed by the State Board of Elections and, in the case of~~  
8 ~~application by precinct election officers, shall contain a verification of appointment~~  
9 ~~signed by a member of the county board of elections. If an alternate precinct~~  
10 ~~election officer or a precinct election officer appointed to serve in a precinct other~~  
11 ~~than that in which he or she is registered receives his or her appointment while~~  
12 ~~absentee voting is being conducted in the county, such officer may vote on a voting~~  
13 ~~machine in the county clerk's office or other place designated by the county board of~~  
14 ~~elections, and approved by the State Board of Elections, up to the close of normal~~  
15 ~~business hours on the day before the election. In case of such voters, the verification~~  
16 ~~of appointment shall also contain the date of appointment. The applications shall be~~  
17 ~~restricted to the use of the voter only.~~

18 ~~(h) The members of the county board of elections or their designees who provide equal~~  
19 ~~representation of both political parties may serve as precinct election officers,~~  
20 ~~without compensation, for all absentee voting performed on a voting machine in the~~  
21 ~~county clerk's office or other place designated by the county board of elections and~~  
22 ~~approved by the State Board of Elections. If the members of the county board of~~  
23 ~~elections or their designees serve as precinct election officers for the absentee~~  
24 ~~voting, they shall perform the same duties and exercise the same authority as~~  
25 ~~precinct election officers who serve on the day of an election. If the members of the~~  
26 ~~county board of elections or their designees do not serve as precinct election~~  
27 ~~officers for the absentee voting, the county clerk or deputy county clerks shall~~

1 supervise the absentee voting.

2 (i) ~~Any individual qualified to appoint challengers for the day of an election may also~~  
3 ~~appoint challengers to observe all absentee voting performed at the county clerk's~~  
4 ~~office or other place designated by the county board of elections, and approved by~~  
5 ~~the State Board of Elections, and those challengers may exercise the same privileges~~  
6 ~~as challengers appointed for observing voting on the day of an election at a regular~~  
7 ~~polling place.]~~

8 (2) The county clerk shall type the name of the voter permitted to vote by mail-in  
9 absentee ballot on the application form for that person's use and no other. The mail-  
10 in absentee ballot application form shall be in the form prescribed by the State  
11 Board of Elections, shall bear the seal of the county clerk, and shall contain the  
12 following information: name, residential address, precinct, party affiliation,  
13 statement of the reason the person cannot vote in person on election day or during  
14 the dates and times in-person absentee voting is being conducted in accordance  
15 with Section 1 of this Act, statement of where the voter shall be on election day or  
16 during the dates and times in-person absentee voting is being conducted in  
17 accordance with Section 1 of this Act, statement of compliance with residency  
18 requirements for voting in the precinct, and the voter's mailing address for a mail-  
19 in~~an~~ absentee ballot. The form shall be verified and signed by the voter. A notice  
20 of the actual penalty provisions in KRS 117.995(2) and (5) shall be printed on the  
21 application.

22 (3) If the county clerk finds that the voter is properly registered as stated in his or her  
23 application and qualifies to receive a mail-in~~an~~ absentee ballot ~~by mail~~, he or  
24 she shall mail to the voter a mail-in~~an~~ absentee ballot, two (2) official envelopes  
25 for returning the ballot, and instructions for voting. The county clerk shall complete  
26 a postal form for a certificate of mailing for ballots mailed within the fifty (50)  
27 states, and it shall be stamped by the postal service when the ballots are mailed. A

1        mail-in~~[An]~~ absentee ballot may be transmitted by facsimile machine or by the  
2        electronic transmission system established under KRS 117A.030(4) to a covered  
3        voter as defined in KRS 117A.010. The covered voter shall be notified of the  
4        options for transmittal of the mail-in absentee ballot, and the mail-in absentee  
5        ballot shall be transmitted by the method chosen for receipt by the resident of  
6        Kentucky who is a covered voter.

7        (4) Mail-in absentee ballots which are requested prior to the printing of the ballots shall  
8        be mailed or otherwise transmitted as provided in subsection (3) of this section by  
9        the county clerk to the voter within three (3) days of the receipt of the printed  
10       ballots; and mail-in absentee ballots which are requested subsequent to the receipt  
11       of the ballots by the county clerk shall be mailed or otherwise transmitted as  
12       provided in subsection (3) of this section to the voter within three (3) days of the  
13       receipt of the request.

14       (5) The county clerk shall cause ballots to be printed fifty (50) days prior to each  
15       primary or regular election, and forty-five (45) days prior to a special election.

16       (6) The outer envelope shall bear the words "Mail-in Absentee Ballot" and the address  
17       and official title of the county clerk and shall provide space for the voter's signature,  
18       voting address, precinct number, and signatures of two (2) witnesses if the voter  
19       signs the form with the use of a mark instead of the voter's signature. A detachable  
20       flap on the inner envelope shall provide space for the voter's signature, voting  
21       address, precinct number, signatures of two (2) witnesses if the voter signs the form  
22       with the use of a mark instead of the voter's signature and notice of penalty provided  
23       in KRS 117.995(5). The county clerk shall type the voter's address and precinct  
24       number in the upper left hand corner of the outer envelope and of the detachable  
25       flap on the inner envelope immediately below the blank space for the voter's  
26       signature. The inner envelope shall be blank. The county clerk shall retain the  
27       application and the postal form required by subsection (3) of this section for twenty-



- 1 two (22) months after the election.
- 2 (7) Any person who has received a mail-in~~[an]~~ absentee ballot~~[by mail]~~ but who  
3 knows at least seven (7) days before the date of the election or during the dates and  
4 times in-person absentee voting is being conducted in accordance with Section 1  
5 of this Act that he or she will be in the county on election day or during the dates  
6 and times in-person absentee voting is being conducted in accordance with  
7 Section 1 of this Act and who has not voted in accordance with~~[pursuant to]~~ the  
8 provisions of KRS 117.086 shall cancel his or her mail-in absentee ballot and vote  
9 in person. The voter shall return the mail-in absentee ballot to the county clerk's  
10 office no later than seven (7) days prior to the date of the election or during the  
11 dates and times in-person absentee voting is being conducted in accordance with  
12 Section 1 of this Act. Upon the return of the mail-in absentee ballot, the county  
13 clerk shall mark on the outer envelope of the sealed ballot or the unmarked ballot  
14 the words "Canceled because voter appeared to vote in person." Sealed envelopes so  
15 marked shall not be opened. The county clerk shall remove the voter's name from  
16 the list of persons who were sent mail-in absentee ballots, and the voter may vote in  
17 the precinct in which he or she is properly registered on the day of election or  
18 during the dates and times in-person absentee voting is being conducted in  
19 accordance with Section 1 of this Act.
- 20 (8) Any voter qualified for a mail-in absentee ballot who does not receive a requested  
21 mail-in ballot within a reasonable amount of time shall contact the county clerk,  
22 who shall reissue a second ballot. The county clerk shall keep a record of the  
23 absentee ballots issued and returned by mail, and the in-person absentee voting that  
24 is performed on the voting machine in the county clerk's office or other place  
25 designated by the county board of elections and approved by the State Board of  
26 Elections, to verify that only the first voted ballot to be returned by the voter is  
27 counted. Upon the return of any ballot after the first ballot is returned, the county

- 1 clerk shall mark on the outer envelope of the sealed ballot the words "Canceled  
2 because ballot reissued."
- 3 (9) Any covered voter as defined in KRS 117A.010 who has received a mail-in~~[an]~~  
4 absentee ballot but who knows that he or she will be in the county on election day  
5 or during the dates and times in-person absentee voting is being conducted in  
6 accordance with Section 1 of this Act and who has not voted in accordance  
7 with~~[pursuant to]~~ the provisions of KRS 117.086 shall cancel his or her mail-in  
8 absentee ballot and vote in person. The voter shall return the mail-in absentee ballot  
9 to the county clerk's office on or before the day the voter votes in-person~~[election~~  
10 ~~day]~~. Upon the return of the mail-in absentee ballot, the county clerk shall mark on  
11 the outer envelope of the sealed ballot or the unmarked ballot the words "Canceled  
12 because voter appeared to vote in person." Sealed envelopes so marked shall not be  
13 opened. If the covered voter is unable to return the mail-in absentee ballot to the  
14 county clerk's office on or before the voter~~[election day, at the time he or she]~~ votes  
15 in person, he or she shall sign a written oath as to his or her qualifications on the  
16 form prescribed by the State Board of Elections in accordance with~~[pursuant to]~~  
17 KRS 117.245. The county clerk shall remove the voter's name from the list of  
18 persons who were sent mail-in absentee ballots, and provide the voter with written  
19 authorization to vote~~[at the precinct, and the voter may vote in the precinct in~~  
20 ~~which he or she is properly registered]~~.
- 21 (10) Notwithstanding the provisions of the Kentucky Open Records Act, KRS 61.870 to  
22 61.884, the information contained in an application for a mail-in~~[an]~~ absentee  
23 ballot shall not be made public until after the close of business hours on the election  
24 day for which the application applies. This subsection shall not prohibit at any time  
25 the disclosure, upon request, of the total number of applications for mail-in  
26 absentee ballots that have been filed, or the disclosure to the Secretary of State or  
27 the State Board of Elections, if requested or if otherwise required by law, of any

1 information in an application for a mail-in~~[an]~~ absentee ballot.

2 ➔Section 3. KRS 117.0851 is amended to read as follows:

3 Absentee ballots cast, as provided by KRS 117.075, 117.077,~~[and]~~ 117.085, and Section  
4 I of this Act shall all be tabulated in the same manner, as shall be provided by this  
5 chapter.

6 ➔Section 4. KRS 117.086 is amended to read as follows:

7 (1) The voter returning his or her absentee ballot by mail shall mark his or her ballot,  
8 seal it in the inner envelope and then in the outer envelope, and mail it to the county  
9 clerk as~~[shall be]~~ provided by this chapter. The voter shall sign the detachable flap  
10 and the outer envelope in order to validate the ballot. A person having power of  
11 attorney for the voter and who signs the detachable flap and outer envelope for the  
12 voter shall complete the voter assistance form as required by KRS 117.255. The  
13 signatures of two (2) witnesses are required if the voter signs the form with the use  
14 of a mark instead of the voter's signature. A resident of Kentucky who is a covered  
15 voter as defined in KRS 117A.010 who has received a mail-in~~[an]~~ absentee ballot  
16 transmitted by facsimile machine or by means of the electronic transmission system  
17 established under KRS 117A.030(4) shall transmit the voted ballot to the county  
18 clerk by mail only, conforming with ballot security requirements that may be  
19 promulgated by the State Board of Elections by administrative regulation. In order  
20 to be counted, the ballots shall be received by the county clerk by at least the time  
21 established by the election laws generally for the closing of the polls, which time  
22 shall not include the extra hour during which those voters may vote who were  
23 waiting in line to vote at the scheduled poll closing time.

24 ~~(2) [Any voter who shall be absent from the county on election day, but who does not~~  
25 ~~qualify to receive an absentee ballot by mail under the provisions of KRS 117.085,~~  
26 ~~and] All voters qualified to vote prior to the election under the provisions of Section~~  
27 I of this Act~~[KRS 117.085]~~, shall vote at the main office of the county clerk or

1 other place designated by the county board of elections, and approved by the State  
2 Board of Elections~~[, prior to the day of election]~~. The **county** clerk may provide for~~[~~  
3 ~~such]~~ voting by the voting equipment in general use in the county either at the  
4 precinct~~[, the equipment as may be used to tabulate absentee ballots,]~~ or any other  
5 voting equipment approved by the State Board of Elections for use in Kentucky,  
6 except as follows:

7 (a) Any voter~~[ qualifying to vote in the clerk's office or other place designated by~~  
8 ~~the county board of elections, and approved by the State Board of Elections,]~~  
9 who receives assistance to vote shall complete the voter assistance form  
10 required by KRS 117.255.

11 (b) Any voter~~[ qualifying to vote in the clerk's office or other place designated by~~  
12 ~~the county board of elections, and approved by the State Board of Elections,]~~  
13 whose qualifications are challenged by any clerk or deputy shall complete an  
14 "Oath of Voter" affidavit.

15 (3) When the **county** clerk uses general voting equipment as provided~~[ for]~~ in  
16 subsection (2) of this section, each voter casting his **or her** vote at the **county** clerk's  
17 office or other place designated by the county board of elections, and approved by  
18 the State Board of Elections, shall sign an "***In-Person*** Absentee Ballot Signature  
19 Roster."

20 (4) The **county** clerk shall designate a location within his **or her** office where the ***in-***  
21 ***person absentee*** ballots shall be cast secretly. The county clerk, with the approval  
22 of the State Board of Elections, may establish locations other than his **or her** main  
23 office in which the voters may execute their ***in-person absentee*** ballots. Public  
24 notice of the locations shall be given ***in accordance with***~~[pursuant to]~~ KRS Chapter  
25 424 and similar notice by mail shall be given to the county **chair**~~[chairmen]~~ of the  
26 two (2) political parties whose candidates polled the largest number of votes in the  
27 county at the last **regular**~~[general]~~ election.

- 1 (5) The State Board of Elections shall promulgate administrative regulations to provide  
2 for casting ballots as provided in subsection (2) of this section.
- 3 (6) The county clerk shall deposit all of the absentee ballots returned by mail in a  
4 locked ballot box immediately upon receipt without opening the outer envelope.  
5 The ballot box shall be locked with three (3) locks. The keys to the box shall be  
6 retained by the three (3) members of the central absentee ballot counting board, if  
7 one is appointed, or by the members of the board of elections, and the box shall  
8 remain locked until the ballots are counted. All voting equipment on which ballots  
9 are cast as permitted in subsection (2) of this section shall also remain locked and  
10 the keys shall be retained by the three (3) members of the central absentee ballot  
11 counting board, if one is appointed, or by the members of the board of elections,  
12 and the equipment shall remain locked until the ballots are counted.
- 13 (7) The county clerk shall keep a list for each election of all persons who return their  
14 absentee ballots by mail and who voted in-person in accordance with Section 1 of  
15 this Act~~for who cast their ballots in the clerk's office or other place designated by~~  
16 ~~the county board of elections and approved by the State Board of Elections~~, and  
17 shall send a copy of each list to the State Board of Elections after the election day  
18 for which the list applies. Notwithstanding the provisions of the Kentucky Open  
19 Records Act, KRS 61.870 to 61.884, each list of all persons who return their  
20 absentee ballots by mail or who voted in-person in accordance with Section 1 of  
21 this Act~~cast their ballots in the clerk's office or other designated and approved~~  
22 ~~place~~ shall not be made public until after the close of business hours on the election  
23 day for which the list applies. The county clerk and the Secretary of State shall keep  
24 a record of the number of votes cast by absentee ballots returned by mail and cast in  
25 accordance with Section 1 of this Act~~on the voting machine in the county clerk's~~  
26 ~~office or other place designated by the county board of elections and approved by~~  
27 ~~the State Board of Elections, which are cast in any election] as a part of the official~~

1 returns of the election.

2 (8) The county board of elections shall report to the State Board of Elections within ten  
3 (10) days after any primary or ~~regular~~<sup>general</sup> election as to the number of rejected  
4 mail-in absentee ballots and the reasons for rejected mail-in absentee ballots on a  
5 form prescribed by the State Board of Elections in administrative regulations  
6 promulgated under KRS Chapter 13A.

7 ➔Section 5. KRS 117.087 is amended to read as follows:

- 8 (1) The challenge of an absentee ballot returned by mail shall be in writing and in the  
9 hands of the county clerk before 8 a.m. on election day.
- 10 (2) The county board of elections shall count the absentee ballots returned by mail and  
11 the in-person absentee votes cast in accordance with Section 1 of this Act on the  
12 voting machine in the county clerk's office or other place designated by the county  
13 board of elections and approved by the State Board of Elections. The county board  
14 of elections may appoint a central ballot counting board of not less than three (3)  
15 members, who shall be qualified voters and no more than two-thirds (2/3) of whom  
16 shall be members of the same political party, to count the ballots at the direction of  
17 the county board of elections.
- 18 (3) Beginning at 8 a.m. on election day, the county board of elections shall meet at the  
19 county clerk's office to count the absentee ballots returned by mail and the in-  
20 person ballots cast in accordance with Section 1 of this Act on the voting machine  
21 in the county clerk's office or other place designated by the county board of  
22 elections and approved by the State Board of Elections. Candidates or their  
23 representatives shall be permitted to be present. The county board of elections shall  
24 authorize representatives of the news media to observe the counting of the ballots.  
25 The county board of elections shall open the boxes containing absentee ballots  
26 returned by mail and remove the envelopes one (1) at a time. As each envelope is  
27 removed, it shall be examined to ascertain whether the outer envelope and the

1 detachable flap are in proper order and have been signed by the voter. A person  
2 having power of attorney for the voter and who signs the detachable flap and outer  
3 envelope for the voter shall complete the voter assistance form required by KRS  
4 117.255. The signatures of two (2) witnesses are required if the voter signs the form  
5 with the use of a mark instead of the voter's signature. All unsigned mail-in  
6 absentee ballots shall be rejected automatically. The chair~~chairman~~ of the county  
7 board of elections shall compare the signatures on the outer envelope and the  
8 detachable flap with the signature of the voter that appears on the registration card.  
9 If the outer envelope and the detachable flap are found to be in order, the  
10 chair~~chairman~~ shall read aloud the name of the voter. If the vote of the voter is  
11 not rejected on a challenge then made as provided in subsection (4) of this section,  
12 the chair~~chairman~~ shall remove the detachable flap and place the inner envelope

14 (4) When the name of a voter who cast an absentee ballot by mail is read aloud by the  
15 chair~~chairman~~, the vote of the voter may be challenged by any county board of  
16 elections member or by the written challenge provided in subsection (1) of this  
17 section and the challenge may be determined and the vote accepted or rejected by  
18 the board as if the voter was present and voting in person; but if the outer envelope  
19 and the detachable flap are regular, and substantially comply with the provisions of
