

1 AN ACT relating to special license plates and making an appropriation therefor.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 164 IS CREATED TO
4 READ AS FOLLOWS:

5 (1) *The Kentucky Community and Technical College System special license plate*
6 *student scholarship fund is created as a separate trust fund in the State Treasury.*
7 *The trust fund shall consist of any proceeds from fees from subsection 2(ac) of*
8 *Section 2 of this Act, gifts, grants, contributions, appropriations, or other moneys*
9 *made available for the purposes of the trust fund and shall be used by the*
10 *Kentucky Community College and Technical System to pay for any costs or fees*
11 *incurred in the administration of this fund and for the distribution of*
12 *scholarships.*

13 (2) *The fund shall be administered by the Kentucky Community and Technical*
14 *College System.*

15 (3) *Notwithstanding KRS 45.229, trust fund amounts not expended at the close of a*
16 *fiscal year shall not lapse but shall be carried forward to the next fiscal year.*

17 (4) *Any interest earnings of the trust fund shall become part of the trust fund and*
18 *shall not lapse.*

19 (5) *Moneys in the fund are hereby appropriated for the purposes set forth in*
20 *subsection (1) of this section.*

21 ➔Section 2. KRS 186.162 is amended to read as follows:

22 (1) As used in this section and in KRS 186.043, 186.164, 186.166, 186.1722, and
23 186.174:

24 (a) "Special license plate" means a unique license plate issued under this chapter
25 to a group or organization that readily identifies the operator of the motor
26 vehicle or motorcycle bearing the plate as a member of a group or
27 organization, or a supporter of the work, goals, or mission of a group or

- 1 organization. The term shall not include regular license plates issued under
 2 KRS 186.240;
- 3 (b) "Street rod" means a modernized private passenger motor vehicle
 4 manufactured prior to the year 1949, or designed or manufactured to resemble
 5 a vehicle manufactured prior to 1949;
- 6 (c) "SF" means the portion of an initial or renewal fee to obtain a special license
 7 plate that is dedicated for use by the Transportation Cabinet;
- 8 (d) "CF" means the portion of an initial or renewal fee to obtain a special license
 9 plate that is dedicated for use by a county clerk; and
- 10 (e) "EF" means the portion of an initial or renewal fee to obtain a special license
 11 plate that is mandated by this chapter to be dedicated for use by a particular
 12 group or organization.
- 13 (2) The initial purchase fee and renewal fee for a special license plate created under this
 14 chapter shall be as established in this subsection and includes the name of group or
 15 organization and the total initial and renewal fee required for the plate. The amount
 16 in parentheses indicates how the total fee is required to be divided:
- 17 (a) Disabled veterans who receive assistance to purchase a vehicle from the
 18 United States Department of Veterans' Affairs, veterans declared by the
 19 United States Department of Veterans' Affairs to be one hundred percent
 20 (100%) service-connected disabled, and recipients of the Congressional Medal
 21 of Honor:
- 22 1. Initial Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).
 23 2. Renewal Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).
- 24 (b) Former prisoners of war and survivors of Pearl Harbor:
- 25 1. Initial Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
 26 program trust fund established under KRS 40.460).
 27 2. Renewal Fee: \$3 (\$0 SF/\$3 CF/\$0 EF).

- 1 (c) Members of the Kentucky National Guard and recipients of the Purple Heart:
- 2 1. Initial Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
- 3 program trust fund established under KRS 40.460).
- 4 2. Renewal Fee: \$8 (\$0 SF/\$3 CF/\$5 EF to the veterans'
- 5 program trust fund established under KRS 40.460).
- 6 (d) Members of the Civil Air Patrol; active, retired, veteran, reserve, or auxiliary
- 7 members of the United States Army, Navy, Air Force, Marine Corps, or Coast
- 8 Guard; Merchant Marines who served between December 7, 1941, and August
- 9 15, 1945; recipients of the Silver Star Medal, or the Bronze Star Medal
- 10 awarded for valor; persons who wish to receive Gold Star Mothers, Gold Star
- 11 Fathers, or Gold Star Spouses license plates beyond the two (2) exempted
- 12 from fees under KRS 186.041(6); individuals eligible for a special military
- 13 service academy license plate under KRS 186.041(8); and disabled veterans
- 14 who have been declared to be between fifty percent (50%) and ninety-nine
- 15 percent (99%) service-connected disabled by the United States Department of
- 16 Veterans' Affairs:
- 17 1. Initial Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
- 18 program trust fund established under KRS 40.460).
- 19 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
- 20 program trust fund established under KRS 40.460).
- 21 (e) Recipients of the Distinguished Service Cross, Navy Cross, or Air Force
- 22 Cross:
- 23 1. Initial Fee: \$3 (\$0 SF/\$3 CF/\$0 EF).
- 24 2. Renewal Fee: \$3 (\$0 SF/\$3 CF/\$0 EF).
- 25 (f) Disabled license plates:
- 26 1. Initial Fee: \$15 (\$12 SF/\$3 CF/\$0 EF).
- 27 2. Renewal Fee: \$15 (\$12 SF/\$3 CF/\$0 EF).

- 1 (g) Historic vehicles:
- 2 1. Initial Fee for two plates: \$53 (\$50 SF/\$3 CF/\$0 EF).
- 3 2. Renewal Fee: Do not renew annually.

2 (u) Independent Colleges:

3 1. Initial Fee: \$38 (\$25 SF/\$3 CF/\$10 EF to the Association of
4 Independent Kentucky Colleges and Universities for distribution to the
5 general scholarship funds of the Association's members).

6 2. Renewal Fee: \$25 (\$12 SF/\$3 CF/\$10 EF to the Association of
7 Independent Kentucky Colleges and Universities for distribution to the
8 general scholarship funds of the Association's members).

9 (v) Child Victims:

10 1. Initial Fee: \$38 (\$25 SF/\$3 CF/\$10 EF to the child victims'
11 trust fund established under KRS 41.400).

12 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the child victims'
13 trust fund established under KRS 41.400).

14 (w) Kentucky Horse Council:

15 1. Initial Fee: \$38 (\$25 SF/\$3 CF/\$10 EF to the Kentucky
16 Horse Council).

17 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the Kentucky
18 Horse Council).

19 (x) Ducks Unlimited:

20 1. Initial Fee: \$38 (\$25 SF/\$3 CF/\$10 EF to Kentucky Ducks
21 Unlimited).

22 2. Renewal Fee: \$25 (\$12 SF/\$3 CF/\$10 EF to Kentucky Ducks
23 Unlimited).

24 (y) Spay neuter:

25 1. Initial Fee: \$25 (\$12 SF/\$3 CF/\$10 EF to the animal control
26 and care fund established under KRS 258.119).

27 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the animal control

1 and care fund established under KRS 258.119).

2 (z) Gold Star Mothers, Gold Star Fathers, or Gold Star Spouses:

3 1. Initial Fee: \$0 (\$0 SF/\$0 CF/ \$0 EF).

4 2. Renewal Fee: \$0 (\$0 SF/\$0 CF/ \$0 EF).

5 3. A person may receive a maximum of two (2) plates under this paragraph
6 free of charge and may purchase additional plates for fees as established
7 in subsection (2)(d) of this section.

8 (aa) I Support Veterans:

9 1. Initial Fee: \$25 (\$12 SF/\$3 CF/\$10 EF to the Kentucky
10 Department of Veterans' Affairs).

11 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the Kentucky
12 Department of Veterans' Affairs).

13 (ab) Gold Star Siblings:

14 1. Initial Fee: \$25 (\$12 SF/\$3 CF/\$10 EF to the veterans'
15 program trust fund established under KRS 40.460).

16 2. Renewal Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
17 program trust fund established under KRS 40.460).

18 **(ac) Community and Technical Colleges:**

19 **1. Initial Fee: \$50 (\$37 SF/\$3 CF/\$10 EF to the Kentucky**
20 **Community and Technical College System for distribution to the**
21 **special license plate student scholarship fund established under**
22 **Section 1 of this Act).**

23 **2. Renewal Fee: \$25 (\$12 SF/\$3 CF/\$10 to the Kentucky**
24 **Community and Technical College System for distribution to the**
25 **special license plate student scholarship fund established under**
26 **Section 1 of this Act).**

27 (3) Any special license plate may be combined with a personalized license plate for a

1 twenty-five dollar (\$25) state fee in addition to all other fees for the particular
2 special license plate established in this section and in KRS 186.164(3). The twenty-
3 five dollar (\$25) fee required under this subsection shall be divided between the
4 cabinet and the county clerk of the county where the applicant is applying for the
5 license plate with the cabinet receiving twenty dollars (\$20) and the county clerk
6 receiving five dollars (\$5).

7 (4) Owners and lessees of motorcycles registered under KRS 186.050(2) may be
8 eligible to receive special license plates issued under this section or established
9 under the provisions of KRS 186.164 after the cabinet has received three hundred
10 (300) applications and initial state fees from the sponsoring organization.
11 Applicants for a special license plate for a motorcycle shall be required to pay the
12 fee for a special plate as prescribed in this section or in KRS 186.164. The fee paid
13 for the special plate for a motorcycle shall be in lieu of the registration fee required
14 under KRS 186.050(2).

15 ➔Section 3. KRS 186.166 is amended to read as follows:

16 (1) The Transportation Cabinet shall, unless directed otherwise by the General
17 Assembly, perpetually produce the following special license plates: military license
18 plates, U.S. Congressional license plates, firefighter license plates, emergency
19 management license plates, Fraternal Order of Police license plates, Law
20 Enforcement Memorial license plates, street rod license plates, nature license plates,
21 amateur radio license plates, Kentucky General Assembly license plates, Kentucky
22 Court of Justice license plates, Masonic Order license plates, collegiate license
23 plates, independent college and university license plates, **community and technical**
24 **college system plates**, child victims' trust fund license plates, Kentucky Horse
25 Council license plates, Ducks Unlimited license plates, Gold Star Mothers license
26 plates, Silver Star Medal license plates, Bronze Star Medal license plates, spay
27 neuter license plates, service academy license plates, and I Support Veterans license

1 plates.

2 (2) The design of the plates identified for perpetual production under this section may
3 be revised upon request of a group or organization requesting a design revision
4 under the provisions of KRS 186.164(15).

5 (3) (a) The design of a Purple Heart license plate shall not include any representation
6 of the word "Kentucky" that is a registered trademark or slogan which appears
7 on a general issue license plate.

8 (b) The design of a Purple Heart license plate shall include a representation of the
9 Purple Heart medal and the words "Combat Wounded."
