3 ➔Section 1. KRS 15.010 is amended to read as follows:

4 (1) The Attorney General is the head of the Department of Law.

5 (2) The Department of Law shall include the following major organizational units:

6 (a) ***Department of Criminal Investigations***~~[Criminal Appellate Division];~~

7 (b) ***Office of*** Consumer Protection~~[Division];~~

8 (c) ***Office of Criminal Appeals***~~[Special Investigations Division];~~

9 (d) ***Office of*** Special Prosecutions~~[Division];~~

10 (e) ***Office of*** Prosecutors Advisory Council~~[Services Division];~~

27 ➔Section 2. KRS 13B.010 is amended to read as follows:

1 As used in this chapter, unless the context requires otherwise:

- 2 (1) "Administrative agency" or "agency" means each state board, bureau, cabinet,
3 commission, department, authority, officer, or other entity in the executive branch
4 of state government authorized by law to conduct administrative hearings.
- 5 (2) "Administrative hearing" or "hearing" means any type of formal adjudicatory
6 proceeding conducted by an agency as required or permitted by statute or regulation
7 to adjudicate the legal rights, duties, privileges, or immunities of a named person.
- 8 (3) "Party" means:
- 9 (a) The named person whose legal rights, duties, privileges, or immunities are
10 being adjudicated in the administrative hearing;
- 11 (b) Any other person who is duly granted intervention in an administrative
12 hearing; and
- 13 (c) Any agency named as a party to the adjudicatory proceeding or entitled or
14 permitted by the law being enforced to participate fully in the administrative
15 hearing.
- 16 (4) "Agency head" means the individual or collegial body in an agency that is
17 responsible for entry of a final order.
- 18 (5) "Recommended order" means the whole or part of a preliminary hearing report to an
19 agency head for the disposition of an administrative hearing.
- 20 (6) "Final order" means the whole or part of the final disposition of an administrative
21 hearing, whenever made effective by an agency head, whether affirmative, negative,
22 injunctive, declaratory, agreed, or imperative in form.
- 23 (7) "Hearing officer" means the individual, duly qualified and employed pursuant to
24 this chapter, assigned by an agency head as presiding officer for an administrative
25 hearing or the presiding member of the agency head.
- 26 (8) "~~Office~~~~[Division]~~" means the *Office of Civil and Environmental Law*~~[Division of~~
27 ~~Administrative Hearings]~~ in the Office of the Attorney General~~[created pursuant to~~

1 ~~KRS 15.111.~~

2 ➔Section 3. KRS 13B.030 is amended to read as follows:

3 (1) An agency head may exercise all powers conferred on an agency relating to the
4 conduct of administrative hearings, and he may delegate conferred powers to a
5 hearing officer or a member of a collegial body that serves as an agency head, or he
6 may delegate conferred powers to a hearing officer to conduct an administrative
7 hearing before a hearing panel, reserving the authority to render a recommended
8 order to that panel. An agency head may not, however, delegate the power to issue a
9 final order unless specifically authorized by statute, or unless disqualified in
10 accordance with KRS 13B.040(2).

11 (2) (a) In securing hearing officers as necessary to conduct administrative hearings
12 under the jurisdiction of the agency, an agency may:

- 13 1. Employ hearing officers;
- 14 2. Contract with another agency for hearing officers; or
- 15 3. Contract with private attorneys through personal service contract.

16 (b) An agency may secure hearing officers pursuant to subsection (2)(a)3. of this
17 section only if the Attorney General has first determined that the Attorney
18 General's Office cannot provide the needed hearing officers to the agency. If
19 the Attorney General determines that the Attorney General's Office can
20 provide the needed hearing officers to the agency, the agency shall use the
21 hearing officers provided by the Attorney General's Office. The expenses
22 incurred by the Attorney General's Office in providing the hearing officers to
23 the agency shall be paid to the Attorney General's Office by the agency in the
24 following manner:

- 25 1. The amount to be paid by the agency to the Attorney General's Office
26 shall be established by vouchers submitted by the Attorney General's
27 Office to the agency which shall be promptly paid by the agency, at the

- 1 beginning of, at the end of, or at any time during the provision of the
2 hearing officers by the Attorney General's Office.
- 3 2. The expenses to be paid to the Attorney General's Office shall be
4 calculated according to the amount of time spent by the salaried hearing
5 officers of the Attorney General's Office in providing the services. The
6 charge for time spent shall not exceed twenty-five percent (25%) more
7 than the amount allowed for a sole practitioner under personal service
8 contract. The Attorney General may require payment in advance of the
9 provision of the requested services based on his calculation of the
10 amount of time that will be spent by the salaried hearing officers of the
11 Attorney General's Office in providing the services. The agency shall be
12 reimbursed for any overpayment at the conclusion of the provision of
13 services by the Attorney General's Office.
- 14 (3) A hearing officer shall possess and meet qualifications as the Personnel Cabinet and
15 the employing agency, with the advice of the office~~[division]~~, may find necessary to
16 assure competency in the conduct of an administrative hearing. The qualifications in
17 this subsection shall not, however, apply to a member of a board, commission, or
18 other collegial body who may serve as a hearing officer in his capacity as a member
19 of the collegial body.
- 20 (4) All hearing officers, including members of collegial bodies who serve as hearing
21 officers, shall receive training necessary to prepare them to conduct a competent
22 administrative hearing. The training shall pertain to the conduct of administrative
23 hearings generally and to the applications of the provisions of this chapter,
24 specifically. The office~~[division]~~ shall establish by administrative regulation
25 minimum standards concerning the length of training, course content, and instructor
26 qualifications. Required training shall not exceed eighteen (18) classroom hours for
27 initial training and six (6) classroom hours per year for continuing training. Actual

1 training may be conducted by an agency or any other organization, if the training
2 program offered has been approved by the office~~[division]~~ as meeting minimum
3 standards.

5 ~~[(1)]~~The *Office of Civil and Environmental Law in the Office of the Attorney*

8 ~~[(2)]~~~~This division~~ shall have the following responsibilities:

9 (1)~~[(a)]~~ Employing and maintaining a pool of hearing officers for assignment to the
10 individual agencies at their request, for the conduct of administrative hearings. The
11 Attorney General's office may also employ other staff as necessary to carry out
12 functions and responsibilities assigned by KRS Chapter 13B;

13 (2)~~[(b)]~~ Reviewing and approving or disapproving requests from agencies for waivers
14 from provisions of KRS Chapter 13B;

15 (3)~~[(c)]~~ Providing training in administrative hearing procedures for hearing officers as

17 contracting with appropriate organizations for the provision of training, or by

20 establishment of relevant and appropriate qualifications for classes of hearing
21 officers;

22 (5)~~[(e)]~~ Establishing, in cooperation with the Office~~[Division]~~ of Consumer
23 Protection, a clearinghouse for complaints concerning the administrative hearing
24 process in Kentucky. Each complaint received shall be referred to the agency that is
25 the subject of the complaint, and the action of the agency to resolve the complaint
26 shall be noted and reported to the *Office of Civil and Environmental*
27 *Law*~~[division]~~;

1 ~~(6)~~~~(f)~~ Reporting to the Legislative Research Commission by July 1 of each odd-
2 numbered year, the status of the administrative hearing process in Kentucky. The
3 report shall include a compilation of statistical data and other information necessary
4 to assess the effectiveness and efficiency of hearing procedures and
5 recommendations for making improvements to the system. Agencies shall provide
6 the information requested by the Office of Civil and Environmental Law~~[Division~~
7 ~~of Administrative Hearings]~~ necessary to complete the report.

8 ➔Section 5. KRS 15.113 is amended to read as follows:

9 (1) The Office of the Attorney General~~[Financial Integrity Enforcement Division is~~
10 ~~created in the Department of Law. The division]~~ shall:

- 11 (a) Investigate illegal redemption of food stamp benefits in cooperation with the
12 United States Department of Agriculture and the Cabinet for Health and
13 Family Services;
- 14 (b) Verify eligibility of food stamp program applicants as to past criminal history;
- 15 (c) Investigate the illegal distribution of counterfeit merchandise; and
- 16 (d) Investigate the use of personal identification and financial information by
17 persons for the purpose of theft, or fraud, or both theft and fraud, and other
18 illegal or fraudulent activity which may involve electronic commerce.

19 (2) The Office of the Attorney General shall coordinate with the Department of
20 Financial Institutions, the United States Secret Service, the Federal Trade
21 Commission, the Kentucky Bankers' Association, and any other agency or
22 organization to prepare and disseminate information to prevent identity theft.

23 ➔Section 6. KRS 15.753 is amended to read as follows:

24 (1) This section shall apply to:

- 25 (a) The Attorney General and his staff;
- 26 (b) A county attorney and his staff; and
- 27 (c) A Commonwealth's attorney and his staff.

- 1 (2) A person named in subsection (1) of this section who is sued for any act or omission
2 in the course of his duties and who has a judgment for monetary damages rendered
3 against him and who personally suffers actual financial loss, unreimbursed from any
4 source, by the enforcement and satisfaction of the judgment, including any costs or
5 attorney's fees awarded pursuant thereto, shall be indemnified by the
6 Commonwealth from funds appropriated to the Finance and Administration Cabinet
7 for the payment of judgments, to the extent of his actual financial loss.
- 8 (3) The indemnification shall be contingent upon an express determination by the
9 Prosecutors~~Prosecutor's~~ Advisory Council that the act or omission which resulted
10 in liability was within the scope and course of the officer's employment and
11 occurred during the performance of duty and was committed or omitted in the good
12 faith belief that the act or omission was lawful and proper.
- 13 (4) If the officer seeking indemnification is the Attorney General, the determination
14 referred to in subsection (3) of this section shall be made by the Governor.
- 15 (5) The indemnification shall not be construed to abrogate or limit any privilege,
16 immunity, or matter of defense otherwise available to the person claiming
17 indemnification and shall not constitute a waiver of any privilege, immunity, or
18 matter or defense including the sovereign immunity of the Commonwealth.
- 19 (6) The indemnification shall not be the subject of comment, directly or indirectly,
20 before any jury hearing any cause of action in which the Attorney General, a county
21 or Commonwealth's attorney, or a member of their staff is a party, and any comment
22 before the jury shall result in an immediate mistrial.
- 23 ➔Section 7. KRS 189A.050 is amended to read as follows:
- 24 (1) All persons convicted of violation of KRS 189A.010(1)(a), (b), (c), (d), or (e) shall
25 be sentenced to pay a service fee of three hundred seventy-five dollars (\$375),
26 which shall be in addition to all other penalties authorized by law.
- 27 (2) The fee shall be imposed in all cases but shall be subject to the provisions of KRS

1 534.020 relating to the method of imposition and KRS 534.060 as to remedies for
2 nonpayment of the fee.

3 (3) The first fifty dollars (\$50) of each service fee imposed by this section shall be paid
4 into the general fund, and the remainder of the revenue collected from the service
5 fee imposed by this section shall be utilized as follows:

6 (a) Twelve percent (12%) of the amount collected shall be transferred to the
7 Department of Kentucky State Police forensic laboratory for the acquisition,
8 maintenance, testing, and calibration of alcohol concentration testing
9 instruments and the training of laboratory personnel to perform these tasks;

10 (b) Twenty percent (20%) of the service fee collected pursuant to this section
11 shall be allocated to the Department for Public Advocacy;

12 (c) One percent (1%) shall be transferred to the Prosecutors~~[Prosecutor's]~~
13 Advisory Council for training of prosecutors for the prosecution of persons
14 charged with violations of this chapter and for obtaining expert witnesses in
15 cases involving the prosecution of persons charged with violations of this
16 chapter or any other offense in which driving under the influence is a factor in
17 the commission of the offense charged;

18 (d) Sixteen percent (16%) of the amount collected shall be transferred as follows:

19 1. Fifty percent (50%) shall be credited to the traumatic brain injury trust
20 fund established under KRS 211.476; and

21 2. Fifty percent (50%) shall be credited to the Cabinet for Health and
22 Family Services, Department for Behavioral Health, Developmental and
23 Intellectual Disabilities, for the purposes of providing direct services to
24 individuals with brain injuries that may include long-term supportive
25 services and training and consultation to professionals working with
26 individuals with brain injuries. As funding becomes available under this
27 subparagraph, the cabinet may promulgate administrative regulations

1 pursuant to KRS Chapter 13A to implement the services permitted by
2 this subparagraph;

3 (e) Any amount specified by a specific statute shall be transferred as provided in
4 that statute;

5 (f) Forty-six percent (46%) of the amount collected shall be transferred to be
6 utilized to fund enforcement of this chapter and for the support of jails,
7 recordkeeping, treatment, and educational programs authorized by this chapter
8 and by the Department for Public Advocacy; and

9 (g) The remainder of the amount collected shall be transferred to the general fund.

10 (4) The amounts specified in subsection (3)(a), (b), (c), and (d) of this section shall be
11 placed in trust and agency accounts that shall not lapse.

12 ➔Section 8. KRS 205.712 is amended to read as follows:

13 (1) The Department for Income Support, Child Support Enforcement, is established in
14 the Cabinet for Health and Family Services.

15 (2) The duties of the Department for Income Support, Child Support Enforcement, or
16 its designee, shall include:

17 (a) Serve as state agency authorized to administer Part D of Title IV of the Social
18 Security Act, 42 U.S.C. secs. 651 to 669;

19 (b) Serve as the information agency as provided in the Uniform Interstate Family
20 Support Act, KRS Chapter 407;

21 (c) Serve as collector of all court-ordered or administratively ordered child
22 support payments pursuant to Part D of Title IV of the Social Security Act;

23 (d) Serve as the agent for enforcement of international child support obligations,
24 and respond to requests from foreign reciprocating countries;

25 (e) Establish and enforce an obligation upon receipt of a completed, notarized
26 voluntary acknowledgment-of-paternity form;

27 (f) Enforce Kentucky child support laws, including collection of court-ordered or

- 1 administratively ordered child support arrearages and prosecution of persons
2 who fail to pay child support;
- 3 (g) Publicize the availability of services and encourage the use of these services
4 for establishing paternity and child support;
- 5 (h) Pay the cost of genetic testing to establish paternity, subject to recoupment
6 from the alleged father, when paternity is administratively or judicially
7 determined; and obtain additional testing when an original test is contested,
8 upon request and advance payment by the contestant;
- 9 (i) Establish child support obligations and seek modification of judicially or
10 administratively established child support obligations in accordance with the
11 child support guidelines of the Commonwealth of Kentucky as provided under
12 KRS 403.212;
- 13 (j) Administratively establish child support orders which shall have the same
14 force and effect of law;
- 15 (k) Issue an administrative subpoena to secure public and private records of utility
16 and cable companies and asset and liability information from financial
17 institutions for the establishment, modification, or enforcement of a child
18 support obligation;
- 19 (l) Impose a penalty for failure to comply with an administrative subpoena;
- 20 (m) Provide notices, copies of proceedings, and determinations of support
21 amounts to any parties or individuals who are applying for or receiving Title
22 IV-D services, or who are parties to cases in which Title IV-D services are
23 being provided;
- 24 (n) Issue interstate administrative subpoenas to any individual or entity for
25 financial or other information or documents which are needed to establish,
26 modify, or enforce a child support obligation pursuant to Part D of Title IV of
27 the Social Security Act, 42 U.S.C. secs. 651 et seq. An administrative

1 subpoena lawfully issued in another state to an individual or entity residing in
2 this state shall be honored and enforced in the Circuit Court where the
3 individual or entity resides; and

4 (o) May promulgate administrative regulations to implement this section and
5 adopt forms or implement other requirements of federal law relating to
6 interstate administrative subpoenas.

7 (3) Effective September 30, 1999, the cabinet shall establish a system to receive and
8 process all child support payments. The system shall include existing computer
9 systems to record the payments. The automated system shall include a state case
10 registry that contains records with respect to each case in which services are being
11 provided by the cabinet and each child support order established or modified in the
12 state on or after October 1, 1998.

13 (4) The cabinet shall establish and operate a state disbursement unit for the collection,
14 disbursement, and recording of payments under support orders for all Title IV-D
15 cases and for all cases initially issued in the state on or after January 1, 1994, in
16 which a wage withholding has been court-ordered or administratively ordered,
17 pursuant to Part D of Title IV of the Social Security Act. Establishment of the state
18 unit may include the designation and continuation of existing local collection units
19 to aid efficient and effective collection, disbursement, and recording of child
20 support payments.

21 (5) After the establishment of the disbursement unit child support collection system, the
22 cabinet or its designee shall serve as collector of all court-ordered or
23 administratively ordered child support payments pursuant to Part D of Title IV of
24 the Social Security Act.

25 (6) Where establishment of paternity and enforcement and collection of child support is
26 by law the responsibility of local officials, the cabinet shall refer cases to the
27 appropriate official for such action. The cabinet may enter into cooperative

1 arrangements with appropriate courts and law enforcement officials to assist the
2 cabinet in administering the program of child support recovery, including the
3 entering into of financial arrangements with such courts and officials as provided
4 for under the provisions of federal law and regulations. The local county attorney
5 shall be considered the designee of the cabinet for purposes of administering the
6 program of child support recovery within a county, subject to the option of the
7 county attorney to decline such designation. Nothing in this section shall prevent the
8 secretary from taking such action, with prior written notice, as appropriate if the
9 terms and conditions of the cooperative agreement are not met. When a cooperative
10 agreement with a contracting official is canceled for good cause, the cabinet may
11 not offer that cooperative agreement to that official during the official's tenure.

12 (7) Where the local county attorney, friend of the court, domestic relations agent, or
13 other designee of the cabinet has been contracted for the purpose of administering
14 child support enforcement pursuant to Title IV-D of the Social Security Act, the
15 contracting official shall be deemed to be representing the cabinet and as such does
16 not have an attorney-client relationship with the applicant who has requested
17 services pursuant to Title IV-D of the Social Security Act nor with any dependent
18 on behalf of the individuals for whom services are sought.

19 (8) The cabinet shall determine the name of each obligor who owes an arrearage of at
20 least two thousand five hundred dollars (\$2,500). After notification to the obligor
21 owing an arrearage amount of two thousand five hundred dollars (\$2,500), the
22 cabinet shall transmit to the United States secretary of health and human services
23 the certified names of the individuals and supporting documentation for the denial,
24 revocation, or limitation of the obligor's passport. The cabinet shall notify the
25 identified obligor of the determination and the consequences and provide an
26 opportunity to contest the determination.

27 (9) The cabinet shall determine the name of an obligor owing an arrearage and shall

- 1 indefinitely deny, suspend, or revoke a license or certification that has been issued if
2 the person has a child support arrearage that equals or exceeds the amount that
3 would be owed after six (6) months of nonpayment or fails, after receiving
4 appropriate notice, to comply with subpoenas or warrants relating to paternity or
5 child support proceedings as provided by 42 U.S.C. sec. 666(a)(16).
- 6 (10) The cabinet shall forward the name of the individual to a board of licensure or
7 board of certification for the notification of the denial, revocation, or suspension of
8 a driver's license, professional license or certification, occupational license or
9 certification, recreational license, or sporting license.
- 10 (11) The denial or suspension shall remain in effect until the child support arrearage has
11 been eliminated or payments on the child support arrearage are being made in
12 accordance with a court or administrative order, the person complies with the
13 subpoena or warrant relating to paternity or child support proceedings, or the appeal
14 of the denial or suspension is upheld and the license is reinstated.
- 15 (12) Except for cases administered by the cabinet under 42 U.S.C. secs. 651 et seq.
16 which shall be afforded the appeal process set forth by KRS 405.450(3), an
17 individual who has a license or certification denied, revoked, or suspended shall
18 have the right to appeal to the licensing or certifying board.
- 19 (13) A dispute hearing shall be conducted by the cabinet in accordance with KRS
20 405.450. The only basis for a dispute hearing shall be a mistake in fact.
- 21 (14) The cabinet shall in its discretion enter into agreements with financial institutions
22 doing business in the Commonwealth to develop and operate, in coordination with
23 the financial institutions, a data match system as required by KRS 205.772 to
24 205.778.
- 25 (15) The cabinet may issue both intrastate and interstate administrative subpoenas to any
26 individual or entity for financial or other information or documents that are needed
27 to establish, modify, or enforce a child support obligation pursuant to Title IV-D of

1 the Social Security Act, 42 U.S.C. secs. 651 et seq. An administrative subpoena
 2 lawfully issued in another state to an individual or entity in this state shall be
 3 honored and enforced in the Circuit Court of the county in which the individual or
 4 entity resides.

5 (16) ~~[The Cabinet for Health and Family Services shall forward to the Office of the~~
 6 ~~Attorney General a list of names of delinquent obligors and, in cooperation with the~~
 7 ~~Office of the Attorney General, shall promulgate administrative regulations in~~
 8 ~~accordance with KRS Chapter 13A to implement KRS 15.055.~~

9 ~~(17)~~ The cabinet shall compare a quarterly report provided by the Finance and
 10 Administration Cabinet of all tort claims made against the state by individuals with
 11 the child support database to match individuals who have a child support arrearage
 12 and may receive a settlement from the state.

13 (17)~~(18)~~ The cabinet shall prepare and distribute to the cabinet's designee for the
 14 administration of the child support program information on child support
 15 collections and enforcement. The information shall include a description of how
 16 child support obligations are:

- 17 (a) Established;
- 18 (b) Modified;
- 19 (c) Enforced;
- 20 (d) Collected; and
- 21 (e) Distributed.

22 (18)~~(19)~~ The cabinet's designee for the administration of the child support program
 23 shall distribute, when appropriate, the following:

- 24 (a) Information on child support collections and enforcement; and
- 25 (b) Job listings posted by employment services.

26 ➔Section 9. KRS 205.8465 is amended to read as follows:

27 (1) Any person who knows or has reasonable cause to believe that a violation of this

1 chapter has been or is being committed by any person, corporation, or entity, shall
2 report or cause to be reported to the **Office of Medicaid Fraud and Abuse Control**
3 **in the Office of the Attorney General**~~[state Medicaid Fraud Control Unit]~~, or the
4 Medicaid fraud and abuse hotline, the following information, if known:

- 5 (a) The name and address of the offender;
- 6 (b) The offender's place of employment;
- 7 (c) The nature and extent of the violation;
- 8 (d) The identity of the complainant; and
- 9 (e) Any other information that the receiving person reasonably believes might be
10 helpful in investigation of the alleged fraud, abuse, or misappropriation.

11 The **Office of Medicaid Fraud and Abuse Control**~~[state Medicaid Fraud Control~~
12 ~~Unit]~~ shall periodically publicize the provisions of this subsection.

13 (2) The identity of any person making a report under this section shall be considered
14 confidential by the receiving party. Any person making a report under this section
15 regarding the offenses of another shall not be liable in any civil or criminal action
16 based on the report if it was made in good faith.

17 (3) No employer shall, without just cause, discharge or in any manner discriminate or
18 retaliate against any person who in good faith makes a report required or permitted
19 by KRS 205.8451 to 205.8483, testifies, or is about to testify, in any proceeding
20 with regard to any report or investigation. Any individual injured by any act in
21 violation of the provisions of this subsection shall have a civil cause of action in
22 Circuit Court to enjoin further violations, and to recover the actual damages
23 sustained, together with the costs of the lawsuit, including a reasonable fee for the
24 individual's attorney of record.

27 the prospective consumer/investor of the business opportunity will be doing

4 chief executive officers, and the names, home addresses, and home telephone
5 numbers of all representatives selling business opportunities in Kentucky.

7 business opportunity has conducted a business of the type being offered both
8 within and without Kentucky.

9 (d) A statement as to whether the person or company offering the business
10 opportunity or any of its directors or chief executive officers or sales
11 representatives operating in Kentucky is currently involved in litigation or has
12 been held liable in a civil action by final judgment for having engaged in
13 unfair, false, misleading, or deceptive practices or is currently charged with or
14 has been convicted of or pleaded nolo contendere to a felony involving fraud,

26 (f) A statement disclosing the names, addresses, and telephone numbers of all
27 persons who have been sold a business opportunity by the offeror within the

- 2 (g) A statement listing the names and addresses of any consumer/investor who
3 has requested within the preceding three (3) years that the offeror return his
4 money.
- 5 (h) A current audited financial statement of the offeror.
- 6 (i) A specimen of each contract proposed for use in connection with the business
7 opportunity.
- 8 (j) A full and detailed description of the actual services that the offeror of the
9 business opportunity undertakes to perform for the consumer/investor.
- 10 (k) If training is promised by the offeror, a complete description of the training,
11 including length of the training and costs.
- 12 (2) The offeror shall immediately notify the office~~[division]~~ of any material change in
13 information contained in the application for registration and shall make appropriate
14 amendment of the disclosure statement.
- 15 (3) The office~~[division]~~ shall collect, from any offeror required to comply with this
16 section, an initial fee of one hundred fifty dollars (\$150), and an annual renewal fee
17 of fifty dollars (\$50), and an update fee of twenty-five dollars (\$25) for the
18 administration and enforcement of KRS 367.801 to 367.819. Funds so collected
19 shall be credited to a trust or agency account for the administrative purpose of the
20 Attorney General's Office~~[office, Division]~~ of Consumer Protection.
- 21 (4) The Attorney General may promulgate administrative regulations as needed to
22 provide for: a hearing, to be conducted in accordance with KRS Chapter 13B, for
23 any business opportunity which the Attorney General initially determines should not
24 be registered or should have registration revoked or suspended; for the
25 establishment of specific standards for the form and content of the disclosure
26 document; and for registration procedures including fee schedules.
- 27 ➔Section 20. KRS 367.807 is amended to read as follows:

- 1 (1) An offeror is exempt from the provisions of KRS 367.801 to 367.819 and KRS
2 367.990 when the offeror:
- 3 (a) Meets the definition of a franchise as defined in the Federal Trade
4 Commission's Regulation on Disclosure Requirements and Prohibitions
5 Concerning Franchising and Business Opportunity Ventures, as set forth in 16
6 C.F.R. 436 et seq., and has complied with these and filed written notice so
7 stating with the office[division]; or
- 8 (b) Offers a security pursuant to KRS 292.313;
- 9 (c) Offers an ongoing business for sale; or
- 10 (d) Offers a not-for-profit sale of sales demonstration equipment, materials, or
11 samples for use in making sales and not for resale for a total price of \$500 or
12 less.
- 13 (2) The Attorney General may promulgate administrative regulations as needed to
14 provide for additional exemptions. Is offering to sell or selling a package franchise
15 as described in KRS 367.801(7).
- 16 ➔Section 21. KRS 367.809 is amended to read as follows:
- 17 (1) The office[division], after ascertaining that the applicant has complied with KRS
18 367.805, shall issue a registration number.
- 19 (2) It shall be unlawful for the registrant to fail to include the registration number in any
20 advertising.
- 21 ➔Section 22. KRS 367.811 is amended to read as follows:
- 22 It shall be unlawful for any offeror to make any oral or written representation, actual or
23 hypothetical, regarding the business opportunity's potential sales, income, gross or net
24 profit unless such sales, income, or profits are examples based upon the actual earnings
25 made by existing consumer/investors of the business opportunity. Upon request by the
26 office[division], names and addresses of the consumer/investors shall be made available
27 for verification of the earnings claims. If such actual or hypothetical earnings examples

1 are in excess of the average net earnings realized by all of the consumer/investors of the
2 business opportunity, then there must be a full and complete disclosure of the average net
3 earnings actually realized by all of these consumer/investors.

4 ➔Section 23. KRS 367.813 is amended to read as follows:

- 5 (1) Prior to the solicitation of potential consumer/investors the offeror shall furnish and
6 display to the potential consumer/investor a copy of the material required to be
7 furnished the office~~[division]~~ when registering pursuant to KRS 367.805.
- 8 (2) When furnishing the information required by subsection (1) of this section, the
9 offeror shall furnish the prospective consumer/investor with a notice in at least ten
10 (10) point bold-face type, stating that registration with the office~~[division]~~ does not
11 directly or indirectly imply approval by the office~~[division]~~ or the Commonwealth
12 of Kentucky of the business opportunity or any of the activities of representatives
13 selling such business opportunities.

14 ➔Section 24. KRS 367.815 is amended to read as follows:

- 15 (1) Any person who offers a business opportunity and makes representations that are
16 false, misleading, or deceptive shall be liable to the consumer/investor of such
17 business opportunity in an amount equal to the sum of his actual damages or fifteen
18 hundred dollars (\$1,500), whichever is greater, as well as the cost of the action
19 together with reasonable attorney's fees, as determined by the court.
- 20 (2) (a) All persons registering pursuant to KRS 367.805 shall either furnish a bond by
21 a surety company authorized to do business in the Commonwealth or establish
22 a full cash certificate of deposit with a licensed and insured bank or savings
23 institution located in the Commonwealth to insure the veracity of all
24 statements contained in the registration. The amount of the bond or certificate
25 of deposit shall be in an amount equal to the total amount of the initial
26 payments under all business opportunity agreements the offeror has entered
27 into in the Commonwealth during the previous year but in no case shall the

1 amount be less than seventy-five thousand dollars (\$75,000). The bond or
2 certificate of deposit shall be in the favor of the Attorney General of

15 maintain a complete set of books, records, and accounts of its business opportunity
16 sales. The sale documents shall be maintained on each transaction for a period of

20 (1) Any person, corporation, partnership, association, or group intending to open or

22 (a) File a registration statement, accompanied by a one hundred dollar (\$100)
23 initial registration fee, with the Attorney General's Office~~[Division]~~ of
24 Consumer Protection prior to the sale of any memberships in the
25 Commonwealth of Kentucky. Such a registration statement shall contain the
26 name and address of the health spa; the names and addresses of the officers,

13 Consumer Protection on or before July 1 of each year following the opening of the
14 health spa.

15 (3) Each health spa selling contracts on a prepayment basis shall deposit all funds
16 received from such contracts in an escrow account until the health spa has remained
17 open for a period of thirty (30) days. At the end of this thirty (30) day period, such
18 prepayment funds shall be eligible for withdrawal at the depositor's discretion.

19 (4) Each health spa registering pursuant to this statute shall maintain in the files of the
20 health spa, a copy of its registration statement filed pursuant to this section. This

24 account for the administrative purposes of the Attorney General's Office~~[Division]~~

26 (6) Each separate location where health spa services are offered shall be considered a
27 separate health spa and shall file a separate registration statement and surety bond,

1 even though the separate locations are owned or operated by the same owner.

2 ➔Section 26. KRS 367.906 is amended to read as follows:

3 (1) The surety bond required by KRS 367.905(1)(b) shall be in favor of the Attorney
4 General's Office~~[Division]~~ of Consumer Protection and shall be held for
5 compensation to any member who suffers loss of money paid due to the insolvency
6 of the health spa, cessation of operation of the health spa, or failure of the health spa
7 to open for business within ninety (90) days from the sale of the first contract.

8 (2) The bond shall be in a form prescribed by the Attorney General's Office~~[Division]~~
9 of Consumer Protection and shall be issued by a company authorized to transact
10 business in the Commonwealth of Kentucky.

11 (3) The amount of the bond shall be computed as follows:

17 (4) The Attorney General's Office~~[Division]~~ of Consumer Protection shall exempt a spa
18 from the bonding requirement if all of its unexpired contracts and present
19 membership plans meet the following criteria:

20 (a) No initiation fee, or similar nonrecurring fee, is charged at or near the
21 beginning of the contract term or renewal period, and

22 (b) At no time is any member charged for use of facilities or services more than
23 thirty-one (31) days in advance.

24 (5) If, because of an increase in membership or change in membership plans, a spa is
25 required to file a bond or increase the amount of its bond, it shall notify the
26 Attorney General's Office~~[Division]~~ of Consumer Protection in writing at least
27 thirty (30) days prior to the expected change. No contract in excess of the limits

1 stated in subsection (3) of this section or not in compliance with subsection (4) of
2 this section shall be sold until a new bond in the required amount has been
3 provided.

4 (6) A change in ownership shall not release, cancel or terminate liability under any
5 bond previously filed unless the Attorney General's Office of Consumer Protection~~[~~
6 ~~Division]~~ agrees in writing to the release, cancellation or termination because the
7 new owner has filed a new bond for the benefit of the previous owner's members, or
8 because the former owner has paid the required refunds to its members.

9 ➔Section 27. KRS 367.932 is amended to read as follows:

10 As used in KRS 367.934 to 367.974 and 367.991, unless the context requires otherwise:

11 (1) "Attorney General" means the Office~~[Division]~~ of Consumer Protection in the
12 Office~~[office]~~ of the Attorney General.

13 (2) "Financial institution" means a bank, trust company, federally chartered credit
14 union, or savings and loan association authorized by law to do business in this state.

15 (3) "Preneed burial contract" means a contract, which has for a purpose the furnishing
16 or performance of funeral services, or the furnishing or delivery of personal
17 property, merchandise, or services of any nature in connection with the final
18 disposition of a dead human body, for future use at a time determinable by the death
19 of the person whose body is to be disposed of; but does not mean the furnishing of a

22 corporation receiving any payments on a preneed funeral contract.

23 (5) "Trustee" means the financial institution.

24 (6) "Person" means an individual, corporation, partnership, joint venture, association,

26 an individual employee of an entity registered pursuant to KRS 367.934 to 367.974
27 and 367.991 shall not be required to comply with the registration requirement

- 1 herein.
- 2 (7) "Remains" means the bodies of deceased persons, in whatever stage of
3 decomposition, and cremated remains.
- 4 (8) "Cemetery" means any one (1) or combination of more than one (1) of the following
5 in a place used or to be used and dedicated or designated for such purposes:
- 6 (a) A burial park, for earth interment.
- 7 (b) A mausoleum, for entombment.
- 8 (c) A columbarium, for inurnment.
- 9 (9) "Mausoleum" means a building or structure substantially exposed above ground
10 used or intended to be used for the entombment of human remains, which is sold or
11 offered for sale to the public.
- 12 (10) "Columbarium" means a structure or building substantially exposed above ground
13 intended to be used for the inurnment of cremated remains and sold or offered for
14 sale to the public.
- 15 (11) "Columbarium niche" means an inurnment space in a columbarium as defined
16 herein.
- 17 (12) "Cemetery company" means any person who conducts the business of a cemetery.
18 Excepted are small community cemeteries, their agents, lessees and otherwise that
19 operate nonprofit; have no salaried employees, directors, officers or managers other
20 than maintenance caretakers; are owned, controlled by lot owners; and do not sell
21 any preneed merchandise or services.
- 22 (13) "Grave space" means a space of ground in a cemetery intended to be used for the
23 interment in the ground of the remains of one (1) human being.
- 24 (14) "Underground crypt" means a single unit entombment space in preplaced chambers
25 below ground and also known as lawn crypt, westminister turftop mausoleum or
26 below ground crypt.
- 27 (15) "Bank of underground crypts" means any construction unit of twenty (20) or more

1 underground crypts designed as a part of a below ground crypt program, whether
2 physically connected or not, having a common drainage system.

3 (16) "Mausoleum crypt" means an entombment space in a mausoleum as defined herein.

4 (17) "Cemetery merchandise" means urns, memorials, monuments, markers, vases,
5 foundations, memorial bases, and other similar personal property commonly sold by
6 or used in cemeteries.

7 (18) "Preneed cemetery merchandise contract" means any agreement or contract, or any
8 series or combination of agreements or contracts, which has for a purpose the
9 furnishing or delivery of cemetery merchandise, which within six (6) months of the
10 date of the contract is not attached to the realty and permanently installed or which
11 is not stored in a bonded warehouse with the receipt of ownership issued by the
12 manufacturer in the name of the purchaser and transmitted to the purchaser.

13 ➔Section 28. KRS 367.954 is amended to read as follows:

14 (1) Forty percent (40%), not including interest or finance charges, of all payments of
15 money made to any person, partnership, association, or corporation upon any
16 agreement or contract, or any series or combination of agreements or contracts,
17 which has for a purpose the furnishing or delivery of cemetery merchandise, which
18 within six (6) months of the date of the contract is not delivered by attachment to
19 the realty and permanent installation or which is not stored in a bonded warehouse
20 with the receipt of ownership issued by the manufacturer in the name of the
21 purchaser and transmitted to the purchaser are held to be trust funds. The person,
22 partnership, association, or corporation receiving the payments shall deposit forty
23 percent (40%) of all payments received on a preneed cemetery merchandise contract
24 in a trust fund account within six (6) months of the date of contract, and forty
25 percent (40%) of all payments received thereafter on said contract shall be deposited
26 in the trust fund account within thirty (30) days after each calendar quarter of
27 operation. The trustee shall be the financial institution holding said funds. All of the

1 interest, dividends, increases, or accretions of whatever nature earned by the funds
2 deposited in a trust account shall remain with the principal of such account and
3 become a part thereof, subject to all of the regulations concerning the principal of
4 said fund herein contained.

5 (2) All trust funds mentioned in this section shall be deposited in the name of the
6 person making said deposits, with the financial institution as trustee, and shall be
7 held together with the interest, dividends, or accretions thereon, in trust, subject to
8 the provisions of KRS 367.932 to 367.974 and 367.991. The person at the time of
9 making deposit or investment shall furnish to the financial institution the name of
10 each payor, and the amount of payment on each account for which the deposit or
11 investment is being made.

12 (3) Forty percent (40%) of all payments, not including interest or finance charges, made
13 under the agreement, contract, or plan are and shall remain trust funds with the
14 financial institution, until the financial institution receives a sworn affidavit from
15 the depositor stating one of the following:

16 (a) That the delivery of all merchandise by attachment to the realty, or permanent
17 installation of the merchandise has been completed and that there has been full
18 performance of all services called for by the agreement, contract or plan; or

19 (b) That there has been delivery of all of the merchandise called for by the
20 agreement by storing the same in a bonded warehouse with the receipt of
21 ownership issued by the manufacturer in the name of the purchaser and
22 transmitted to the purchaser.

23 Upon receiving said affidavit, the financial institution shall remit the funds on
24 deposit for the performed contract, plus interest, to the depositor. Release of funds
25 may also be made pursuant to a request for a refund or cancellation under KRS
26 367.932 to 367.974 and 367.991.

27 (4) In the event that a purchaser is in default of a preneed cemetery merchandise

1 contract, the financial institution shall release to the depositor the funds, plus
2 interest, deposited on behalf of the defaulted contract upon receiving from the
3 depositor a sworn affidavit stating that the purchaser is in default of the preneed
4 cemetery merchandise agreement, the date of the default, an explanation of the
5 default, and that the depositor has mailed a copy of the affidavit to the purchaser's
6 last known address at least thirty (30) days prior to said request for release.

7 (5) Deposits to such funds and the amounts deposited may be commingled, but the
8 accounting records shall establish a separate account for each prepaid contract and
9 shall show amounts deposited and the income and loss occurring thereon with
10 respect to each contract.

11 (6) The trustee may rely upon all certifications and affidavits made pursuant to or
12 required by the provisions of KRS 367.932 to 367.974 and 367.991, and shall not
13 be liable to any person for such reliance.

14 (7) In lieu of the trust fund deposits required herein, the person may post with the
15 Attorney General, Office~~[Division]~~ of Consumer Protection, a good and sufficient
16 bond by a surety company licensed to do business in Kentucky and in an amount
17 sufficient to cover all payments made by or on account of purchasers who have not
18 received the purchased property and services. This bond shall be held for the benefit
19 of a purchaser, or his or her heir or assign or duly authorized representative, who
20 suffers a loss of money paid pursuant to a preneed cemetery merchandise contract
21 entered into after July 13, 1984, due to the insolvency of the registrant, or failure to
22 provide the cemetery merchandise called for by contract that has been paid in full
23 and not provided after a ninety (90) day request in writing to do so. If a bond is
24 posted, the Attorney General's office shall receive sixty (60) days' written notice in
25 the event of cancellation. On or before the cancellation date, the person shall
26 comply with the trust fund requirements herein or post another good and sufficient
27 bond.

1 (8) Any person selling a preneed cemetery merchandise contract shall pay to the
2 Attorney General five dollars (\$5), for each said contract entered into and all of
3 which fees shall be remitted by the person collecting them to the Attorney General
4 at least once each month, and such funds shall be used by the Attorney General in
5 administering this chapter.

6 ➔Section 29. KRS 367.958 is amended to read as follows:

7 (1) Every person before engaging in a sale, contract for sale, reservation for sale or
8 agreement for sale of a mausoleum crypt within a mausoleum, underground crypt
9 within a crypt section, or columbarium niche within a mausoleum prior to the
10 completion of the construction thereof, shall give notice in writing to the Attorney
11 General of the commencement of such sale at least thirty (30) days prior thereto and
12 register with the Attorney General. Such registration shall be on forms provided by
13 the Attorney General.

14 (2) Every person engaged in the sale of a mausoleum crypt, underground crypt or
15 columbarium niche shall commence construction thereof within twenty-four (24)
16 months of the date of such sale and shall complete such construction within sixty
17 (60) months of the date of such sale. A delay caused by strike, national emergency,
18 shortage of materials, civil disorder, natural disaster or any like occurrence beyond
19 the control of such person shall extend the time of such commencement and
20 completion by the length of such delay. This subsection shall not apply to the sale of
21 mausoleum crypts, underground crypts or columbarium niches if there has been any
22 sale in the same project prior to July 13, 1984. Prior projects shall have commenced
23 construction thereof within thirty-six (36) months of the date of such sale and shall
24 complete construction within seventy-two (72) months of the date of such sale.

25 (3) Every person who plans to offer for sale space in a section of a mausoleum or bank
26 of underground crypts prior to its construction shall establish a preconstruction trust
27 account. The trust account shall be administered and operated in the same manner

1 as the merchandise trust account provided for in this chapter and shall be exclusive
2 of the merchandise trust account or such other trust accounts or funds that may be
3 required by law.

4 (4) Every person shall place thirty-six percent (36%), not including interest or finance
5 charges, of all payments of money made to any person pursuant to any agreement,
6 contract or any series or combination of agreements or contracts which are for the
7 purchase of sections in a mausoleum, columbarium, or any kind of underground
8 crypt which at the time of the payment of money have not been completely and
9 totally constructed, in a trust fund account in a financial institution within thirty (30)
10 days after each calendar quarter of operations. Excepted therefrom, however, are
11 persons who have constructed in the past their own mausoleum using primarily
12 equipment owned by the self-constructing person and their own personnel with a
13 minimum of subcontracting, and in that event there shall be deposited a minimum
14 of twenty percent (20%) of all payments of money, subject, however, to the actual
15 cost. If, from project to project, their actual cost is in excess of twenty percent
16 (20%), the full cost percentage shall be deposited from project to project, not to
17 exceed thirty-six percent (36%). At the time of notification to the Attorney
18 General's office the self-constructing mausoleum person shall also notify the
19 Attorney General that he intends to self-construct and the percentage of contribution
20 of trust that is required.

21 (5) All trust funds mentioned in this section shall be deposited in the name of the
22 person depositing said funds, with the financial institution as trustee, and shall be
23 held together with the interest, dividends, or accretions thereon, in trust, subject to
24 the provisions of KRS 367.932 to 367.974 and 367.991. The person at the time of
25 making deposit or investment shall furnish to the financial institution the name of
26 each payor, and the amount of payment on each account for which the deposit or
27 investment is being made.

- 1 (6) Deposits to such funds and the amounts deposited may be commingled, but the
2 accounting records shall establish a separate account for each prepaid contract and
3 shall show amounts deposited and the income and loss occurring thereon with
4 respect to each contract.
- 5 (7) All payments made to the preconstruction trust fund account shall remain in the
6 trust fund with the financial institution until the financial institution receives a
7 certified statement from the depositor stating that the particular project for which
8 the preconstruction trust fund has been established is totally completed. During the
9 construction stage, trust funds may be withdrawn by presenting the trustee with
10 appropriate evidence of expenditure for construction cost. The trustee shall
11 thereupon disburse moneys from the trust fund to pay for the expenses of
12 construction presented for payment.
- 13 (8) A trustee may rely upon all certifications and affidavits made pursuant to or
14 required by the provisions of KRS 367.932 to 367.974 and 367.991, and shall not
15 be liable to any person for such reliance.
- 16 (9) If a mausoleum section or bank of underground crypts is not completed within the
17 time limits set out in KRS 367.932 to 367.974 and 367.991, the financial institution
18 acting as trustee, if any, may contract for and cause said project to be completed and
19 paid therefor from the trust account funds deposited to the project's account, paying
20 any balance, less cost and expenses, to the depositor. In the event there is no
21 corporate trustee, or the trustee chooses not to serve in the capacity to complete
22 construction, the Attorney General shall appoint a committee to serve as trustees to
23 trust account funds deposited to the project's account, paying any balance, less cost
24 and expenses, to the cemetery company.
- 25 (10) If it is determined by the trustee after the expiration of the time of construction set
26 out above that there is not enough money in the trust fund account to complete the
27 project, the trustee shall make a refund of all moneys held to all purchasers, or his

1 heirs or assigns, in the amount of the deposit to the credit of their particular contract
2 and all income those funds have earned. The purchasers shall be entitled to receive
3 any remainder of the purchase price paid from the depositor. However, nothing
4 herein contained shall relieve any person from any liability for nonperformance of
5 the contract terms.

6 (11) If temporary entombment or inurnment is not used, upon written notification to the
7 seller, the personal representative or any purchaser of such space who dies before
8 completion of construction shall be entitled to a refund of all moneys paid into the
9 preconstruction trust fund for such space, including any income earned thereon, and
10 from the seller, the remainder of the purchase price paid.

11 (12) In lieu of the trust fund deposits required herein, the person may post with the
12 Attorney General, Office~~[Division]~~ of Consumer Protection, a good and sufficient
13 bond by a surety company licensed to do business in Kentucky and in an amount
14 sufficient to cover all payments made by or on account of purchasers who have not
15 received the purchased property and services. This bond shall be held for the benefit
16 of any purchaser, or his or her heir or assign or duly authorized representative, who
17 suffers a loss of money paid for a preconstructed mausoleum crypt or niche or
18 underground crypt after July 13, 1984, due to the insolvency of the registrant, or
19 failure to construct within the time limits set out herein. If a bond is posted, the

16 Acceptance of a fee, contribution, or other consideration in advance of the
17 complete performance of all promised services in relation to secured debt,
18 including the placement of the fee, contribution, or other consideration into an
19 escrow account to be paid upon completion of the services, is specifically

11 administrative regulations promulgated by the Attorney General.

22 audit and the auditor's opinion upon written request of any person and

24 (7) (a) A person engaged in debt adjusting shall obtain and at all times maintain
25 insurance coverage for errors and omissions, employee dishonesty, depositor's
26 forgery, computer fraud, and violations of this chapter in the amount of ten
27 percent (10%) of the monthly average for the immediately preceding six (6)

1 months of the aggregate amount of all deposits made with the person by all
2 debtors. The insurance coverage shall comply with all of the following:

- 3 1. The minimum limit of the insurance coverage shall not be less than one
4 hundred thousand dollars (\$100,000), and the maximum limit of the
5 insurance coverage shall not be more than two hundred fifty thousand
6 dollars (\$250,000);
- 7 2. The insurance coverage shall not include a deductible in excess of ten

18 property, the amount of insurance coverage required in paragraph (a) of this

21 (8) (a) A debt adjuster shall maintain a bond issued by a surety company admitted to
22 do business in this Commonwealth. The bond shall be in the amount of
23 twenty-five thousand dollars (\$25,000) in favor of the Attorney General for

25 person suffering injury or loss by reason of any violation of this chapter. A
26 copy of the bond shall be filed with the Attorney General.

8 (d) The proceeds of the bond required by paragraph (a) of this subsection shall be
9 paid to any person suffering injury or loss by reason of any violation of this
10 chapter or to the Attorney General for any violation of this chapter or shall be
11 paid pursuant to the terms of any order of a court of competent jurisdiction.
12 Any person who is damaged by any violation of this chapter may bring an
13 action against the bond to recover damages pursuant to this paragraph,
14 provided the aggregate liability of the surety shall not exceed the amount of

16 (e) In lieu of the bond required by paragraph (a) of this subsection, a debt adjuster
17 may, with the written approval of the Attorney General, deliver to the
18 Attorney General an irrevocable letter of credit issued or confirmed by a

5 (a) Misappropriate or misapply money held in trust;

6 (b) Settle a debtor's debt if the amount the debtor will owe after settlement is
7 equal to or more than fifty percent (50%) of the amount of the debt prior to
8 settlement unless, after the creditor has assented, the debtor assents to a
9 settlement for which the amount the debtor will owe after settlement is equal
10 to or more than fifty percent (50%) of the amount of the debt prior to
11 settlement;

12 (c) Take a power of attorney that authorizes the debt adjuster to settle a debt,
13 unless the power of attorney is expressly limited to the debtor's debts and
14 grants authority to settle debts only if the amount the debtor will owe after
15 settlement is less than fifty percent (50%) of the amount of the debt prior to
16 settlement. However, in no event shall an agreement confer on a debt adjuster
17 a power of attorney to negotiate or settle any of the debtor's debt that is
18 primarily for personal, family, or household use that is secured by a mortgage,
19 deed of trust, other equivalent consensual security interest on residential real
20 property, or collateral that has a mortgage lien interest in residential real
21 property;

22 (d) Exercise or attempt to exercise a power of attorney after a debtor has
23 terminated an agreement;

25 unless the transfer is:

26 1. A return of money to the debtor; or

27 2. Before termination of an agreement, properly authorized by the

- 1 agreement and this chapter, and for payment to one (1) or more creditors
2 pursuant to a plan or payment of a fee;
- 3 (f) Structure a plan in a manner that would result in a negative amortization of
4 any of a debtor's debts, unless a creditor that is owed a negatively amortizing
5 debt agrees to refund or waive the finance charge upon payment of the
6 principal amount of the debt;
- 7 (g) Settle a debt or lead a debtor to believe that a payment to a creditor is in
8 settlement of a debt to the creditor unless, at the time of settlement, the debtor
9 receives a certification by the creditor that the payment is in full settlement of
10 the debt or is part of a payment plan, the terms of which are included in the
11 certification, that upon completion will lead to full settlement of the debt;
- 12 (h) Make a representation that:
- 13 1. The debt adjuster will furnish money to pay bills or prevent attachments;
 - 14 2. Payment of a certain amount will permit satisfaction of a certain amount
15 or range of indebtedness;
 - 16 3. Participation in a plan will or may prevent litigation, garnishment,
17 attachment, repossession, foreclosure, eviction, or loss of employment,
18 and will or may stop efforts to collect a debt from the debtor;
 - 19 4. Failure to make required minimum payments to creditors will not or may
20 not break the terms of agreements with creditors, will not or may not
21 lead creditors to increase finance charges and pursue litigation, will not
22 or may not be reported to consumer reporting agencies, or will not or
23 may not have an adverse effect on the debtor's credit report and credit
24 score; or
 - 25 5. Fees paid to a debt adjuster will be used to pay creditors;
- 26 (i) Misrepresent that it is authorized or competent to furnish legal advice or
27 perform legal services;

- 1 (j) Take a confession of judgment or power of attorney to confess judgment
2 against a debtor;
- 3 (k) Purchase a debt or obligation of the debtor;

- 10 (1) When a parent presents himself to the cabinet for the voluntary establishment of
- 11 paternity and clear evidence of parentage is not present, the cabinet shall pay when
