

1 A JOINT RESOLUTION directing the Transportation Cabinet to designate portions
2 of Whitley County and McCreary County roadways as the "Copperhead Trail."

3 WHEREAS, tourism is vital to the economy of the Commonwealth; and

4 WHEREAS, both the Whitley County and McCreary County Fiscal Courts have
5 voiced their support in establishing the Copperhead Trail as a local motorcycle trail; and

6 WHEREAS, Copperhead Trail will help to promote tourism activities, increase the
7 civic economic impact in the area, and allow its riders to view the beauty of the area;

8 WHEREAS, Copperhead Trail will be a 60-mile motorcycle trail which loops back
9 to the starting point;

10 NOW, THEREFORE,

11 ***Be it resolved by the General Assembly of the Commonwealth of Kentucky:***

12 ➔Section 1. The Transportation Cabinet shall designate the following sections of
13 roadway as the "Copperhead Trail," and shall within 30 days of the effective date of this
14 Resolution erect signage denoting this designation:

15 1. From mile point 9.859 of Kentucky Route 92 in Whitley County to its
16 intersection with Kentucky Route 296;

17 2. From mile point 0.0 of Kentucky Route 296 in Whitley County to its
18 intersection with Kentucky Route 204;

19 3. From mile point 0.0 of Kentucky Route 204 in Whitley County to its
20 intersection with Kentucky Route 478;

21 4. From mile point 7.705 of Kentucky Route 478 in Whitley County to the
22 Whitley County/McCreary County line;

23 5. From the McCreary County/Whitley County line on Kentucky Route 478 to its
24 intersection with United States Highway 27 in McCreary County;

25 6. From mile point 9.093 of United States Highway 27 in McCreary County to
26 its intersection with Kentucky Route 700;

27 7. From Kentucky Route 700 in McCreary County to its intersection with

1 Kentucky Route 90 in McCreary County;

2 8. From mile point 9.51 on Kentucky Route 90 to the Whitley County/McCreary
3 County line;

4 9. From mile point 0.0 on Kentucky Route 90 in Whitley County to its
5 intersection with Kentucky Route 90S;

6 10. From mile point 0.0 on Kentucky 90S in Whitley County to its intersection
7 with United States Highway 25W;

8 11. From mile point 21.94 on United States Highway 25W in Whitley County to
9 its intersection with Kentucky Route 296;

10 12. From mile point 2.075 on Kentucky Route 296 in Whitley County to its
11 intersection with Kentucky Route 2386;

12 13. From mile point 0.776 on Kentucky Route 2386 in Whitley County to its
13 intersection with Kentucky Route 92; and

14 14. From mile point 10.736 on Kentucky Route 92 in Whitley County to mile
15 point 9.85 on Kentucky Route 92 in Whitley County.
